Opening

Payments for January were made to the post office for 3 rolls of stamps in the amount of \$198; Kruse's for the remaining stained glass window payment, \$11,246; Wells Plumbing for the furnace, \$13,445.94; transfer to savings, \$5,000; electric bill, \$72.59; Diane Jonak, candles, etc. \$72.75; Rose Kowalski, \$50, filing fee; and Aurora Co-op, \$791.25. Deposits in the amount of \$28,977.34 (which included transfers from savings) were made for the month. A motion to accept the treasurer's report was made by Bonnie Badura and seconded by Mike Ference. Motion carried.

Old Business:

Copies of the finished budget were distributed. Diane and Stacie continue to work on the rental agreement.

We were not selected for funding by the Sherman County Community Foundation for a grant this year. In a letter to Rose, the SCCF board cited the fact that the church is in Howard County, and they have faced criticism for funding projects outside of Sherman County. Its infrequent use was also cited as a reason for the denial of the grant.

New Business

A bus tour from an Omaha Polish retirement home will visit the Paplin Church in August. They will visit the Polish Heritage Center and have lunch in Ashton first.

The remainder of the meeting was spent making plans for the Palm Sunday breakfast, which is scheduled for Sunday, March 24, 2024. Everyone is encouraged to seek items for the silent auction.

Janelle Mostek will investigate t-shirt designs.

We will decorate the hall for Palm Sunday at 9 a.m. on Saturday, March 23, 2024.
