

Applying for Legal Aid for Mediation?

If you think you might be eligible for Legal Aid you will need to bring certain information with you to your first appointment. You **must** bring this information or the meeting may need to be postponed or you may be charged. If you have a partner living with you we also need to see evidence of their income.

How it works

At the beginning of the meeting the mediator will assess you to see if you are eligible for Legal Aid.

Being assessed for Legal Aid does not guarantee that you will be eligible.

To be eligible for Legal Aid you must meet certain criteria based on your income. The decision is not a personal one. Our mediators assess your situation based on the evidence you bring and the legal requirements of Legal Aid.

If you are eligible, your assessment appointment and any further mediation sessions will be free of charge.

A) Are you receiving benefits?

If you are in receipt of one of the following benefits...

- Income support
- Income based Job Seeker's Allowance (JSA)
- Income related Employment and Support Allowance (ESA)
- Guarantee Credit
- Universal Credit

Then you need to bring both

- The original notification letter or a recent change in benefit letter
- Your most recent bank statement

B) Are you in paid work?

If you are in paid work you need to bring <u>all</u> of the following:

- Your most recent bank statement
- Payslip(s) for the past month (i.e. if paid monthly, your last pay slip, if paid weekly your last 4 pay slips)
- If you receive tax credits, the most recent award notice
- Evidence of rent or mortgage payments
- Evidence of any housing benefit
- Evidence of child care costs if over £600 per month (e.g. copy of the agreement/ contract)

C) Are you self-employed?

If you are self-employed you need to bring <u>all</u> of the following:

- Recent bank statements
- Last year's complete accounts
- Self-assessment tax return for the last tax year

D) Are you retired?

If you are retired you need to bring <u>all</u> of the following:

- Evidence of your gross pension income
- Your most recent bank statement
