In the event that United Refueling extends credit to applicant, acceptance of applicant's order(s) is expressly made conditional on applicant's assent to the terms and conditions of this credit application. The terms and conditions set forth in this credit application will govern all transactions between applicant and United Refueling. The terms and conditions of purchase order(s) and other similar documents submitted by applicant will not become part of any agreement with United Refueling unless United Refueling accepts it in writing.

United Refueling has the right to suspend deliveries in the event that applicant fails to pay for any one shipment when due or applicant exceeds the extended credit limit. The undersigned company agrees to pay all collection costs, court costs, and legal fees incurred to collect delinquent balances. *It is agreed that this agreement shall be governed by and construed in accordance with the laws of The State of Texas with venue and jurisdiction in Dallas County, Texas.* In addition to any other remedy to which United Refueling may be entitled, United Refueling shall be entitled to charge interest at the highest rate permitted by law on any invoice not paid in accordance with all the terms and conditions. All payables are due at United Refueling's current place of business.

This agreement is strictly confidential and is not transferable or assignable without the prior written consent of United Refueling. Applicant agrees that any change in the liability for any debts owed to United Refueling due to a change in applicant's form of business, shall not be effective for United Refueling until United Refueling receives actual notice of the change by certified mail.
