Welcome to our October Funding Gazette

CYA would like to acknowledge a wide range of sources of information. We regularly look at funding information from NAVCA, Active Cumbria, NCVO, Merseyside Funding Portal, Get Grants and Focus on Funding from Cumbria CVS. CVS will do a search for funding for your specific project via Grantfinder. Contact: cvsfunding@cumbriacvs.org.uk

There are significant opportunities to apply for grants and trusts but now more than ever the competition is stiff and you need to take time to read the guidelines carefully for each of the charitable trusts and foundations and only apply to those where you do meet the criteria.

Funders tell us that over 30% of the applications they receive don't meet their criteria and they waste time reading through them and rejecting them but more importantly the organisations have wasted their time compiling the application and the supporting documents only for them to be consigned to the bin.

Cumbria Youth Alliance can help you with your funding applications -we can supply you with up to 10 potential funding sources that are a good match for your organisation. We can assist by being a second pair of eyes to read through your applications before you send them away and we can be a referee for your application if we have worked together and we are aware of your work.

Better Tomorrows

Cumbria's outgoing High Sheriff, David Beeby, is encouraging people to think about a career in youth work by offering fully funded training and grants to support salary costs.

Better Tomorrows is a three-year programme which aims to substantially increase the number of young people having access to support from youth workers to help them reach their full potential.

The unique initiative provides accredited training via Cumbria Youth Alliance and offers grants of up to \pounds 25,000 per year to community organisations setting up or providing new youth work opportunities for local people. The Better Tomorrows Fund, administered by Cumbria Community Foundation, is now open for applications.

Better Tomorrows aims to invest £1 million over the next three years into quality youth work training and provision. Funding has been secured from individuals, businesses and funders, including Cumbria Community Foundation, Francis C Scott Charitable Trust, Four Acre Trust, LLWR, Cumbria's Police and Crime Commissioner, BAE Systems, CCL Secure, Carr's Group, CGP Publications, Iggesund, James Walker and Lloyd Motors.

The training, Cumbria Youth Alliance, will lead to Level 2 and Level 3 qualifications in Youth Work and around 150 people are expected to access the learning, which will be delivered through face-to-face sessions. Participants will be supported during and after their training as well as in their youth work settings.

ASDA Foundation - U18 Better Starts Grants

The new U18 Better Starts Grant supports a wide range of activities and projects to improve the lives of under 18-year-olds in the UK and there are four themes for applicants to choose from:

- Supporting Essentials: to ensure there is no hungry child and basic essentials are provided.
- Being Active: to enable every child has the opportunity to be active.
- Improving Wellbeing: activities to support a child's mental health, to encourage creativity.
- Celebrating and Bringing Children Together: enable under 18s to celebrate within the community.

Grants from ± 500 to $\pm 1,500$ are supported. Who Can Apply Not-for-profit community groups in the UK are eligible to apply. Organisations must have a presence in their local community and must demonstrate how the activity will benefit those under 18 years old.

Eligible Expenditure

- Supporting Essentials: activities that focus on the provision of healthy, nutritious food, plus hygiene and health-related supplies for children e.g. breakfast clubs, school holiday clubs, food banks that support children, hygiene banks, clothing banks.
- Being Active: physical activities that are inclusive for all children and embrace diversity are supported e.g. any under 18s sport or physical activity-based groups.
- Improving Wellbeing: projects that are inclusive for all children, are accessible to everyone and embrace diversity e.g. arts, crafts, music, hobby groups, Brownies, Scouts and Guides, training for counsellors, learning clubs (reading support/homework help).
- Celebrating and Bringing Children Together: activities to bring children together to share experiences and encourage everyone to be together are supported e.g. Easter or Jubilee Celebrations for under 18s.

Cumbria Community Foundation

Various grants to local charities, community groups and social enterprises. Projects that Cumbria Community Foundation will fund:

- Projects where the majority of people who will benefit are disadvantaged
- Groups working with children where the majority are disadvantaged or have special needs
- Groups with 12 months or less running costs in unrestricted reserves
- Groups operating within the county of Cumbria (Except Beckburn Windfarm and Cumberland Building Society Community Fund – Please refer to Cumbria Community Foundation's fund pages for the full area of benefit)
- Groups with a registered address and/or local voluntary management committee or Board of Trustees in Cumbria (Except Beckburn Windfarm and Cumberland Building Society Community Fund – Please refer to Cumbria Community Foundation's fund pages for the full area of benefit)
- Core costs and overheads for your organisation
- Salaries and equipment purchases
- Capital projects that meet our fund criteria

Projects that Cumbria Community Foundation will not fund:

- Animal welfare
- Contact boxing, except where donor-advised
- Businesses and personal profit
- Deficit funding
- General large appeals
- Medical research and equipment, except where donor-advised
- Activities that are normally the responsibility of central or local government
- Awards from the same fund in a 12 month period
- Projects which duplicate an existing service in an area
- Fundraisers and fundraising events
- Advancement of religion including buildings solely for religious purposes, except where donoradvised
- Party political activities
- Retrospective funding unless through a disaster appeal
- Purchase of vehicle, except where donor-advised
- Groups or individuals who have not returned their monitoring form
- Beautification projects, except where donor-advised
- National organisations that do not have local presence within Cumbria

Eligibility Criteria is as follows:

For Volunteer- led organisations, registered charities and CIO's:

- Have a management committee with a minimum of three unrelated members
- Have a bank or building society account in the name of the organisation/group, with a minimum of two unrelated bank signatories.
- Have charitable aims, evidenced by the governing document.
- Provide evidence of good governance practices and sound financial management including being registered with the Charity Commission, Community Amateur Sports Club (CASC) or other governing body, depending on the size of the organisation, annual accounts.
- Register with the Charity Commission if your charitable organisation is based in England or Wales and has over £5,000 income per year.

For Social enterprises, CIC's and other companies:

- Have a management committee with a minimum of three directors, or four directors if two are related. The majority of directors should be unpaid. Directors should have equal voting rights
- Have a band or building society account in the name of the organisation/company, with a minimum of two unrelated bank signatories.
- Have clear charitable purposes and a defined social benefit, evidenced by Articles of Association and community benefit statement. Please also supply your CIC 34 report (if this has been made available)
- Provide evidence of good governance practices and sound financial management, including having a recognised status (e.g a company limited by guarantee), and be registered with the necessary relevant body (e.g Companies House, CIC regulator, annual accounts.
- Ensure an Asset Lock body is named and has objectives both charitable and like the CIC, ensuring benefit to the community

My Lakeland Community Fund is a fund that is available through Cumbria Community foundation. The main aim of this fund is to support projects that improve lives and wellbeing of residents in south Cumbria. Maximum reward available £15,000.

Nuvia Limited fund is a fund that is available through Cumbria Community Foundation. The aim of this fund is to support voluntary groups and organisations with projects that promote sustainability through young people and/or the environment in the area.

The fund is available for the areas around the Nuvia Site in West Cumbria, Allerdale and Copeland. There is no maximum award amount but usual grant amounts are between £500 and £2,000.

Violet Laidlwaw Trust Fund is a fund that is available through Cumbria Community Foundation. The funds aim is to continue violet Laidlaw's support for people in need by making grants to help people that have been made homeless due to the results of alcohol and drug addiction, domestic violence, family breakdown and mental ill health.

Fund is available for people in the district of Carlisle. There is no maximum reward amount although grants awarded are normally around \pounds 500 and \pounds 1000.

The Cumbria Fund is a fund that is available through Cumbria Community Foundation. This fund is setv in place to boost the capacity of local voluntary and community groups to enable them to carry out projects that help disadvantaged local people and strengthen communities. Grants of up to $\pounds 10,000$ can be provided for up to one year. Multi-year funding may be awarded for certain projects.

High Pow Community Fund is a fund that is available through Cumbria Community Foundation. This funds objective is to fund charitable activities that are environmental, community or education related which benefit the communities in the Parish of Bolton. Grant values are generally between $\pounds1,000$ and $\pounds5,000$ over the course of a year though there is no minimum or maximum award amount.

National Lottery Heritage Fund

We are the largest dedicated grant funder of the UK's heritage. Locally connected and with national expertise we are a change-maker working to enhance and champion the value of heritage for all.

- As The National Lottery Heritage Fund, we distribute National Lottery grants from £3,00 to £5million and over, funding projects that sustain and transform the UK's heritage.
- As The Heritage Fund, we distribute non-Lottery funding, including grant-in-aid/government funding and loans, to heritage organisations.
- We provide leadership and support across the heritage sector, and advocate for the value of heritage.

What the National Lottery Heritage Fund support:

- nature works to improve habitats or conserve species, as well as helping people to connect to nature in their daily lives
- designed landscapes improving and conserving historic landscapes such as public parks, historic gardens and botanical gardens
- landscapes and the countryside large-scale rural projects that help improve landscapes for people and nature, by for example, restoring habitats and celebrating the cultural traditions of the land
- oral history recordings of people's stories, memories and songs, as a way of communicating and revealing the past
- cultural traditions exploring the history of different cultures through storytelling, or things that you do as part of your community. This could be anything from dance and theatre, to food or clothing It could also include the heritage of languages and dialects
- community archaeology involves the active participation of volunteers in archaeological activities, everything from investigating, photographing, surveying to finds processing. Can occasionally include excavation. Sometimes called public archaeology
- historic buildings, monuments and the historic environment from houses and mills, to caves and gardens. Areas that are connected to history and heritage
- museums, libraries and archives making the collections that museums, libraries and archives hold more accessible through new displays, improving public buildings and galleries, or engaging people with interpreting new and existing collections
- acquiring new objects help towards the cost of acquiring one-off objects or collections as part of a collections development policy
- commemorations and celebrations telling the stories and histories of people, communities, places or events related to specific times and dates
- industrial, maritime and transport this might be places and objects linked to our industrial, maritime and transport history

What the money can be used for

- activities: to engage the wider community in your heritage. They might include guided heritage walks, sharing oral histories, or workshops. Your activities should link to the heritage focus of your project and be tailored to the needs of the audiences you want to work with.
- repairs and conservation
- digital outputs: this could be digital images, sound files or data, a website with heritage material, an app, or a film made using digital technology
- new staff posts: this could include part of a current employees' role, if they were dedicating a specific amount of time to the project
- paid training placements: this could also include training for existing staff, to support the aims of the project
- professional fees: includes anyone related to your project in a professional capacity, from architects and heritage professionals to teaching staff

What the money can't be used for

- existing staff posts or organisational costs: unless calculated through Full Cost Recovery which
 means securing funding for all costs involved in running a project. So you can request funding for
 direct project costs and also for part of your organisation's overheads.
- repairs to your own home
- legal and/or statutory responsibilities: includes anything that would be paid for regardless, whether the project went ahead or not. For example, rent, utilities, building maintenance, unless you have a Heritage Enterprise grant.
- promoting the causes or beliefs of political or faith organisations
- recoverable VAT
- costs for any activity that has taken place before a grant is awarded

Understanding, value and sharing our heritage brings people together, inspires pride in communities and boosts investment in local economies. We're supporting the heritage sector to strengthen its recovery from the coronavirus (COVID-19) pandemic and build back for positive change. Currently the National Lottery Heritage Fund are holding young people and applications from youth organisations as a priority.

Applying for Funding

We run two grant rounds each year – one for work supporting young carers/young adult carers and one for work supporting young people with criminal convictions. The application process has two stages as this gives us the best chance of understanding your proposal and how it links to our aims. Following the submission of your initial online application, shortlisted applicants will be asked to host an assessment visit with our Director.

Supporting organisations working with young carers and young adult carers. More

What we fund

- GRANT SIZE: Grants of up to £60,000 over two years are available. A maximum of £30,000 per year can be requested
- SECTORS WE SUPPORT: Community and voluntary organisations working solely with unpaid carers or exclusively with young carers. Community and voluntary organisations who can demonstrate a track record of working with young offenders
- GEOGRAPHICAL REACH: We support not for profit organisations working anywhere within the UK, with a registered UK office. We particularly welcome applications from organisations working in Northern Ireland, Scotland and Wales.
- OUR GRANT DATA: We work with 360giving to make data about our grants freely accessible. 360giving supports organisations to publish their data so that charities and funders can use the data to support their decision making and learning.

Heritage Trade Up Programme

Applications are now open!

Heritage Trade Up Programme will support leaders of heritage organisations, in partnership with the National Lottery Heritage Fund, to promote and support a stronger heritage sector.

Are you looking to strengthen the financial resilience and governance capabilities of your heritage organisation? This fully-funded programme will offer 12 months of capacity building support for a broad range of heritage sector organisations from across the UK.

We'll support you to develop the skills, knowledge and attitudes you need to develop enterprise models and deepen social and/or environmental impact. You will be part of a safe and supportive group of like-minded peers.

Key benefits:

- **Strengthen your organisation** with our free learning programme: Eight days of learning between January 2023 and December 2023
- **Receive a £4,000 Match Trading grant** that supports your recovery from the Covid pandemic.
- Gain a network of peers, who will help you develop your plans and act as a sounding board.

Our programmes are based on peer and action-learning. We're definitely not about textbooks and teachers. Instead, we help you to get the headspace you need to map out next steps, with the support of other leaders facing similar challenges.

Who should apply?

The programme is designed for people who are leading a heritage organisation or trading project. They should have responsibility for the trading activity and be able to shape it and make strategic decisions.

We encourage applications from across the UK and from organisations led by underrepresented groups, which celebrate heritage for all.

Ready to apply?

What do we mean by heritage organisations?

We understand heritage to be the narratives, traditions, objects, spaces and places that are inherited from past generations, maintained in the present, and handed down to future generations.

Heritage sector organisations are those whose primary purpose it is to protect, preserve, or promote these traditions, practices, and spaces. These may include, for example:

- Organisations that protect historical buildings, sites, artefacts or natural environments for public benefit, or
- Organisations that promote the cultural heritage of a community, keeping alive traditions and cultural history through art, music, theatre, archives or education.

When and where does Heritage Trade Up take place?

The programme comprises eight days of learning, four Action Learning Sets and an overnight residential between January 2023 and May 2023.

Our aim (dependent upon Covid restrictions at the time) is to run a blended learning approach, offering a mix of online and on-site learning. The on-site learning will take place in one of four locations: London, Birmingham, Edinburgh, and York. There will be an access budget to support participants' travel and accommodation where required.

Zero Carbon Cumbria

Community Climate Grants Funding is intended to spread awareness, build capacity, and help local people to take action on climate change.

There is a total funding pot of $\pounds 100,000$. The following levels of funding are available:

- Small grants of £200 to £750.
- Medium grants of £750 to £2,000.
- Large grants of up to £10,000. Only a small number of large grants will be awarded.

Who Can Apply

Locally controlled and not-for-profit organisations based in Cumbria can apply.

Eligible Expenditure

Projects should reduce carbon emissions and/or promote changes in behaviour within local communities or development work to set up a new group or further develop the skills of an existing group.

Activities may include:

- Delivery Projects
- Reducing carbon emissions including those relating to energy use, food, buying things and/or travel.
- Engaging with more people and/or building knowledge and understanding of climate change within communities.
- Linking with other projects or activities which will help achieve the target of a Zero Carbon Cumbria by 2037. Development Projects
- Developing skills and knowledge to have more impact, such as skilling up to respond to consultations or making planning objections, conducting surveys, gaining media and communication skills or setting up a website.
- Building capacity, for example, by recruiting more volunteers and members to take on more activities.

How To Apply

Funding is provided by Warburtons, a family run bakery business. The aim of these small community grants is to support projects, activities and organisations that will be of real direct benefit to families and have a direct and tangible social impact on people's lives. Grants of up to and including £400.

Who Can Apply

Not-for-profit organisations with charitable purposes that are operating in England, Scotland and Wales are eligible to apply. Employees of Warburtons are able to apply on behalf of organisations if they are actively involved with them (e.g. they are a volunteer, trustee, active supporter).

Eligible Expenditure

Funding is available for projects that are working towards one of Warburtons' outcome areas:

- Health supporting families to care for each other and lead healthier lives:
- Place supporting families to flourish in communities that are safer, greener and more inclusive:
- Skills supporting families to gain useful skills for life and work:

How To Apply

myLakeland Community Fund Grants

Available for charitable organisations for projects and activities in Cumbria that improve the health and wellbeing of local people and protect the environment, with priority for projects located in South Cumbria. Typically, grants of between \pounds 5,000 and \pounds 15,000 are available over one year.

Who Can Apply

Charitable, not-for-profit organisations that meet the criteria of supporting health, wellness, and the environment in South Cumbria can apply.

Eligible Expenditure

Priority will be given to projects that:

- Support community needs in or around Windermere, Kendal, and South Lakeland.
- Support young people.
- Have minimal opportunities for raising funds and/or have exhausted other funding opportunities.

The Archer Trust

The Archer Trust provides funding for small UK charities who support needy or deserving people including those with physical or mental disabilities and the disadvantaged.

Grants vary from \pounds 250 to \pounds 3,000. They prioritise organisations working in areas of high unemployment/deprivation and favour charities who make good use of volunteers.

The A B Charitable Trust (ABCT), an independent, UK based grant-making organisation, is concerned with promoting and defending human dignity and human rights. The Trust's focus is on unpopular causes reaching the most vulnerable and marginalised in society.

Shine Trust

Schools in the North of England can apply for funding to help raise the attainment for children from low income homes. The funding is available to try out new ideas to improve teaching and learning in schools and help the best ideas grow to scale.

The funding aims to address the following priorities:

- Ready for School: improving the school readiness of children during the reception year, with a priority focus on language and communication skills (age 4-5)
- Bridging the Gap: supporting vulnerable children who may not meet Age Related Expectations at primary school to make better academic progress during Key Stage 3 (age 9-14)
- Flying High: supporting high attaining students to build on their achievements at primary school and stay on a high attaining trajectory during the first few years at secondary school (age 9-14).
- The funding is being made available through the educational charity Shine and funding decisions are made four times a year typically in March, June, September and December.
- Any grants to non-school organisations, including to other charities, will need to involve a strong element of co-delivery and/or training for schools, with the aim of the project becoming sustainable without SHINE over time. On average, it takes 3-6 months between initial contact with the SHINE office to a grants decision being reached.
- If you have an idea which you think may meet our funding criteria, please email info@shinetrust.org.uk with a basic outline detailing the following points, in 3-4 paragraphs:
- An overview of the project and its aims, specifically related to academic attainment in maths, literacy or science; How it would meet SHINE's core priorities;
- The number of beneficiaries and schools it would reach; and
- The overall project budget and size of request to SHINE.

Ragdoll Foundation

Not-for-profit organisations in the UK that are working with children and young people using the arts and creative media can apply for funding through the Ragdoll Foundation's Open Grants Programme.

The Foundation's vision is to support projects where the concerns of childhood can be heard. A variety of art forms can be supported including dance, drama, ceramics, creative play, film, music, puppetry and storytelling. Supported projects will support equality of opportunity, can include families and take place in rural or urban settings and may be delivered, for example, in children's and community centres, nurseries, schools and hospitals.

Organisations can apply for both one-off short-term projects and for projects lasting up to three years. Preference will be given to those projects which have a deep commitment to listening to children and allow the perceptions and feelings of children themselves to be better understood. The Foundation is mainly interested in applications that involve children during their early years, but appropriate projects for older children (up to 18 years) will also be considered.

Whilst the Foundation will fund work in and around London, they will prioritise projects taking place elsewhere in the UK. Grants of up to \pounds 50,000 are available with \pounds 7,500 generally the smallest.

Charities in England and Wales can apply for Early Years Opportunities Grants through the Masonic Charitable Foundation.

The Early Years Opportunities programme is open to charities that help disadvantaged children and young people (up to the age of 25 years) overcome the barriers they face to achieve the best possible start in life.

Grants can be offered to charities that provide:

- Mental and physical health support/ Learning and development, including language and communication skills, social and emotional etc./ Parental Support, including whole family approach/Pastoral and advocacy support. The type of activities that could be funded include:
- Additional educational opportunities such as improving literacy and numeracy
- Individual interventions, i.e. parent education, home visiting or mentoring
- Encouraging healthy behaviours with regards to diet, activity and wellbeing
- Psychological interventions for domestic abuse and behavioural issues etc.
- Provision of vital adaptive technologies and equipment removing barriers
- Alternative methods or specialist therapies to help children and young people integrate into the mainstream education system.

The programme offers both small grants of up to $\pounds 15,000$ to charities with an annual income of up to $\pounds 500,000$ for projects lasting up to three years; and grants of between $\pounds 10,000$ and $\pounds 150,000$ to charities with an annual income of above $\pounds 500,000$ for projects lasting up to three years.

Grants for Specialist Tennis Equipment (UK)

Grants of up to £1,500 are available to special schools, disability groups and associations, etc for equipment and specialist wheelchairs to enable disabled people to play tennis. Individuals can apply for grants of up to £500. Individuals can receive support for sports wheelchairs, tennis rackets, coaching lessons with a Lawn Tennis Association (LTA) licensed coach or course fees for official LTA development/coaching courses.

- Groups can apply for:
- Wheelchairs;
- Court hire;
- Coaching fees;
- and equipment packages which will include: / Rackets/Balls/ Mini net/ Coaching aids such as: cones and throw down marker lines.

In the case of wheelchairs, a deposit will be required; for individuals, the amount of deposit required will depend on the wheelchair type requested, clubs will need to raise deposit of \pounds 250.

The Allen Lane Foundation

The Foundation funds small community groups and voluntary organisations working with specific beneficiary groups including the elderly, and people experiencing mental health difficulties. However, it does not fund organisations specifically working with physical disability or learning disability.

It is open to groups throughout the UK except where the beneficiaries of the work all live in London. The maximum grant is $\pounds 15,000$, either as a single grant, or over two or three years. Examples of previous funding activities include advocacy, self help groups, arts activities and befriending.

The Paul Bush Foundation Trust

Supports registered charitable organisations in England whose objectives are solely related to the provision of services to people with an acquired disability as a result of an accident or birth injury.

Grants of up to $\pounds 10,000$ for one year only are awarded at twice yearly meetings held in April and October. Preference is given to discrete projects with defined outcomes and seed-funding will be considered.

For example, grants may be awarded for:

- Projects or items related to improving the health and well-being of individuals suffering as the result of an acquired physical disability.
- Projects or services aimed at providing education to disabled people, their families and professionals regarding the difficulties they face.
- Projects or services that assist individuals or families to overcome social deprivation related to disability

Funding is also available to assist those individuals with a disability to improve their physical, psychological and emotional well-being. Applications for funding for individuals must be supported and completed by a third party sponsor, for example, a health/personal care professional, social worker or charity /support group representative.

The Henry Smith Charity

Newlife- disability or life limiting conditions

Newlife is the largest provider of specialist equipment to help children/young people who are disabled or terminally ill under 19 years who live in the UK. It offers professional support to families and practical support through the provision of specialist equipment.

Newlife Nurses are the key contact point for families and gateway for services. They can discuss your child's needs on their free confidential Nurse Helpline: 0800 902 0095. There is also Live Chat on the website. Newlife provides grants for essential equipment such as beds, wheelchairs and communication aids. It also offers:

- Play Therapy Pod Service providing specialist toys on loan
- Emergency Bed Loan Service providing specialist beds within 72 hours
- Comfort Capsule Service providing equipment to improve the quality for a child with a terminal illness
- Just Can't Wait Service providing equipment within 72 hours to children with life limiting or/and palliative needs to enable them to be discharged from hospital.

It supplies a variety of mobility equipment not available through the NHS. This includes powered, manual and sports wheelchairs, walkers, trikes, scooters and car seats. Powered wheelchairs are on 'permanent loan' and remain the property of the charity. This means that AFK is responsible for maintenance and repairs. Other items supplied are the property of the family or individual.
