CYA would like to acknowledge a wide range of sources of information. We regularly look at funding information from NAVCA, Active Cumbria, NCVO, Merseyside Funding Portal, Get Grants and Focus on Funding from Cumbria CVS. CVS will do a search for funding for your specific project via Grantfinder. Contact: cvsfunding@cumbriacvs.org.uk

There are significant opportunities to apply for grants and trusts but now more than ever the competition is stiff and you need to take time to read the guidelines carefully for each of the charitable trusts and foundations and only apply to those where you do meet the criteria.

Funders tell us that over 30% of the applications they receive don't meet their criteria and they waste time reading through them and rejecting them but more importantly the organisations have wasted their time compiling the application and the supporting documents only for them to be consigned to the bin.

Cumbria Youth Alliance can help you with your funding applications -we can supply you with up to 10 potential funding sources that are a good match for your organisation. We can assist by being a second pair of eyes to read through your applications before you send them away and we can be a referee for your application if we have worked together and we are aware of your work.

Open Space Event - 22 July 2022 Fellside Centre, Low Fellside, Kendal LA9 4NH

CDEC are hosting a day to bring together community organisations to develop potential new collaborations and funding bids. Encouraged by the experiences we had so far in networking and partnership based community work we want to take it further. The idea is to meet for half a day either in person and have a facilitated, focused working session.

NATIONAL FUNDING SOURCES

Fairer South Lakeland Community Fund

The 'Fairer South Lakeland Community Fund' is aimed at supporting projects that help alleviate poverty and promote resilience among our communities.

The long-term aim of the project must be to tackle poverty, they may aim to:

- give more extra-curricular opportunities to children from poorer households
- work with local food hubs to expand their reach or update facilities
- increase transport connections in rural communities
- or help vulnerable people into work

Grants available are from £500 to £8K (maximum amount awarded may be waivered in exceptional cases). There is £25K available in Round I.

Who Can Apply?

The Council will consider applications from charities, community interest companies, parish councils, voluntary groups and other not-for-profit organisations in South Lakeland. The funding must be spent to benefit the local community, and we expect applicants will work with other funders and community organisations and agencies to maximise benefit.

Eligible Expenditure

The funding must be spent to benefit the local community, applicants are expected to work with other funders and community organisations and agencies to maximise benefit. Projects need to support South Lakeland District Council's (SLDC) aim of 'A fairer South Lakeland, a South Lakeland for everyone' and "Halve the proportion of households in poverty and eliminate child poverty". The fund is designed to build infrastructure and networks to enable communities to work together to become more sustainable and financially resilient. The fund is intended to provide seed funding for community projects both with longer term aims to tackle poverty and short-term measures to meet immediate need. For example, the funding could support:

- Community schemes/projects (e.g. community energy, repair/reuse, community food initiatives, community car share schemes, warm hubs and networking schemes)
- Projects to support local people in moving toward financial stability and security
- Schemes which target the alleviation of child poverty and promote inclusion in mainstream activities
- Projects supporting vulnerable people back into work
- Sustainable cost-effective transport initiatives e.g. community lift-share, cycling/ walking projects
- Behaviour change initiatives towards sound financial management

The fund can support all types of costs relating to your project or activity, including core costs (e.g. staff, office costs), project costs (e.g. venue hire, project worker) and capital costs (can support the cost of a renewable installation).

Grants are targeted at Town and Parish Councils, small organisations with charitable or community focused aims and community groups that are based and working in South Lakeland. The fund will support up to a maximum of 50% of total costs (more than 50% for groups with an exceptional case) for the project.

We will not fund:

- 100% of your project (unless an exceptional case and at discretion of portfolio holder).
- Funding of general running costs of your organisation.
- Activities that fail to show how impact on alleviating poverty will be measured.
- Projects not benefiting people living in South Lakeland.
- Direct replacement of statutory obligation and public funding.
- Groups that cannot justify having significant unrestricted reserves e.g. where a Group has £10k or more in unrestricted reserves.
- Private members' sports/ social clubs.
- National charities/ organisations.

Cumbria Community Foundation (CCF) manages over 100 different grant making funds, distribute funding for Trusts and Foundations and help the public sector and central government distribute funding to VCFSEs.

CCF's current grant making priorities as identified in the Cumbria Revealed report are:

- Improving the lives of disadvantaged children and families.
- Improving the life skills, education, employability and enterprise of disadvantaged people.
- Supporting vulnerable older people.
- Improving the health and well-being of the people of Cumbria.
- Strengthening and supporting fragile communities.
- Enabling people to access arts, sports, culture, heritage, and the environment.

CCF ask that you read the fund guidelines carefully on the Cumbria Community Foundation website: https://www.cumbriafoundation.org/_and review whether you are eligible before applying and read the FAQs if you have any queries. You can also find some useful tips in the Guide to Completing a Grant Application.

Power to Change - Powering Up

Tailored support packages are available to support community businesses in England in the areas of digital growth, environmental sustainability, and financial resilience, with a cross cutting theme of diversity, equity and inclusion.

Do you run a project or organisation that exists to improve your local community? Is it led by local people and ideally less than four years' old? It's tough and rewarding. But you never get the time to focus 'on the business' as you're always 'running the business'.

This FREE support programme will give you the head-space, support network and funding needed to start or diversify your income from trading. You'll become a stronger, more sustainable community business as a result of this programme.

The Powering Up programme will run over a four-year period with multiple rounds of funding. The initial phase of the programme focused on community businesses looking to learn how digital skills could help their business develop and grow. The programme is now expanding to include support to help community businesses become more environmentally sustainable. The second round will focus on community businesses that are looking to deliver changes within their business to:

- Help address the climate crisis and/ or
- Improve their use of digital to better serve their communities.

It is anticipated that 30 community businesses will be supported in round two. About 18 to 20 organisations will have a primary focus on environmental sustainability and approximately 10 to 12 of them will have a digital focus. An initial 20 organisations will be supported in the autumn and a further 10 will start their support in December onwards.

Round 2 offers a tailored support package for each community business worth up to £20K in total which can be drawn over a 12-month period. This includes:

- Paid access to technical and business support providers (up to £9K) who are brokered in to meet the specific needs of the community.
- Professional development and wellbeing support (up to £3K) such as leadership coaching, peer mentoring, team building and mental health support.
- An £8K unrestricted grant to support community business leaders and teams, to engage in the required support of the programme. This could be to cover their time, back fill a post, purchase essential equipment, or supports development and resilience of their community business.

Who Can Apply?

Locally rooted community business can apply. Applicants must be:

- Incorporated. This could be as a company with Companies House, a society with the Financial Conduct Authority, or a Charitable Incorporated Organisation with the Charity Commission.
- Trading for at least 12 months and provide accounts as evidence.
- Able to dedicate a minimum of 12 days (over the next 12 months) of their time or a team members time to engage with the support being offered in this programme.
- Seeking support to improve how their business uses digital to develop and grow or to develop sustainable environmental solutions and practices to improve their business.

Priority will be given to community businesses in the most deprived areas of England, as well as organisations that are led or predominantly working in communities with a high percentage of minoritised ethnicity. If demand is above capacity, priority will be given to:

- Community businesses that are led or predominantly working in communities with a high percentage of minoritised ethnicity.
- Community businesses based in the English Indices of Deprivation (IMDs) I-3. This can be checked using this postcode lookup.

Organisations can also use the Powering Up eligibility checker to see if they are eligible to apply.

Eligible Expenditure

The support package will be tailored to each community business depending on the needs of their organisation. Community businesses can expect the following technical expertise development support:

- Using digital skills, strategies and tools
- Strengthening practices to support climate action, resilience and sustainability
- Embedding diversity, equity and inclusion in their culture, systems, processes and actions
- Reviewing their strategy and business model to help consider options in uncertain times
- Support in financial planning, including managing cashflow, debt with appropriate systems
- Access to funding sources and diversifying ways to generate income
- Advice on human resources such as tips for specific situations, designing effective processes and systems including use of digital
- Support on operational effectiveness, including on evaluating best next steps for business and IT infrastructure and systems, buildings and facilities, and/or legal and governance
- Learning research methods for in house evaluations, community and stakeholder engagement, and data analysis and impact evaluation for better service engagement and delivery
- Furthering community engagement by developing connections and collaborative solutions with new and existing partners
- Support for public relations and marketing, such as strategies and tools, including for digital.

The professional development and wellbeing support offer includes: coaching for personal and professional development; peer to peer mentoring – provided by community business leaders; team building; Mental health and wellbeing support.

John Ellerman Foundation

Grants for small to medium-sized charities in the UK whose work in the Foundation's priority areas of arts, environment or social action has impact across the whole of the UK.

The Foundation aims to advance the wellbeing of people, society, and the natural world. Support is available for charitable work in the arts, environment, and social action. The Foundation is keenly aware of the connections between these areas and their effects on each other and on people's health and happiness. The Foundation 'likes to support smaller organisations whose work has reach and significance across the UK' and 'looks for charities that have a national footprint'.

The minimum grant available is £10,000. There is no maximum limit. Most grants are for two or three years. The Foundation normally supports core funding but grants for projects are also available. Please note that demand for funds is high.

Match Funding Restrictions: Grants can be used as matched funding.

Who Can Apply?

Funding is available to registered, excepted or exempt charities that are doing work that has a national footprint or a wide reach, such as working in more than one country, region or county. Occasionally organisations that work locally may receive funding if the work has national significance through good potential for replication or being rolled out on a larger scale.

Organisations should have an income of between £100,000 and £10 million and be able to demonstrate:

- Strong governance and management that the board is engaged, people well qualified and well
 led, the organisation has a thorough understanding and oversight of finances at all levels, the
 organisation's reporting is thoughtful and the organisation is aware of its own strengths and
 weaknesses.
- Effectiveness and impact that the organisation has a good understanding of the needs being met and how best to tackle them, awareness of how the organisation relates to and complements other agencies, effective systems to monitor and review progress, a culture of always trying to do better, an eye on how to prevent problems recurring and are alert to opportunities to have a wider impact.
- Good use of volunteers from professionals to local communities.
- Partnerships formal collaboration and networking to help the organisation understand the issues it addresses.

Preference is given to smaller niche national charities which shine a light on a particular concern or area of interest.

Eligible Expenditure

Support is available for core funding, projects, and programmes. The Foundation funds three categories and aims to allocate it in the following way:

Arts

The Foundation believes that art has the potential to enrich and transform lives and it will support arts organisations that represent excellence in their field at a national level. Funding is available in the following areas outside of London:

- Regional museums and galleries funding is available to strengthen these institutions, with a focus
 on using curatorial skills to enhance collections for public benefit.
- The performing arts, mainly theatre, music and dance. Support may be available for other performing art forms if the organisation and its work are exceptional.

In the performing arts, organisations should demonstrate some of the following:

- Organisations with new or original work.
- Track record of producing excellent work.
- Exciting, fresh and imaginative ideas and models of working.
- Integration of emerging talent and artist development into the artistic programme of work (ie developing an individual is not the organisation's main or sole focus).
- An understanding of actual and potential audiences and how the artistic plans relate to them.

Environment

The Foundation aims to contribute to greater harmony between people and the planet. It is particularly interested in organisations that integrate the needs of communities, habitats and species.

Funding is available in the following areas:

- Creating richer, more sustainable places on land in urban or rural settings. Building healthier
 ecosystems in urban or rural settings, through better management of these areas; experimenting
 with or linking together habitats; large-scale interventions that help restore places of special
 significance. Work to reduce or prevent damaging effects of human activity, such as noise and
 air pollution or pesticides, is supported.
- Protecting the seas: safeguarding and restoring the marine environment through more and better
 managed protected areas; engaging coastal communities; reducing overfishing and tackling other
 harmful effects of human activity on the sea e.g. pollution. Priority will be given to work in UK
 waters but consideration will be given to Overseas Territories (on land and sea) from UK-based
 NGOs with local partners. Applications should be made for one of the following:
 - Ensuring that UK marine protected areas (MPAs) are well planned, implemented and maintained. Consideration will also be given to applications that protect marine areas other than MPAs if it is convincing.
 - Using market forces to reduce overfishing. This could mean certification schemes, developing markets for the most sustainable fisheries, and working with restaurants, wholesalers and retailers to increase sustainable sourcing of seafood.

Organisations should demonstrate some of the following:

- Understand the significance of habitats for human wellbeing, as well as the impact of people on nature.
- Look for sustainable solutions by ensuring that the livelihoods and economic needs of local communities are integrated into their thinking and strategy.
- Work collaboratively.
- Tackle causes as well as symptoms.

Social Action

The Foundation aims to help create a society where all can thrive, by supporting organisations which work to create positive changes in practice, systems and institutions.

Funding is available in the following areas:

- Improve systems and institutions through policy, advocacy and campaigning:
 - o Building bridges between people and the establishment by creating opportunities for contact and dialogue.
 - o Enabling those with experience to have a voice.
 - o Ensuring professionals/organisations listen and respond.
 - o Campaigning for improving policies, practices and systems.
- Actively involve those with personal experience of the issue tackled:
 - o Bringing together those with direct personal experience of a problem and those who have expertise and insight from working alongside them.
 - Finding new ways to draw on experiences and skills, engaging them in identifying and working on change.
 - Priority will be given to proposals that tackle the greatest barriers created by disadvantage, divisions and inequality.

Priority is given to charities that:

- Are rooted in practical experience, rather than working exclusively on policy.
- Understand the need to build people's confidence and skills so they are ready to engage with others.
- Value, promote and learn from the experience of those they support.
- Do not shy away from the unpopular or difficult cause.
- Seek to tackle causes as well as symptoms.

How to Apply

Applicants should first refer to the guidelines, the eligibility checklist, and frequently asked questions before starting the application process available on the John Ellerman Foundation website.

The Foundation operates a two-stage application process. The first-stage application should include:

- A description of what the organisation is seeking funding for, on no more than two sides of A4, including:
 - o A brief summary of the organisation and relevant track record.
 - o How your proposal meets requirements that the work is of a national significance.
 - What the organisation would like funding for and why it is well placed to do this work.
 - How the proposal fits the Foundation's guidelines.
- A copy of the organisation's most recent annual accounts.

If the proposal is recommended to the second stage, a more detailed application will be required. For further information on how to obtain this grant locally, please contact the following:

Hamish ogston Foundation

Grants are available for charities across the UK to deliver heritage, music, and health projects that promote long-term sustainability and measurable social outcomes.

The Hamish Ogston Foundation was established in October 2019 to continue the philanthropic work of Hamish Ogston, who, from 2008 to the registration of the Foundation, donated over £8.5 million to numerous causes. The Foundation takes a venture philanthropy approach by applying business experience, commercial acumen, and robust analysis to invest in effective charities.

This fund aims to support good causes across three main areas: heritage, music, and health. Grants/ investments starting from £1.5 million are available. The Foundation seeks to support projects that promote long-term sustainability, maximum financial impact, and measurable social outcomes. Successful applicants can expect a minimum investment of £1.5 million and close cooperation with the Foundation over a number of years.

Who Can Apply?

Charities that align with the Foundation's guiding strategy and donation criteria can apply.

Eligible Expenditure

Funding will support projects and activities that focus on the following areas:

- Heritage Protecting the heritage of important sites across the UK and preserving structures, their craftsmanship, and their traditions.
- Music Promoting the UK's choral and organ traditions, including related initiatives and apprenticeships, to preserve their knowledge and culture.
- Health Working towards eliminating the disparities in both access to medical treatment and health awareness amongst the most disadvantaged sections of society.

Funding will be awarded to projects that align with the Foundation's guiding strategy:

- Encourage an entrepreneurial mindset Secure the long-term sustainability of funded projects and, where appropriate, promote sustainable apprenticeships and employment.
- Maximise the benefit Provide a commercially-minded input to ensure that no money is wasted.
- Address the North-South divide Help address the economic divide between the South of England and the rest of the UK. Preference will be given to projects north of the line from the Severn to The Wash.
- Easy to measure outcomes Have measurable outcomes that are easily monitored to ensure a visible and lasting difference.

How to Apply

Guidance notes and an outline application form are available from the Hamish Ogston Foundation website. There is a two-stage application process:

- Applicants should first submit an outline application providing basic information about the organisation, proposed activities, and costs.
- Successful applicants will then be invited to complete a full application.

Blagrave charitable Trust - The Listening Fund's Advisers' fund

Grants are available to youth-focused not-for-profit groups for projects which help disadvantaged young people in positions of leadership across England.

The Listening Fund is a joint initiative which aims to encourage organisations to be more accountable to young people. This is the second phase of the Fund, the design of which has been led by a panel of ten young people advisers. Funding is intended to:

- Support young people and organisations to work together to re-examine what skills, qualities and experiences are valued in leadership roles, to challenge conceptions of who can be a leader.
- Explore different leadership models and structures and strengthen organisations by including young people's experiences and expertise.
- Build a pipeline of opportunities which gives young people access to leadership roles.

There is a total funding pot of £500,000. Grants of up to £40,000 are available over up to two years.

Who Can Apply?

Youth-focused charities and non-profit organisations that are supporting young people (aged 10 to 30) in England may apply. Groups must have the skills to either deliver the work alone or in partnership, and a turnover of £200,000 to £2 million.

Eligible Expenditure

Funded work must create new leadership opportunities for young people. Activities should:

- Meaningfully involve young people.
- Improve organisations' accountability to young people they seek to serve.
- Focus on young people who have experienced young people top bring their expertise into leadership roles.
- Explore new leadership approaches which are grounded in young people's interests and strengths.
- Centre creativity and joy.
- Create ideas, opportunities and learning which have the potential to influence beyond a small cohort of young people.
- Have potential for longer-term impact.

Grants will generally be for specific activities, unless the organisation's mission aligns with that of the Fund, in which case unrestricted funding may be considered.

ovo foundation - climate changers fund

Grants are available to not-for-profit groups in the UK for projects which equip less advantaged children and young people with the skills to take action on sustainability issues and improve access to green spaces.

OVO Foundation is the charitable arm of OVO Energy, set up in 2014 with the aim of giving every child a greener, fairer future. Funding is intended to help meet the two goals of the Foundation:

- Equip less advantaged children and young people with improved skills, knowledge, and confidence to take action on sustainability issues and contribute to building sustainable communities.
- Ensure less advantaged children and young people live in a sustainable community with increased access to green spaces and opportunities.

There is a total funding pot of around £1M. It's expected up to three projects will be funded for up to three years, with lower levels of funding for early-stage ideas and up to £350K for more established projects.

Who Can Apply?

Legally constituted not-for-profit groups in the UK may apply.

Eligible Expenditure

Projects must involve at least one of the following:

- Campaigning for better climate change education.
- Increasing opportunities for children and young people to learn from and connect to nature in/ around schools.
- Inspiring positive action on the climate crisis in/ beyond schools.

Work should focus on:

- Children and young people (up to 25).
- Geographic areas and settings with higher levels of need among children and young people as
 defined by, for example, social mobility, child poverty or free school meal stats.

The funders are particularly interested in projects that:

- Are able to articulate the need for the project by integrating children and young people's voices and opinions on what they believe the barriers to be.
- Bring together more than one delivery partner to tackle communities' multiple needs in order to benefit children and young people.
- Already use, or have an appetite to use, a carbon reduction metric to measure impact.
- Are looking for more than just financial support, for example, advice and support.

How to Apply

Full guidelines and an online application form can be found on the OVO Foundation website. There is a two-stage application process:

- Stage one: Online application completed by on 22 July 2022, with decisions expected by 10 August 2022.
- Stage two: Shortlisted applicants will meet with OVO Foundation (in-person or via video call) between 22 and 26 August 2022, with final decisions expected by 3 October 2022.

Artemis Charitable Foundation

Grants are available for UK-registered charities operating in the UK and internationally to support projects in the areas of health, poverty, education, and the environment.

The Artemis Charitable Foundation was established in 2007 to manage the charitable activities of Artemis, a leading UK-based fund manager. Each year, Artemis gives a proportion of revenues to the Foundation to distribute. In 2021, the foundation awarded over £770,000 to 88 charities. This fund aims to support UK-registered charities in the UK and internationally in the areas of health, poverty, education, and the environment.

Grants tend to be in the range of £1,000 to £10,000. Although one-off awards are typically made, multi-year grants may be considered when a successful partnership is established. Award amounts may increase if a successful partnership develops into a multi-year relationship. Unrestricted funding can also be considered.

Who Can Apply?

UK-registered charities operating both in the UK and internationally can apply. Priority will be given to small-and-medium-sized charities with an income of less than £2 million per annum.

Eligible Expenditure

Funding is intended for projects in the following key areas:

- Health.
- Education.
- Poverty.
- Environment.

Preference will be given to projects that are innovative and can be scaled up or replicated.

Previously funded groups include City Harvest, Alexandra Rose, Shivia, Arrival Education, The Robertson Trust, Client Earth, Global Action Plan.

How to Apply

Applications are accepted on a rolling basis. The trustee's meet at the end of each month to consider applications.

Applicants must provide a cover letter, a brief proposal and basic financial information, including a summary of income and expenditure from their latest annual accounts.

A B Charifable Trust

Grants are available for small to medium-sized charities registered and working in the UK that defend human rights and promote respect for vulnerable individuals.

The AB Charitable Trust (ABCT) was established in 1990 by Yves Bonavero with Anne Bonavero to support unpopular causes that championed human dignity and to focus on small and medium-sized charities working close to the ground. The Trust has no endowment and is funded annually by the Bonaveros. The Trust has awarded around £23 million in grants since 1990.

The values that underpin its work are:

- Justice it seeks to support disenfranchised and forgotten groups.
- Collaboration it aims to build mutually beneficial relationships with the people it works with.
- Efficiency it maintains high standards of administrative efficiency and cost effectiveness.
- Learning it is committed to learn from its grant making to inform future practice.

The Trust aims to support charities that defend human rights and promote respect for vulnerable individuals whatever their circumstances.

The grants range in size, with most grants being in the range of £10,000 to £20,000. The fund is in high demand, and only around a third of eligible applicants will receive funding.

Who Can Apply?

Charities registered and working in the UK can apply. Charities should have an annual income of between £150,000 and £1.5 million, have operated for at least a year and be able to provide a full year's audited or independently examined accounts. The Trust is looking for applicant organisations that:

- Deliver effective work and can demonstrate the difference it makes.
- Listen to the people they seek to support about their needs and amend their work accordingly.
- Engage the talents of people who have experienced the problems the organisation exists to address.
- Are well run, make best use of resources and follow best practice (e.g. in governance, financial management, DEI, safeguarding).
- Work well with others in the geographical or policy area (are happy to combine knowledge and resources where helpful and avoid duplication).
- Share knowledge where possible (e.g. with colleagues in the sector, or to influence attitudes to an issue or to influence policy).
- Would make best use of a grant (i.e., where the grant would make a positive difference).

Eligible Expenditure

ABCT supports charities working where human dignity is imperilled and where there are opportunities for human dignity to be affirmed. To be eligible, projects should address at least one of the following categories:

Migrants, refugees and asylum seekers

In this priority area, funding is available for charities which do any or all of the following:

- Deliver services targeting migrant communities, and people who are refugees or seeking asylum.
- Influence policy and/or counter negative narrative.
- Strengthen the voluntary sector and support charities delivering work in this area.

Criminal justice and penal reform

In this priority area, funding is available for charities which do any or all of the following:

- Deliver services to improve outcomes for individuals (and their families) who are in the criminal justice system (at any stage, from contact with police to courts and prison).
- Support effective rehabilitation in the community.
- Work to influence policy and to reform the criminal justice system.
- Strengthen the sector and support charities delivering work in this area.

Human rights, particularly access to justice

In this priority area, funding is available for charities which do any or all of the following:

- Provide specialist legal advice and representation.
- Work to influence policy through e.g. strategic litigation or public law challenges.
- Strengthens the sector and supports charities delivering work in this area.
- Deliver activities to protect the principles of human rights and the rule of law, including campaigning, advocacy and narrative change work

For all priority areas, the Trust usually supports single focus organisations working solely in priority areas. For these organisations, core funding (unrestricted grants) or project funding (restricted grants) are both available. On occasion it also accepts restricted grant applications from charities working more broadly, where the project is particularly focused, forms a significant strand, and the charity can show it is best placed to deliver the work.

Who Can Apply?

Eligible Expenditure

Projects must meet the following criteria:

- Be for children and young people under the age of 25 who are disadvantaged.
- Consist of educational activities that develop learning, motivation and skills.
- Have clear aims and objectives to be met within a planned timescale.

The Company is looking for projects that deliver clearly defined educational benefits to a specific group of children or young people. Items of equipment will be considered only where a full explanation is given of how they will be of use to this activity. Projects could, for example, achieve the following:

- Foster social, emotional or life skills.

Preference is given to projects piloting new approaches where the outcomes will be disseminated to a wider audience.

Ernest Cook Trust - outdoor Essentials Grant

Grants are available to UK state funded Primary and Secondary schools to enable them to get their pupils learning outdoors.

The Ernest Cook Trust (ECT) was founded in 1952 by the late Ernest Cook, a grandson of Thomas Cook, founder of Cook's Travel Agency. It is an educational charity with a vision for 'an environmentally engaged society'. The COVID pandemic has demonstrated how important being outdoors is to the mental and physical wellbeing of everyone. It has also highlighted inequalities in people's abilities to access the outdoors. Research commissioned by The Ernest Cook Trust has identified that transport costs are a key barrier for schools to access Outdoor Learning.

Grants of £500 per school are available. The current round of funding is for grants to be used for:

- Wellies & Waterproofs Research commissioned by The Ernest Cook Trust has identified that appropriate outdoor clothing and equipment is a key barrier for schools to access Outdoor Learning
- Nature & Nurture projects to create areas where young people can connect with nature within school grounds or within the local community.

Who Can Apply?

Applications are accepted from UK state funded Primary and Secondary schools. This includes:

- Any UK state funded Ofsted Registered Primary, Middle, Secondary or High school
- Any UK state funded Special or Alternative Provision School
- Multi Academy Trusts, but applications must be made by the individual schools.

Priority will be given to:

- Schools who are committed to enabling Outdoor Learning and see environmental engagement as an important part of education.
- Schools who can demonstrate that Outdoor Learning has a wider benefit to families and their local community.
- Schools with disadvantaged pupils.
- Schools that are located in areas of high deprivation and/or have pupils who are living in challenging circumstances.

The grant cannot be used to fund capital infrastructure i.e. school playground equipment or storage sheds.

Eligible Expenditure

This current round of Outdoor Essentials Grant funding is in support of The Queen's Green Canopy initiative; schools can apply for the Outdoor Essentials Grant to fund the necessary equipment required for the planting of trees and their ongoing care. This extends to the funding of:

- Wellies & Waterproofs Outdoor clothing to enable children and young people to learn outdoors.
- Nature and Nurture Projects to create areas where young people can connect with nature within school ground or the local community.

Baily Thomas Charitable Fund

Grants are available to voluntary organisations, charities and schools in the UK to assist with the care and relief of children, young people and adults with learning disabilities in the UK.

The Baily Thomas Charitable Fund is a registered charity which provides funding to voluntary organisations working in the field of learning disability. The funding is available for projects that aid the care and relief of those affected by learning disability. The Trustees consider learning disability to cover the conditions generally referred to as severe learning difficulties, together with autism. Funding is available for projects concerning children or adults.

The Baily Thomas Charitable Fund describes people with learning disabilities as having three things:

- Global intellectual impairment (intelligence quotient less than 70)
- Need for support/help to fulfil ordinary daily activities
- Onset before the age of 18 years.

Learning disabilities may have a recognised cause, e.g. Down syndrome, Williams syndrome, but often the cause is not known. Children, young people, and adults with learning disabilities often also have other physical and mental health conditions, disabilities, and/or impairments as well as having learning disabilities.

The Charity operates the following grant schemes:

Small Grants: from £250 to £5,000.

General Grants: over £10,000.

Normally one-off grants are awarded but exceptionally a new project may be funded over two or three years, subject to satisfactory reports of progress.

Appeals received with funding requests of £10,000 and below will initially be considered under the small grants programme and will be referred to the next Main Grant Board Meeting.

Match Funding Restrictions: The amount of funding available depends on a number of factors including the purpose, the total funding requirement and the potential sources of other funds including, in some cases, matching funding.

Who Can Apply?

Applications will only be considered from voluntary organisations which are registered charities or are associated with a registered charity. Exempt charities such as schools, Parent Teacher Associations and Industrial & Provident Societies can also apply.

A second application from an organisation will not normally be considered for a period of at least two years after completion of an initial grant. If the previous application was unsuccessful, this period is one year. This does not apply to recipients of funding through the Research Grants Programme.

Eligible Expenditure

The main grants and small grants programmes provide funding to aid the care and relief of those affected by learning disability. The Charity will fund projects concerning children and adults with the conditions generally referred to as severe learning difficulties or autism.

Funding is normally considered for capital and revenue costs and for both specific projects and for general running/core costs. Some examples of the type of project that the Charity might fund are listed below:

- Capital building/renovation/refurbishment works for residential, nursing and respite care, and schools.
- Employment schemes, including woodwork, crafts, printing and horticulture.
- Play schemes and play therapy schemes.
- Day and social activities centres including building costs and running costs.
- Support for families, including respite schemes.
- Independent living schemes.
- Support in the community schemes.
- Snoezelen rooms.

Research grants are directed towards the initiation of research into learning disability with the intention that the research can progress to a point where it becomes eligible for support from other major funding bodies.

Application forms are available to complete online from the Baily Thomas Charitable Fund website. More information about the Fund can be found here. All applications to the fund will be subject to an independent review. Applications should be supported by two referees. Small Grant applications are considered monthly, or as demand decrees. General Grants are considered each quarter and decisions are generally made within three months of each deadline.

Home office - Support for Victims and Survivors of Child Sexual Abuse Fund 2022/25

Grants are available for voluntary sector organisations in England and Wales providing nationally accessible support to victims and survivors of child sexual abuse.

Following on from previous years, the Home Office is providing grant funding to non-statutory sector organisations in England and Wales working across a large geographical area to provide support to victims and survivors of child sexual abuse (SVSCSA). In 2017, the Government published the 'Tackling Child Sexual Exploitation: Progress Report', detailing the national response to sexual exploitation and violence against children and young people. This included a commitment to support victims and survivors of child sexual abuse, including through funding to national organisations

In 2021, the Home Office published a cross-government Tackling Child Sexual Abuse Strategy, with improving support to victims and survivors as a key objective. Ongoing support to national organisations, through the SVSCSA fund, was a key commitment in the strategy. The grant funding is for proposed services and activities that directly support victims and survivors of child sexual abuse at a national level in England and Wales and take place over a three-year period (2022/23 to 2024/25).

The total budget for this fund is £4.5M with £1.5M available in 2022/23, 2023/24 and 2024/25. The minimum grant is £1,000. Although there is no set maximum level, applicants should bear in mind the Home Office wants to ensure that a range of services have the chance to receive funding. The funding covers the period from 1 April 2022 to 31 March 2025.

Who Can Apply?

Voluntary sector organisations, single organisations or multi-organisation consortium, may apply.

Eligible Expenditure

The funding is for proposed services and activities that directly support victims and survivors of child sexual abuse at a national level in England and Wales and take place over a three-year period. This can be either or all of the following:

- Children who have experienced sexual abuse.
- Adult survivors of sexual abuse during childhood.
- Non-abusing parents, carers and family members of children who have experienced abuse.
- Family members of adult survivors of child sexual abuse.

The services should be offered over a large geographical area, which must be at least three Police and Crime Commissioner areas.

Information about this fund can be found on the GOV.UK website: Home Office - Support for Victims and Survivors of Child Sexual Abuse. The first step in the application process is to register on Home Office Jaggaer eSourcing portal.

Approval to use the system takes about 24 hours from time of registering on the system.

Once successfully registered, groups should then send an email to the Home Office requesting all the necessary documents, including the application guidance notes.

Applications for the fund will be submitted via the eSourcing portal.

GambleAware - community Resilience Fund

Grants are available to not-for-profit groups for projects which support communities to address gambling harms in light of the cost-of-living crisis in Great Britain.

GambleAware is an independent charity that commissions evidence-informed prevention and treatment services across Great Britain.

Funding is intended to address inequalities experienced by disadvantaged communities, recognising that the current economic crisis will be exacerbating gambling harms and risk of experiencing gambling harms for many people. There is a total funding pot of £1 million. Grants of up to £100,000 are available.

Who Can Apply?

Constituted not-for-profit organisations with a board of Trustees or Directors (ideally three unrelated people) in Great Britain may apply. Groups must not be currently funded by GambleAware.

To be eligible, applicants must have experience or knowledge of gambling harms or an adjacent field such as health inequalities, addictions or mental health.

Eligible Expenditure

Grants can be used to:

- Develop or create an existing service/project.
- Work with a new community.
- Support innovation.
- Develop or strengthen a new partnership within the community/local area.

Proposals should demonstrate:

- How disadvantaged communities will be supported in relation to gambling harms and associated inequalities.
- How inequalities will be addressed through the Fund and how the cost-of-living crisis has exacerbated these.
- The challenges within the community that need to be addressed/solved.
- Partnerships (where applicable) within the local system and any plans to develop work with other local organisations.

Funded activity must take place within 12 months of award.

The fund launched on 30 June. Full guidelines and an application form can be found on the GambleAware website.

community ownership fund

Grants are available to voluntary, community and charitable organisations in the UK to support them in taking ownership of local assets such as pubs, theatres and parks.

This fund is intended to support communities in all parts of the United Kingdom to purchase community assets and amenities which are at risk of being lost to the community and run them as sustainable community businesses. It forms part of a package of UK wide levelling-up interventions, helping to support recovery, build opportunity and empower communities to improve their local places.

The Community Ownership Fund has four strategic objectives:

- To provide targeted investment for communities to save and sustain community assets that would otherwise be lost to community use.
- To strengthen capacity and capability in communities, supporting them to shape their places and develop sustainable community businesses.
- To empower communities in left behind places to level up.
- To strengthen direct links between places across the UK and the UK government.

The Community Ownership Fund has £150M (over four years) of capital and revenue funding:

- Capital funding to take ownership (including the acquisition of the building; refurbishment costs alongside a sale or a transfer). Up to £250K match-funded capital will be available for all eligible asset types. Exceptionally bidders will be able to make the case for up to £1 million matchfunding to help establish a community-owned sports club or help buy a sports club or ground at risk of being lost without community intervention.
- Revenue funding to support the running costs of the project, i.e. for legal fees, general costs including utilities, staffing costs, or costs associated with appointing external consultants such as architects or other specialist support. This does not need to be matched.
- Revenue funding request cannot be more than 20% of the capital funding request or £50K whichever is smaller. This is also applied to sporting assets applying for up to £1M capital funding.
- Two types of revenue funding are available:
 - Pre-acquisition support this will be awarded alongside the main capital grant to cover feasibility studies, professional services and business support in establishing the asset.
 - Post-acquisition support this will be awarded alongside the main capital grant to support organisations to manage cash flow in the first year of operation

Match Funding Restrictions: Applicants are required to provide at least 50% of their total project costs from other sources. Eligible sources of match funding will include funding from:

- Public bodies.
- Devolved administrations.
- Charitable trusts.
- National Lottery funders.
- Community shares.
- Social investors.
- Other lenders.

The following 'in-kind' match funding ('non-cash' match funding) will also count as an eligible match funding:

- Donations of goods.
- Buildings or professional services, including from: individuals; community groups; funders;

Applicants are not required to have all match funding sources secured at the time of project application.

Who Can Apply?

Applications will be accepted from voluntary and community organisations from all parts of the United Kingdom who have a viable plan for taking ownership of a community asset at risk and running it sustainably for community benefit.

To be eligible, the applicant must be an incorporated organisation which is set up to deliver charitable purpose, social purpose or public benefit. Eligible organisation types include:

- Charitable incorporated organisation (CIO).
- Scottish charitable incorporated organisation (SCIO).
- Co-operatives including Community Benefit Societies.
- Community Interest Company (CiC).
- Not-for-profit company limited by guarantee.

To be eligible for investment from the Fund, the terms of community ownership must be either the ownership of the freehold or a long-term leasehold of at least 15 years with reasonable break clauses.

Assets with leaseholds of 25 years and no early break clauses are preferred as applicants will find it easier to demonstrate the long-term sustainability of the asset in community hands.

Proposals will need to prove the value of the asset to local people and that the asset can run sustainably for the long-term benefit of the community. Projects could include (but are not limited to): community centres; sporting and leisure facilities; cinemas.; theatres; music venues; museums; galleries; parks; pubs; post office buildings; shops.

To be eligible for funding, applicants must demonstrate that the community asset they want to save fulfils the following criteria:

There is a risk of loss without community intervention – Risk might be from closure, sale, neglect and dereliction under current ownership, or unsustainable operations under the current business model. Applicants need to demonstrate the nature of the risk facing the asset. This will include evidence that without community intervention the asset or amenity would be lost to the community.

Community value – Applicants will need to show the contribution of the asset to their community including to the social wellbeing or cultural, recreational or sporting interests of the local place.

Community use – The asset will be used and accessed by the community or have had a community use in the recent past, which applicants will need to evidence in their application.

Long-term sustainability – Applicants will be required to demonstrate a clear plan for how the asset can be sustainable in community ownership in the long-term.

Applicants who have been unsuccessful are encouraged to apply again in a future round.

Previous Success: A list of successful bids from the first round have been published on GOV.UK website.

Eligible Expenditure

The Fund will support proposals to:

- Acquire a physical community asset or facility at risk, such as land and buildings which deliver a benefit to local people.
- Renovate, repair or refurbish the asset, only where this is part of a sale or transfer to save a community asset at risk and where this is critical to saving the asset and making it sustainable.
- Set up a new community business or buy an existing business in order to save an asset or amenity of importance to the community.
- The purchase of associated stock, collections or intellectual property, where it is associated with buying a physical asset or buying a business to save an amenity.
- Move a community amenity to a new, more appropriate location within the same community. This might be because a different location offers better value to continue the amenity, or because the venue is in itself an asset of community value.

The funding is for community projects that do at least one of five things:

- Increase feelings of pride in, and improve perceptions of, the local area as a place to live.
- Improve social trust, cohesion and sense of belonging.
- Increase local participation in community life, arts, culture or sport.
- Improve local economic outcomes including creating jobs, volunteering opportunities and improving employability and skills levels in the local community.
- Improve social and wellbeing outcomes including having a positive impact on physical and/or mental health of local people and reducing loneliness and social isolation.

How to Apply

Application documents are available from the GOV.UK website - Community Ownership Fund - Round 2. It is expected that there will be at least eight bidding rounds in total as the Community Ownership Fund runs until 2024/25. There will be three bidding rounds per year.

Expressions of interest can be submitted at any time. Those who are successful will be invited to submit a full application, which they do not have to do immediately. VCSE Health and Wellbeing Fund 2022-2025

Grants are available to local not-for-profit groups across England for projects which support the theme of women's reproductive wellbeing in the workplace.

The VCSE Health and Wellbeing Fund is part of the VCSE Health and Wellbeing Programme, which was launched in 2017, and is a joint initiative by the Department of Health and Social Care (DHSC), Public Health England (PHE) and NHS England and NHS Improvement. The Programme works with VCSE organisations to promote equality and address health inequalities and help people, families and communities to achieve and maintain wellbeing.

Funding is intended to support voluntary and community organisations to provide a holistic support offer to women experiencing reproductive health issues so that they feel confident to remain in and return to the workplace. This includes ensuring that:

- Women feel supported in the workplace.
- Taboos are broken down through open conversation.
- Employers feel well-equipped to support women in managing their health in the workplace.

Grants of £200,000 to £600,000 over three years, to a maximum of £200,000 per year, are available. It is expected that 15 to 20 awards will be made.

Match Funding Restrictions: Applicants are strongly encouraged to seek additional sources of funding, with those that do being given priority.

Who Can Apply?

To be eligible for funding, organisations must:

- Meet the conditions set out in Section 70 of the Charities Act 2006.
- Work in England, with a plan to operate their programme in England only.
- Be not-for-profit, and either:
 - Incorporated (A company limited by guarantee and registered with Companies House, or a co-operative or industrial and provident society or a social enterprise).
 - o Have charitable status.
- Not apply for funding of more than 25% of their annual turnover.
- Have an equal opportunities, health, and safeguarding policy.
- Have been operating in this area, or a closely related area, for at least three years.
- Have a clear connection to work within local communities.

Joint applications are accepted where there is one organisation to be the lead applicant.

Applicants are required to provide a supporting letter from their local statutory commissioner: for example, Sustainability and Transformation Partnership (STP), Integrated Care System (ICS), or local authority.

Eligible Expenditure

Funding must be spent by March 2025. Types of activities that can be supported by this fund include:

- Workplace awareness and training for small and medium enterprises (SMEs) where assistance schemes are unlikely to be available.
- Low-intensity expert work and health support for women experiencing reproductive health issues that are impacting their experience in the workplace. In particular, those women at risk of leaving employment or who have recently fallen out of work who are less likely to have access to occupational health support via their employer. Typical features can include:
 - 'Upstream' support for people to remain in work or return to work, including following a sickness absence.
 - Light-touch, 'biopsychosocial' approaches helping individuals to address their holistic health, personal and workplace barriers to employment.
 - o Case management.
 - Signposting to both clinical services (for example, mental health services, physiotherapy) and wider, local, services (for example, debt advice, CV and interview coaching, wellbeing support).
 - Delivery by multidisciplinary teams, involving clinical or non-clinical professionals (including in case manager roles).

Funding should also:

- Expand or develop projects and programmes that have a whole system approach.
- Promote equalities and reduce health inequalities for women.
- Support strong and sustainable local connections between VCSE and statutory services, without duplicating other existing initiatives.
- Facilitate co-production between local partners and service users.
- Evaluate different approaches and share learning.

Please read the guidance on Holiday Activity Provision before completing this application. It can be during the day, evening, or weekends. If you can offer less, please talk to our HAF coordinator before undertaking the application.

Providers of HAF Activities should provide the following:

- Healthy meals: holiday activities organisers must provide at least one hot healthy meal a day and must meet the School Food Standards throughout the day.
- Enriching activities: holiday clubs must provide fun and enriching activities that provide children with opportunities to develop or consolidate skills and knowledge and improve their wellbeing.
- Provide physical activities which contribute to the Chief Medical Officer Physical Activity Guidelines.
- Nutritional education: holiday clubs must improve children's knowledge and awareness of healthy eating and offer advice and training to parents on how to source, prepare and cook nutritious and low-cost food.
- Signposting and referrals: clubs must be able to provide information signposting or referrals to other services and support that would benefit the children who attend their provision and their families.
- Provide on request policies and procedures: clubs must be able to demonstrate and explain their safeguarding arrangements and have relevant and appropriate policies and procedures in place in relation to safeguarding, health and safety and contingency planning in respect of Covid.

HAF Guidelines:

Cost should be in the range of no more that £20 per day per young person for activities and £5.00 per day for a nutritious hot meal giving a total price of no more that £25,000 per day per young person. There are exceptions to this funding such as provision of transport costs or supporting children with additional needs but please discuss with your HAF lead before undertaking the application.

The HAF programme targets young people with a free school meal entitlement, or those children deemed vulnerable, NEET or with SEND who are of school age 5-16 and activities must last at least 4 hours per day and include a hot nutritious meal in line with school food guidance.

You can only use the HAF monies for these young people, but you can have paying places for those who are not eligible for the HAF funding.

Cumbria's High Sheriff, David Beeby, is encouraging people to think about a career in youth work by offering fully funded training and grants to support salary costs.

Better Tomorrows is a three-year programme which aims to substantially increase the number of young people having access to support from youth workers to help them reach their full potential. The unique initiative provides accredited training via Cumbria Youth Alliance and offers grants of up to £25,000 to community organisations setting up or providing new youth work opportunities for local people. The Better Tomorrows Fund, administered by Cumbria Community Foundation, is now open for applications.

Better Tomorrows aims to invest £1 million over the next three years into quality youth work training and provision. Funding has been secured from individuals, businesses and funders, including Cumbria Community Foundation, Francis C Scott Charitable Trust, Four Acre Trust, LLWR, Cumbria's Police and Crime Commissioner, BAE Systems, CCL Secure, Carr's Group, CGP Publications, Iggesund, James Walker and Lloyd Motors.

- Applicants' must promote equality of opportunity and good relations within the community and make reasonable adjustments to any barriers that may prevent protected groups from using and/or accessing their services.
- Applicants' community groups/organisations must have a bank account as the PCC will only pay the funding via BACS. Payment information must be included on the application form.

The PPC will not fund:

- Commercially run activities
- Speed Laser Devices and Speed Activation Devices
- Projects run for the sole benefit of one individual
- Politically based activities
- Events or activities for which the principle aim is to fundraise for other organisations
- Marketing costs for existing or planned activities
- The development or refurbishment of buildings
- Activities which form a statutory function of an applicant

When considering whether to apply for a grant from the Harold and Alice Bridges Charity, applicants should consider the following criteria which the Trustees use to help assess the applications:

- I. Grants awarded by the Charity are mainly for capital projects and not usually for running expenses. For example, an application from a village hall for a grant towards the re-roofing of the building is likely to be more favourably considered than an application to pay for the hall to be regularly cleaned.
- 2. The Trustees favour applications which show a good degree of self help and local support.
- 3. The area of benefit should, if possible, be shown to be in **Lancashire** and **South Cumbria**, particularly the area north of the River Ribble, eastwards towards the Blackburn area and into South Lakes.
- 4. It is helpful if the applicant is itself a charity registered with the Charity Commission. You will be asked to quote your registered charity number.

Penrith Loffery

Penrith Lottery grant fund capital expenditure for not-for-profit organisations and charities and also financially support events within a five-mile radius of Penrith between £100 – £2,500. Applications are considered year-round on a monthly basis.

- 1. Awards will be given to voluntary/non-profit making organisations or to support community initiatives that benefit the town and the residents of Penrith. Normally grants will only be given to organisations within a 5-mile radius of Penrith although in exceptional cases this boundary will be extended if the organisation can prove significant benefit to the residents of Penrith.
- 2. Grants will only be given for capital funding and events which directly benefit the community. i.e., not for general maintenance or running costs. They cannot fund events if the intention is to pass on any surplus income to other organisations e.g., concerts which seek to benefit local charities.
- 3. Grants can start from as little as £100 but are usually capped at £2500
- 4. Monetary award applications will not be considered from party political organisations.
- 5. Monetary award applications will not generally be considered from any organisation where funding would normally have been derived from local or national government. However, funding will be considered under exceptional circumstances where grant funding can help access larger sums under the concept of matched funding.
- 6. Funding will only be given to organisations where access is unrestricted. i.e. the benefits are available to all parts of the community.
- 7. All applications will be considered by the Penrith Lottery Committee and any decisions made will be final and not subject to appeal.
- 8. Evidence will be required to show that organisations have appropriate safeguarding policies in place when activities include children and other vulnerable persons.
- 9. Grant payments are subject to recipients supporting Penrith Lottery in a variety of ways and grant applicants are asked to refer to their Grant Acknowledgement Guidelines which contains an extensive list of ways their funding can be recognised. In this way they can spread the word and encourage new members to join as well as receive more grant applications.
