Aviva community fund

Small charities and constituted community groups with innovative ideas that benefit their community can apply for funding of up to £50,000 for projects that build more connected, more resilient communities and give people the tools to become more financially independent. In response to the Covid-19 Aviva are temporarily opening up the Fund to projects that will ensure organisations can adapt or maintain critical services and infrastructure in response to the impacts of COVID-19. Projects must still relate to one of Aviva's key funding areas. The closing date for this funding round is the 28th July 2020.

CAF online - Coronavirus Emergency Fund

Smaller charities, not for profit organisations, social enterprises and unregistered community groups can apply for grants of up to £10,000 to help them to continue to deliver much needed support to within their communities. The funding is available to help with core costs, staffing, volunteer costs, supplies and equipment, communications or other critical charitable areas. CAF will aim for grants to be paid to selected organisations within 14 days of application.

Community Grants: one family foundation

The OneFamily Foundation is inviting its customers to nominate a local charity, group or cause for a Community Grant of up to £2,500 to help them to continue providing support to those affected by the coronavirus, or who themselves are struggling to maintain their usual services. The Foundation has already helped more than two hundred good causes deliver projects such as helping disability charities invest in their resources, and community groups tackle isolation amongst the older generation. Due to the need to respond quickly to the emergency they have created a streamlined application process and payment process to make it easier to get funds distributed quickly. If your application is successful the fund will provide a single payment award of £500 to organisations who are supporting vulnerable groups. The programme is set up to support organisational need in this time of crisis rather than fund specific projects.

The Barclays foundation: COVID-19 Community Aid Package

The Barclays Foundation have announced a £100 million COVID-19 Community Aid Package – The package consists of two strands. £50million will be donated to charities chosen by Barclays and £50million will be donated by matching their employees' personal donations (individual organisations cannot apply for this funding. The money will be disbursed principally in the UK, but also in Barclays' international markets, including the USA and India.

Association of Mental Health Providers: Mental Health Response Fund

The Department of Health and Social Care has made £5 million available to support voluntary and community sector (VCS) mental health providers which are experiencing an increase in demand for their services due to coronavirus. Through the Coronavirus Mental Health Response Fund, small and large grants of between £5,000 and £50,000 are available to help increase mental support for people with and at risk of developing mental health problems.

Elfon John Aids Foundation: Covid-19 Emergency fund

The Elton John AIDS Foundation's COVID-19 Emergency Fund is accepting applications for solutions that have strong potential to address specific challenges that have arisen for people already living with or at severe risk of HIV/AIDS and who are now at heightened risk as a result of the COVID-19 pandemic. Such solutions should aim to demonstrably mitigate the threat of COVID-19 on maintaining current levels of access or increasing access to HIV-related prevention, testing, care and treatment adherence services. The Fund is looking to support local community-based organisations, which have been awarded an Elton John AIDS Foundation grant since January 2017, for solutions lasting up to six months.

BBC Children in Need: COVID-19 Next Steps Grant (UK)

BBC Children in Need have launched the Covid-19 Next Steps Grants programme. Eligible organisations can apply for grants of up to £80,000 to deliver support for children and young people affected by the COVID-19 pandemic. Projects need to commence in September 2020 and can last for up to 18 months. The programme is designed for established organisations who are already delivering work in their communities and further afield. To be eligible, organisations must be registered with the appropriate regulatory body, such as your nation's Charity Commission or companies House (unless the organisation currently holds a BBC Children in Need grant). BBC Children in Need will not be accepting applications from educational institutions (including schools), prisons, hospitals or other statutory bodies. The deadline for applications to this programme is the 1st July 2020.

Funding to Address Social and Health Inequalities

The Health Lottery North East and Cumbria has announced that it is seeking applications for funding through the Active Communities Programme. Grants of between £5,000 and £40,000 are available to local community groups in specific areas of Cumbria, Northumberland, Tyne and Wear and County Durham for projects that address social and health inequalities. Eligible organisations that can apply are community groups and not-for-profit organisations, with an income of less than £350,000 a year or an average of £350,000 over two years. The programme also supports Communities of Interest. These are groups of people who have things in common and wish to come together to address something that is important to them. The closing date for applications is I pm on the 1st July 2020.

Sport England is Seeking to Support Innovative Projects

Sport England has launched a new programme to support innovative projects that reduce inequalities and help those most affected by the impact of coronavirus (Covid-19) to get active. In particular, Sport England wants to support projects from individuals and organisations specifically developed to support women, people on low incomes, people from Black, Asian and minority ethnic backgrounds, disabled people or people living with long-term health conditions. Successful applicants will be supported with a combination of advice, further training, insight, access to connections across the industry, and funding. The funding element of the programme will consist of a grant of up to £50,000 from a total funding pot of £1 million. There is a short application window. The closing date for applications is the 24th June 2020.

National Loftery Heritage Emergency Fund



National Lottery Heritage Fund is making £50million available for a Heritage Emergency Fund to support the UK heritage sector as an immediate response to the COVID-19 crisis.

They will be investing the £50m where it is needed most, by providing short-term funding for organisations delivering heritage projects or running previously funded projects, and safeguarding heritage sites they have previously invested in to ensure they are not lost to the public.

Eligible musicians can apply for a one-off payment of £500 if they are suffering significant financial hardship.

Department for Education: Funding to Cover Additional Costs Associated with COVID-19



The Government has announced extra funding and support for schools to cover the exceptional costs associated with coronavirus (COVID-19) for the period March to July 2020. Funding will be available for all state-funded mainstream and special schools, and alternative provision. This can relate to additional costs associated with keeping schools open during the Easter and/or summer half term holidays, for vulnerable children and the children of critical workers; support; the provision of free school meals (FSM) for eligible children who are not attending school; and additional cleaning – required due to confirmed or suspected coronavirus (COVID-19) cases; etc. Funding will be available to schools that are unable to meet such additional costs from their existing resources, or which they could only meet by drawing down on reserves and undermining their long-term financial sustainability.

The RAFT (Rapid Action by The Fore Trusts) programme has been launched to support small charities and social enterprises adversely affected by the crisis. The RAFT Fund offers grants of up to £5,000 to existing grantees so that they are able to meet the rapidly changing needs of their beneficiaries, remain viable and prepare for delivery for when the acute phase of the coronavirus pandemic is over.

The Rank Foundation: Emergency and Resilience Funds

Music For All

UK based community groups and schools who would benefit from a "helping hand" to bring music to their community and fulfil their potential in becoming truly sustainable music programmes.

The funding which is being made available by the charity Music for All, can be put towards musical instrument costs, workshops/training, using music to break down barriers, providing a variety of educational opportunities as well as helping to find ways to integrate many diverse and minority groups positively into society. Grants of up to £2,500 are available, but due to increased demand most awards will be for less than this amount.

UK based community music groups and educational organisations are eligible to apply. Applicants are encouraged to look for other sources of funding to add to the amount needed to deliver the project.

The Masonic Charifable Foundation

Large and Small Grant programmes are currently under review as the organisation examines ways in which it can better target funding to make the greatest possible impact. The new programmes will be open for new applications on Tuesday, 21st August 2018.

The Foundation supports registered charities in England and Wales through the Community Support Grants Scheme which has previously given support for projects that:

- Tackle financial hardship
- Improve the lives of those affected by poor physical and/or mental health and wellbeing
- Provide educational and employment opportunities for disadvantaged children and young people
- Tackle social exclusion and disadvantage.

To date, Charities have been able to apply for large grants of £5,000 and above or for small grants of between £500 – £5,000.

Leeds Building Society Charitable Foundation Grant

UK registered charities working to help those at disadvantage in society can apply to the Leeds Building Society Charitable Foundation for support. Grants of between £250 - £1,000 are available to cover the costs involved directly supporting those in need including those with disabilities, affected by homelessness, or with serious health issues.

Donations usually fund items of "capital expenditure" i.e. items must directly help those in need, rather than contributing to the charity's running costs.

The Foundation accepts applications from UK registered charities with a turnover of less than £1 million per year.

Applications are reviewed every quarter. The next deadline for applications is the 3rd August 2020.

Local charities, community and voluntary groups are carrying out a significant amount of valuable work in our communities during this pandemic to ensure that those people who need help are being supported. Once lockdown measures progressively ease and we enter the recovery phase of Covid-19, it is predicted that there will be a surge in demand for these types of services, but many groups are struggling financially as they are unable to carry out their normal fundraising activities.

The Commissioner has introduced the £250,000 Covid-19 Community Recovery Fund made up from the Innovation, Community and Property Funds to provide short term funding quickly to those groups that support objectives from the Police and Crime Plan in order that they may continue helping communities at this difficult time. The funding can also be used for those who are looking at different ways of working due to the Covid-19 restrictions still being in place for many vulnerable groups. Groups are being encouraged to apply as soon as possible for this funding of up to £5,000, (70% on award, 30% on completion) which must be spent by 31st March 2021. Funding for Projects that Support the Education and Development of Children and Young People

Schools, colleges and community groups in England can apply for grants to support the education and development of children and young people through educational, cultural, sporting and other projects. Of particular interests are projects which will help enhance the self-confidence, team working skills and future employability of children and young people. In most cases grants will be made on a relatively small scale. Many grants will be under £2,000, most will be under £5,000 and only in a few cases will grants exceed £10,000. The funding provided by the BlueSpark Foundation and can be for physical assets (such as iPads, sports equipment, or lighting for stage productions) or for services or facilities (such as sports coaching or music or drama tuition) or simply for the provision of experiences (such as theatre visits). These examples are intended to be illustrative and not restrictive as to the funding which BlueSpark may provide to support projects. Applications can be submitted at any time and must be made online on BlueSpark Foundation's standard Application Form.

Projects that Improve the Wellbeing of Children (UK)

Grants of up to £1,000 are available to registered charities and non-profit organisations who work to improve the education and physical and emotional wellbeing of children. Applicants applying for funding may focus on one or more of these areas: Living in Poverty; Physical & Mental Health Problems; Health & Wellbeing; Living With Disability. Examples of grants awarded in the past include a grant of £5,000 to the Panathlon Foundation for the Panathlon Challenge for young people with disabilities, to fund tournaments and specialist equipment; and a grant of £2,500 JT Inspires to promote the fitness of children and young people with congenital heart disease. The funding is being made available through the Les Mills Fund for Children and the next closing date for applications is 5pm on the 17th November 2020. https://lesmillsfundforchildren.org.uk/apply/

Women Make Music Grants Programme

Grants of up to £5,000 are available to support the development of outstanding women, trans and non-binary songwriters and composers of all genres and backgrounds at different stages of their career. The funding is available to support touring, recording, promotion and marketing, community projects involving high-quality music creators, music creator residencies and live performances featuring new UK music. The funding is being made available through the PRS for Music Foundation's Woman make Music Grants Programme and the closing date for applications is the 5th October 2020.

New to Million Fund For Domestic Abuse Charifies

The Ministry of Housing, Communities and Local Government has re-opened the Domestic abuse safe accommodation: COVID-19 emergency support fund. A total of £1.85 million is available to support domestic violence charities to ensure that they can continue operating and keep bedspaces open for victims and their children fleeing from abuse during COVID-19 emergency. The fund is part of a wider £76 million fund promised to domestic violence and abuse charities to support domestic abuse safe accommodation charities. The fund will be allocated on a first come first served basis and the Ministry of Housing, Communities and Local Government will continue to accept bids until the funding has been exhausted or until 20 July 2020, whichever is sooner. Grants of up to £100,000 are available per individual bid. More may be available for consortium bids.

Funding to Support Projects Which Benefit Local Communities

Grants are available for small, locally based voluntary and community groups to support projects which benefit local communities centred around Co-op Food Stores and funeral homes across the UK or the Isle of Man. The Co-op Local Community Fund will fund projects which help local communities come together to help those in need by providing access to essentials such as community spaces, food and bereavement support; support the mental or physical health of a community through wellbeing activities; or help people develop skills to nurture community spirit and create sustainable communities. Preference will be given to organisations with an income of less than £1 million a year. Applications for this round must be submitted by midnight on the 28th June 2020.

The Foyle Foundation's Small Grants Scheme Re-opens to Support Charities Affected by Covid-19

The Foyle Foundation has re-opened its Small Grants Scheme to support smaller, grass-roots and local charities across the UK during the Covid-19 crisis. Organisations which are currently delivering services to the young, vulnerable, elderly, disadvantaged or the general community either directly or through online support can apply for grants of between £1,000 and £10,000. Funding can be used to cover core costs or essential equipment, to enable ongoing service provision, homeworking, or delivery of online digital services for charities with a turnover of less than £150,000 per annum that can show financial stability and a clear need for their services. Competition for funding is expected to be strong. Applications can be submitted at any time.

The Asda foundation Launches Two New Grants in Response to the Covid-19 Crisis

The Asda Foundation support local grass roots organisations which benefit and involve local communities centred around Asda Food Stores. In response to the coronavirus, the Foundation has launched two new emergency Covid-19 grants: Hygiene Grants which focus on personal hygiene dignity, and supporting residents/patients in facilities who are unable to provide their own toiletries. Applications will be accepted from care homes, hospices, hospitals and homeless shelters; and the Healthy Holiday Grant which would normally hold summer holiday activities to ensure children have a hot meal. Grants of up to £500 are available per group, and up to £1,125 per store. Each store has a Community Champion whose role is to support projects. Applications can be submitted at any time via the community champion.
