THE BEST OF JANUARY'S FUNDING OPPORTUNITIES

The climate Action Fund

will support communities across the UK to take action on climate change by reducing their carbon footprint. These communities will demonstrate what is possible when people take the lead in tackling climate change by working together, sharing their learning and by being active participants in a broader movement of change.

- The amount of funding available per application will depend on what each partnership needs at this stage:
- Applicants who need more time to develop their partnership, engage widely or test their approaches can access initial development funding (up to £200,000 over 18 months)
- Applicants who might be able to start longer-term plans at an earlier stage can access larger, longer-term awards (up to £2.5m over five years)
- Successful applicants will have experience in implementing meaningful action on climate change
- We expect to fund a mix of different places, communities, themes and initiatives, across the UK
- We will use learning from the first round of funding to help shape what happens next and we will test and learn throughout the programme. Further rounds of funding will be available at a later stage.

Deadline: Initial ideas must be submitted by Wednesday 18 December 2019, 5pm. Full proposals must be submitted by **Friday 27 March 2020**, midday. For more information and how to apply please click here.

The Garfield Weston Foundation

has announced the launch of the 2020 round of the Weston Charity Awards. Charities in Wales, the North and Midlands of England with an income of less than £5million a year and working in the fields of Welfare, Youth or Community are eligible to apply for an Award. Twenty winners will be selected who will receive a package of support over the year to help them be successful – this includes free access to experts who can advise the charity on the things they need most, whether that's planning, finances, strategy development, fundraising, expansion or something else. Charities will receive an unrestricted cash contribution of £6,500 to help with the resources to make the most of the year with Pilotlight (This includes travel and expenses to meetings). "Connect" events held throughout the year to allow winning charities to network with other charity leaders.

The closing date for applications is the 10th January 2020 but there will be later calls during 2020 which you can prepare for.

Lloyds Bank Foundation

Charities in England and Wales with an income of between £25,000 and £1million that are tackling complex social issues can now apply for core funding grants worth up to £100,000. The funding is part of the Lloyds Bank Foundations relaunched grants programme which now has a simpler and more flexible approach. The Foundation helps charities to tackle the following complex social issues:

- Addiction and dependency
- Asylum seekers and refugees
- Care leavers
- Domestic abuse
- Homeless and vulnerably housed
- Learning disabilities
- Mental health
- Offending, prison and community service
- Sexual abuse and exploitation
- Trafficking and modern slavery
- Young parents

Grants are available of up to £100,000 and are available over three years (with the possibility of continuing to six years) and can be used entirely for core costs. Core costs are overhead costs of an organisation, as opposed to those specific to a project; with charities able to flex how much they spend each year.

Funding to Use Digital Technology for Vocational Training

The UFI Charitable Trust (Ufi), which aims to help improve vocational skills in the UK's workforce, has announced that it will launch a new call for proposals through its VocTech Seed fund on the 21st January 2020.

VocTech Seed offers grants of up to £50,000 for projects lasting up to 12 months. UFI will be looking for innovative ideas that use digital technology for vocational learning. As the name suggests, VocTech Seed is intended to support innovative and creative projects at a relatively early stage of development. It aims to enable new ideas to reach a point where they can demonstrate their potential to customers or funders and reach the market.

Ufi is also particularly keen to support projects which will have long term impact on employers, communities of learners or sectors which cannot easily access current provision because of industry or market conditions, past learning history or other factors. As part of the launch, the UFI Charitable Trust will be hosting a number of workshops and webinars for potential applicants.

The closing date for applications will be the 13th February 2020.

Greggs foundation

Not-for-profit organisations developing local community projects are being offered the opportunity to apply for a grant of up to £2,000. Any not for profit organisation working to reduce disadvantage experienced by the most deprived people in the community such as the disabled, those living in poverty, voluntary carers and isolated older people can apply. Larger organisations with a turnover in excess of £300,000 are unlikely to be successful with those located near to a Greggs shop most likely to receive awards.

The Greggs Foundation Local Community Projects Fund distributes around £1.8 million per year to organisations throughout England, Scotland and Wales. The Foundation supports projects that improve resilience within communities. This can include sessional activities/respite support, equipment for sessional activities, trips and residential breaks. New approaches and innovative ideas as well as sustainable approaches to supporting communities are welcomed. All projects must support a community of interest, i.e. people who are:

- Disabled or suffering chronic illness / Living in poverty/ Voluntary carers/ Homeless people
- Isolated older people/ Other demonstrable significant need
- Successful applicants will have demonstrated improvements against at least one of the following
 Key Performance Targets: Beneficiaries have decreased social isolation
- Beneficiaries report improved health and wellbeing
- Beneficiaries report improved resilience/coping mechanisms
- Beneficiaries have improved life skills
- Beneficiaries have improved opportunities

The closing date for applications is the 23rd February 2020.

The Weavers' company

a textile-related, charitable and sociable organisation, has announced that the next closing date for its grants programme is the 31st March 2020.

Small registered charities can apply for grants of up to £15,000 for projects working with:

- Young offenders;
- Prisoners and ex-prisoners;
- Young disadvantaged people at risk of criminal involvement.

To be eligible for funding, local organisations such as those working in a village, estate or small town should normally have an income of less than £100,000. Those working across the UK or in larger areas should normally have an income of not more than £250,000. Grants are usually given for one year. Applicants must show that they have investigated other sources of funding and made plans for the future, which should include replacement funding if appropriate.

Tesco Bags of Help

From early January 2020, community groups will be able to apply for funding of up to £2000 for projects in England, Wales and Scotland that benefit their local community. Grants will be awarded to voluntary or community organisations (including registered charities/companies), schools, health bodies (e.g. Clinical Commissioning Groups (CCGs), NHS Hospital Trust, Foundation Trust), Parish/Town Councils, local authorities and social housing providers. The funding has been made available by the Tesco's Bags of Help programme which is administered by Groundwork and can cover a broad range of projects and can be used: to purchase sports kit, litter pickers, camping equipment; improvements to buildings; the development of outdoor space such as a play area or woodland; running a community event or supporting seasonal activities.

Applications are assessed by Groundwork to ensure they are eligible. In areas where application numbers are high, Tesco colleagues will shortlist the projects to determine which go forward to the customer vote. Three community projects in each local area will be voted on by customers in Tesco stores, with projects changing every other month. Following the vote, the project that received the most votes in its area will receive a grant of up to £2,000, second place receiving up to £1,000 and third place up to £500. Since the Bags of Help programme began in 2016, over 27,000 projects have been supported with more than £80 million in community grants.

Applications will be accepted on a rolling basis.

Postcode community Trust

will re-open its grants programme on the 21st January 2020. The Trust was established in 2014 to support marginalised groups in obtaining the skills and resources to effect change in their own communities. Grants of £500 - £20,000 are available to registered charities for projects that benefit communities through grass-roots sports, arts and recreation programmes and healthy living initiatives that improve a community's physical and mental health.

Other voluntary organisations e.g. sports groups, community interest companies and social enterprises can apply for up to £2,000.

The closing date for submitting Expressions to Round One will be the 4th February 2020.

one Stop Shops

Not for profit organisations, including schools that are located within 2 miles of a One Stop shop can apply for grants of up to £1,000 for projects that benefit their local community. One Stop's 'Carriers for Causes' is funded through the money raised from the 5p bag charge in One Stop stores in England, Wales and Scotland.

The grants are available for a wide range of activities and the funding will cover the direct costs needed to deliver the project. Projects eligible for funding include:

- One off community events such as community fun day expenses, summer youth camp, litter picking, sports events, expenses to pay for terminally ill cancer patients on visits to the seaside.
- Purchasing items to run a project such as specialised medical equipment, football/cricket /netball
 kit for local junior club, arts and craft materials for a workshop, kitchen equipment for a healthy
 eating project, marketing materials for an event, fishing kit for youth project.
- Improvements to community buildings such as painting, refurbishing buildings such as hospices,
 scout or guide huts, school building, community centres.
- Improvements to external spaces such as park clean ups, community gardens, hospital/hospice gardens, disabled access projects, food growing projects, woodland walk.
- Purchasing materials to undertake a place-based improvement project such as buying paint, litter pickers, gravel, grass seed, plants, and benches.

Applications can be submitted at any time and are shortlisted on a quarterly basis for panel decision which will take place every three months. Applicants will generally know the outcome of your application within 16 weeks of applying.

Leeds Building Society Charitable Foundation Grant

UK registered charities, or those affiliated with a registered charity working to help those at disadvantage in society can apply to the Leeds Building Society Charitable Foundation for support. Grants of between £250 - £1,000 are available to cover the costs involved in directly supporting those in need including those with disabilities, affected by homelessness, or with serious health issues. Previous grants have gone to organisations supporting young people in applying for jobs and towards the purchase of a portable multi-sensory environment, that will turn any room into a sensory room. Donations usually fund items of "capital expenditure" i.e. items must directly help those in need, rather than contributing to the charity's running costs.

The Foundation accepts applications from UK registered charities, or those affiliated with a registered charity. Applications are reviewed every quarter.

The next deadline for applications is the 11th February 2020.

The Baily Thomas Charifable Fund

is a registered charity which was established to provide both research and project funding in the area of severe learning difficulties, including autism for both children and adults.

Grants are made to cover capital projects and core costs to include staff costs, general running and office costs at charitable organisations, schools and centres.

Projects funded include:

- Capital works for residential, nursing and respite care, and schools
- Employment schemes including woodwork, crafts, printing and horticulture
- Play schemes and play therapy schemes
- Day and social activities centres including building costs and running costs
- Support for families, including respite schemes
- Independent living schemes
- Support in the community schemes
- Snoezelen rooms.

Applications will only be considered from voluntary organisations which are registered charities or are associated with a registered charity. Schools and Parent Teacher Associations and Industrial & Provident Societies can also apply. Funding in the past has ranged in value from £250 to £150,000.

The next deadline for applications seeking funding in excess of £10,000 is the 1st March 2020.

Applications for £10,000 and below are considered under the Small Grants procedure and can be submitted at any time.

Arts Impact Fund (England)

Arts Council England has announced that loans of between £150,000 and £600,000 are available to entrepreneurial arts and cultural organisations. The aim of the loans is to increase the resilience of art and culture in England.

The loans can be used, among other things, to:

- Acquire new assets
- Improve built infrastructure
- Develop new ventures
- Scale up existing revenue streams.

The Arts Impact Fund is created and funded by Bank of America Merrill Lynch, the Esmée Fairbairn Foundation and Nesta. It's supported by the Arts Council with additional funding from the Calouste Gulbenkian Foundation.

Unsecured loans are available with a repayment term of between three and five years with interest rates ranging between 3.5% and 8.5%.

Applications are accepted at any time.

Grants of up to £1,000 Available for Projects that Improve the Wellbeing of Children – 28th April 2020 (UK) Les Mills Charitable Fund

Grants of up to £1,000 are available to registered charities and non-profit organisations who work to improve the education and physical and emotional wellbeing of children.

Applicants applying for funding may focus on one or more of these areas:

- Living in Poverty
- Physical & Mental Health Problems
- Health & Wellbeing
- Living with Disability

The next closing date for applications is 5pm on the 28th April 2020.

The Arts council England

has announced that the V&A Purchase Fund has been renewed until 2022. Accredited museums, specialist libraries and record repositories accredited under the Archive Service Accreditation Scheme can now apply for a share of the £724,000 of funding available this year.

The fund enables regional museums and cultural organisations to strengthen the quality, relevance and standard of their permanent collections and supports the purchase of a wide range of material for the permanent collections of organisations in England and Wales. The purchase price of an object should be between £500 and £500,000 with grants available for up to 50% of the purchase price, though it is unlikely that any organisation will receive more than £50,000 in any one year.

Applications are accepted at any time.

Sport England

Sports clubs, local authorities, schools and community organisations can apply for grants of between £1,000 and £150,000 to enhance local sports and recreational facilities. The funding which is being provided through Sport England's Community Asset Fund can be used to enhance traditional sports facilities as well as outdoor spaces like canal towpaths, woodlands and open spaces; etc that can be used as part of an active lifestyle.

Statutory bodies and education establishments will specifically need to:

- Provide a minimum of pound-for-pound partnership funding;
- Demonstrate the strategic need for their project proportionate to the scale of investment requested;
- Limit requests to a maximum of £150,000 within any 12-month period.

Sport England typically expect their awards to be either:

- Small-scale investments typically ranging from £1,000 to £15,000. These will address emergency works due to something like storm or flood damage, or something totally unexpected that is stopping people from being able to stay active right now.
- Medium-scale investments typically ranging from between £15,000 to £50,000. These will address
 more substantial changes. This might be an upgrade to an existing facility or developing a new
 space in the community.
- By exception, Sport England will consider larger investments ranging from £50,000 to £150,000.
 This will be when organisations can demonstrate a considerable impact or are targeting under-represented groups. They are also unlikely to have received funding from Sport England previously.

The Joseph Rownfree Charifable Trust (JRCT)

is interested in funding work which is about removing problems through radical solutions, and not simply about making problems easier to live with; that has a clear sense of objectives, and of how to achieve them; and is innovative and imaginative and where the grant has a good chance of making a difference.

JCRT makes grants to a range of organisations including registered, excepted or exempt charities based in the UK for work that seeks to make positive change across the UK as a whole, or across one or more of its member countries – England, Scotland, Wales or Northern Ireland.

The Funding priorities for the Rights and Justice theme are:

- I. Protection and promotion of human rights and their enforcement in the UK
- 2. Promoting rights and justice for minorities who face the most severe forms of racism
- 3. Promotion of rights and justice for refugees and other migrants by identifying and tackling structures and systems that may deny them their rights.

JRCT focuses on work at both a national and European level, although work at a European level is limited and must have direct relevance to communities living in the UK.

Whilst the focus is to support national advocacy and campaigning, JRCT is open to applications which aim to effect structural change at local and regional levels of policy-making, provided the applicant can demonstrate the wider significance of the work.

Across the policy, JRCT places an emphasis on supporting those who have direct experience of racism and oppression. Applicants are encouraged to apply for a grant for unrestricted or core support, although support for specific programme or project funding is also available.

The next round of the Joseph Rowntree Charitable Trust's Rights and Justice programme is now open and will close on the 23rd March 2020.

The co-op foundation

is offering interest free loans for enterprising ideas to improve community spaces. Community organisations that manage community buildings and outdoor spaces such as parks and community centres; etc which are for the use of the whole community can apply for loans to grow their trading activities to generate more sustainable income.

The Co-op Foundation can offer:

- Interest-free loans of up to £50,000 towards viable business ideas that will benefit the whole community – particularly those facing greater challenges.
- No repayments for the first year, while your trading activities are developing.
- If you are based in a more deprived area, or your work mainly benefits more disadvantaged members of the community, we might also be able to offer some grant funding alongside a loan.

The Comic Relief Community Fund

administrated by Groundwork, is offering grants to grassroots community organisations with an income of less than £250,000. There are two types of grants available to organisations whose work delivers on one of Comic Relief's four strategic themes:

- Children Survive & Thrive: projects that support children under the age of 5 to reach their potential and have the best start in life.
- Fighting for Gender Justice: projects that improve equality for women, girls and the LGBTQI+ community and initiatives that help people affected by domestic violence, abuse or exploitation due to their gender.
- A Safe Place to Be: projects that support people who are rebuilding their lives because of homelessness or forced migration.
- Mental Health Matters: projects that support good mental health in communities, improve access to support and tackle stigma and discrimination.

The funding aims to strengthen local organisations by helping them with skills and advice to drive community projects forward, as well as providing the necessary funding and support that groups need to kick-start new initiatives. Funding is available through two strands:

- Capacity Building Grants (up to £500): These grants will support a wide range of activities, from
 developing better organisational governance, policies and procedures to increasing understanding
 of beneficiary needs, to increasing organisational delivery capacity.
- Project Delivery Grant (up to £4,000): These grants will support grassroots organisations to
 deliver projects that address Comic Relief's four strategic themes (as listed above). Projects
 should be able to clearly show, the local need for the project, robust planning, and legacy.

The Bupa UK Foundation's purpose is to help people live longer, healthier, happier lives. The Foundation fund practical projects to tackle challenges in health and social care and make a direct impact on people's health and wellbeing. Since 2015 the Bupa UK Foundation has awarded more than £1.6 million in grants to improve mental health, support carers and empower young adults living with ongoing health challenges to live life to the full.

The Woodward Charifable Trust award grants

(typically around £3,000) towards the core costs for small charities, CIOs and CICs. Please note that the Trust does not fund unsolicited applications from charities whose annual income exceeds £300,000 or an organisation that has more than six months running costs in its unrestricted reserves. Trustees will consider applications for core costs in at least one of the following areas:

- Arts outreach work by local groups involving disadvantaged people;
- Children and young people who are isolated, at risk of exclusion or involved in anti-social behaviour and in particular organisations that work to discourage individuals getting involved in gangs or violent behaviour;
- Disability projects, which can include rehabilitation and training for people who are either
 physically or learning disabled as well as charities supporting mental health issues, particularly
 where it relates to our other priority areas;
- Disadvantaged women and their children, covering refuges and domestic violence shelters and groups;
- Disadvantaged families including parenting support;
- Prisoners and ex-offenders and specifically projects that help the rehabilitation and resettlement
 of prisoners and/or ex-offenders as well as requests to help prisoners' families;
- Projects that promote integration and community cohesion particularly amongst minority groups, refugees and traveller communities.

The Trustees make two types of grants – **smaller grants** of under £3,000, usually around 100 grants per year; and **larger grants** of over £3,000, usually no more than 5-8 per year and almost always to charities already known to the Trustees. The Trustees favour small-scale, locally based initiatives and most grants are only for one year. In addition, 60-70 grants of £250-£1,000 per year are made towards Children's Summer Playschemes. Applications open from 1 February 2020 and are considered in April/May each year, grants are only given to charities whose annual income is under £100,000.

The Pefer cruddas foundation

Priority is given to programmes designed to help disadvantaged and disengaged young people in the age range of 14 to 30, to pursue pathways to Education, Training and Employment with the ultimate aim of helping them to become financially independent. Priority is given to applicants able to demonstrate that they can manage the amount they have applied for and how they intend to continue after the funding has been spent. Please note that the Foundation is not accepting applications for Capital Projects. Eligible applicants will be charities registered with the charity commission in England and Wales benefitting people living in England and Wales.

The next closing date for applications is the 1st March 2020. Useful Links:

Grants From Trusthouse

Trusthouse gives grants for running costs or one-off capital costs to charities and not-for-profit organisations in accordance with criteria that are regularly reviewed and decided by the Trustees. Our overarching themes are Rural Issues and Urban Deprivation.

Rural Issues:

We are looking for applications from organisations which are addressing issues in rural areas. 'Rural' in this context means cities, towns, villages and areas with 10,000 or less inhabitants which are classified in the latest government Indices of Multiple Deprivation as being in the most deprived 50%. We are interested in, for example, projects providing transport for the elderly, disabled or disadvantaged; contact networks for the young disabled; projects which encourage a sense of community such as community centres and village halls; employment training schemes especially those promoting local, traditional crafts; projects addressing issues such as drug/alcohol misuse or homelessness.

Urban Deprivation:

We are seeking applications from local charities or not-for-profit organisations which are working with residents of urban areas (i.e. more than 10,000 inhabitants) which are classified in the latest government Indices of Multiple Deprivation as being in the most deprived 20%. We are interested in, for example, youth clubs; training schemes to help people out of unemployment; drop in centres for the homeless. National charities might be eligible if working in a specific area which is within the deprivation ranks described above.

Applicants must clearly show in their application how their project fits into one or both of these categories. Within these overarching themes, we are interested in two areas:

- **Community Support** For example: work with young people; community centres; support for carers; older people's projects; help for refugees; family support; community transport; sports projects; rehabilitation of ex-offenders; alcohol and drug misuse projects; domestic violence prevention and aftermath; support groups for people with disabilities.
- Arts, Education and Heritage For example: arts projects for people with disabilities;
 performance or visual arts with a clear and strong community impact; alternative education
 projects; supplementary teaching; heritage projects in marine or industrial areas which involve
 local people and have a demonstrable community benefit.
