- 1) The meeting was called to order at 10:00 A.M.
- 2) Meeting Safety Briefing was given by Chairman, Donn Thane.
- **3)** Consent for current Agenda and order of business (Single Motion Needed): Approval of current Agenda, motioned by Eubanks and seconded by Nolle, all approved.
- **4) Consent for previous meeting minutes (Single Motion Needed):** Approval of Minutes from 6/27/2019 Board Meeting, motioned by Weston, seconded by Walker, all approved.
- 5) Public Comment: None were made.

6) Agency/Partner Reports:

<u>Jenn Tamo</u> of NevCo OES: Reported that the Code Red Test will be done annually. An Insurance Town Hall will take place this evening (Aug. 22) with the CA Insurance Commissioner Ricardo Lara speaking. Event is anticipated to be full so overflow spaces will be available for the public at the Eric Rood Center. GreenWaste drop sites are happening in Floriston soon. FEMA Access & Functional needs Grant is coming soon. The Nevada County Stakeholder meeting is next week.

Julie Martin of BLM- Round Mountain project starts this winter.

<u>Jecobie Waters of USFS</u>: The Madrone Springs under burn project area is being prepped right now. There is a 4,300-acre fuel reduction beginning in Western Nevada City. There is a prescribed burn north of Hwy 20 and to the west. USFS is finished with their portion of the FSCNC project. An 82-acre mastication project is starting and finishes NFWF project. A 239-acre project in Cascade Shores and Lower Greenhorn begin in one week.

<u>Jim Mathias</u> of Cal Fire: Ponderosa West started this Tuesday and will be going light at first and will be mostly hand cutting. These debris piles will be burned in the winter. The Governor's declaration for additional seasonal hires is well underway. While talking with the public these next few months all parties are recommended to talk about doing the right thing, but in the wrong way or at the wrong time. Comparison of 18 & 19 incidents (information and occurrence).

<u>Matt Furtado</u> of Cal Fire: Would like people to note that tensions are high, and residents are nervous, so he asks that people be extra diligent about sharing proper and correct information.

<u>Terry McMahon</u> of Nevada County Consolidated: County Defensible Space Inspections group has 200 complaints currently and are coming in at a rate of 2-3 new per day. Steve Monaghan stated there are currently two openings for Defensible Space Inspectors.

7) Report from the Executive Committee -Donn Thane:

- a. Meeting with Lake Wildwood regarding Green Waste is coming soon.
- b. A draft of the Executive Director priorities has been included in the Board Packet and will be coming online in October.
- c. The interviews for new directors have been completed, and the Nominating Committee recommends Julie Siegenthaler for Secretary, and Janeth Marroletti for Director.
- 8) Report from the Finance Committee -<u>Dave Walker</u>:
 - a. The Audit for the 2017/2018 taxes is underway and is nearly completed.
 - b. Samples of the new reporting style are included in the Board Packet.
 - c. FSCNC has applied for the \$400k new equipment line of credit.
- 9) Report from the Chairman Donn Thane: shared the time as an example of how director reports could work for various programs: Pete Williams has reported there were 400 Defensible Space Advisory Visits (DSAV) in 2018, and there has been a substantial increase to 1,000 so far in 2019. Alan reported there are 32 Firewise Communities in training, with 36 certified, and 2 pending certifications.

10) Report from the Executive Director – Jamie Jones:

- a. PG&E is offering Stevenson Grants in the amount of \$50K for roadside vegetation management on private roads.
- b. Matt and Chris were introduced as new staff members, in addition to Jon and Spencer. An admin, named Allison, will start on Monday. Etta is no longer in the office as of the date that public school resumed session.
- c. Matt has obtained Right of Entry for 400+ acres for Ponderosa West. There are four Denials of Entry at this time. September 4th is the Open House for the Ponderosa Project; the format will be more of an Open House than a Town Hall. Sheila indicated the messaging highlights collaboration and has received a 53% positive return immediately.
- d. Listos CA is sending funding to small local groups to better reach residents in minority groups. Extreme detail for this funding is required for tracking. A campaign implementation meeting and press conference will take place in the future.
- **11) Report from the Fundraising Committee –** <u>Bill Drown</u>: Approximately 150 tickets have been sold, so far. The press release is being held for conformation by John Paye. Allison Kirk is no longer planning, and a new planner Gillian Shenon is taking her place. Red Zone Affair is September 27 and 28th.
- 12) Report from Projects Committee- <u>Donn Thane</u>: DSAV update class to include Yuba County FSC was a success and will be repeated annually.

13) Director Comments:

<u>Wanda Mertens –</u> Insurance Companies change their cancellation requirements as frequently as 10-day cycles. Hartford is currently using the National Fire Protection Agency (NFPA) Firewise (FWC) standard

in determinations. More insurance carriers are also using NFPA guidelines. Insurance inspectors do not have specific knowledge for state or local guidelines, they are only recording and reporting back to the insurance carrier. A Firewise Community spreadsheet helped eliminate a cancelation that was threatened.

- 14) Presentation to the board by Trisha Tillotson, head of Nevada County Public Works: Anyone can clear their property all the way up to the roadside if they are not standing or working in the roadway. Nevada County has 1,500 miles of private roads, which is three times as much as public roads; therefore, most of the roadside clearance in Nevada County is the responsibility of individual property owners. Individuals can request on-the-spot service through the Ask Nevada County app.
- **15) Reporting out of Closed Session (Only Voting Board Members May Participate):** Commenced at approximately 11:45. Board of Directors discussed Non-Disclosure Signature Forms and Had a conference with legal counsel concerning existing litigation Subdivision (a) of Section 54956.9)w Drummond v. Fire Safe Council. Closed session was adjourned at 12:15.

The meeting was called to order at 9:29 A.M.

 Public Comment: Director Jones played a video clip of Steve Monaghan presenting at the last Board of Supervisor's (BOS) Meeting, during which he utilized the Stakeholder Meeting presentation materials prepared by Jones. Monaghan stated that the Fire Safe Council of Nevada County (FSCNC) was the County's primary partner for wildfire, expressing confidence after having attended a recent FSCNC Board Meeting. Executive Director Jones further relayed there were unanimously positive comments made by the BOS regarding the presence and momentum of FSCNC in the county. Dan Miller noted that the FSCNC has been very active and visible in the County, of late.

In addition, Matthew Coulter, well-known on local social media pages for his candor, commented that should FSCNC request funding, the County should react favorably to such requests. Jones encouraged the Board to view the video replay of the BOS meeting. The Union was in attendance, and published an article in response.

Executive Director Jones was told by the County that, though not listed yet, the entire \$12M FEMA funding will be run through FSCNC.

The presentation included discussion of the \$60 in funding from Proposition 172, there was an additional \$18 amendment that came from an increase in taxes, directly out of the County's portion of funding. Director Weston clarified that Prop 172 are distributed to departments based on a formula and that the funds will come directly from the County's portion, and thus will not affect funding for the Fire Department.

Chairman commended the Board and Executive Director Jones for working so diligently on improving communication and visibility, as engendering such positive feedback from the County possible.

2. Red Zone Affair: ED Jones indicates the event is sold out, which was unfortunately prior to the promotion in the press. More sponsors are interested, but including them may not be fair to the original sponsors. The event coordinators will provide a list of duties for the 10 volunteers FSCNC has offered. Set-up and tear-down are provided by catering. The food will be buffet-style, served by Maria's and

Kane's. Directors Williams, Trygg, and Weston have indicated an interest in volunteering. The Board will likely be met by the FSCNC Board. Dress code will not be formal, as initially promoted based on attendee feedback, but will be red-themed, and as comfortably formal as suitable to and outdoor event.

3. SNAP Title Change: ED Jones informed the Board that the Special Needs Assistance Program (SNAP) name does not align with Federal and State nomenclature, which is Access and Functional Needs Program. Regardless of name, this program addresses needs for disabled, low-income, and elderly families and is a component of FEMA funding. Jones recommended the Board consider a name change from SNAP to Access and Functional Needs Program. Director Weston moved that the name be changed, with a second by Director Trygg. The motion passed unanimously.

Chairman Thane asked that Jones involve Director Marroletti in this program with her extensive experience and interest in serving seniors, as well as her position with Gold Country Community Services.

4. Board Organization Structure and Roles: ED Jones stated that Associate Directors function more as Agency Partners, and not as Directors. Jones suggested that the title Associate Directors may not be appropriate for a representative from an agency, and may give those representatives the impression that they have voting rights on regular Board decisions. They are listed on Agency Partner reports, so for the sake of consistency Jones recommends these Associate Directors be given the title Agency Partner, particularly given the agencies will send different representatives, rather than a single and consistent representative.

Director Trygg indicated the roles and lists of partners may need to be cleaned up to remove inactive members.

Treasurer Walker made a motion eliminate the term Associate Director, with a second by Director Weston. The motion was unanimously passed. ED Jones suggested a review of the Agency Partner list, adding and removing as appropriate. If an individual or organization is interested in participating, but not as an engaged and active Agency Partner, they are still welcome to attend public meetings. Chairman Thane will contact Agency Partners to see if they are still interested in active participation with FSCNC.

5. Director Training and Board Retreat: Chairman Thane and Director Williams attended a training session at the Center for Nonprofit Leadership (CNL), at which FSCNC has a membership. The class was "Board Essentials: Getting to Great" which was very informative. Thane would like to ask Board Members to attend 1-2 training sessions at CNL per year, which will be paid for by FSCNC. ED Jones commented that this training would be helpful for new Board members, as well. FSCNC will obtain the class schedule for each year, then ask Directors to pick two they will attend, reporting their selection at a subsequent meeting.

Chairman Thane and Director Williams held orientation for new Directors Julie Siegenthaler and Janeth Marrioletti to introduce them to FSCNC.

Chairman Thane is proposing a single-day Board retreat for strategic planning some time from mid-February through the end of March. Director Williams will lead the committee to organize the retreat. Several suggestions were made by those in attendance, but in the interest of time, Chairman Thane suggested those with comments or suggestions should forward them to Director Williams via email. Williams indicated the Director Training process is already established, and that the retreats should be more strategic in nature.

Ponderosa West Project: Steve Garcia will be conducting 40-acres of field review. The masticator head is on its way, and work could start as early as Sept. 13. Labor crew of twelve is contracted, with potential to inherit another 35-40 from the North Fork Project. Crews will being work in the next week or so. County property is dependent on Washington Ridge crew availability, which has been getting calls for fires. The Native Plant Society is still on Board.

Ponderosa West Open House event was a great success. Several Right-of-Entries were given following the event, and ED Jones would like to thank the Board for their support. The County is reluctant to finalize verbiage of contract, but is working with Jones and Steve Monaghan, and Nevada County CEO Allison Lehman to get details figured out. FSCNC will be able to invoice the county multiple times per month, and in advance if needed, to assist those contractors who have weekly payroll demands. Jenn Tamo with Nevada County is modifying the project to include the northern BLM parcel. ED Jones is looking into getting SEQA funds to help cover that area, and meet the goal of 300 acres.

Matt is doing a great job of organization on this project.

Getting the chipper vehicles for this project is held up with financing, which will hold up the contract. FSCNC is looking at USDA Rural Community Loans for nonprofits. Tax returns from 2015-2017 made FSCNC look unfavorable as a loan candidate. Jones will keep the board updated. Down-payment has been made, and paperwork has been signed. The administrative fee on the grant could cover the vehicles, with the funds to be re-allocated as they are available. Local financial institutions are willing to partner with FSCNC, however the corporate underwriters don't have the same level of motivation. Director Walker educated the Board about the challenges in the banking industry. Director Weston suggested the County has a loan pool at the going interest rate that ED Jones could look into. Jones is very interested in keeping the loan funds from the local community. The total funds needed for the vehicles is \$160k, and the next payment is TBD. These trucks are needed to execute the roadside vegetation and chipping grants. Currently, a Ponderosa vehicle is being borrowed for this project. Jones communicated the need and benefits of adding vehicles to the fleet, not only for these projects, but also for ongoing needs.

- 6. Firewise Communities: There are a total of 37 established Firewise Communities in Nevada County. Funding for fifteen new communities, which have already been selected, were approved by the County, and partners are working on them. An additional four are self-funded, three of which are in Truckee. The new total upon completion will be 56 communities. There are still 38 communities on the wait list.
- 7. Grants: ED Jones anticipates the next round of Cal Fire grants in Oct. Woodpecker Ravine (between Alta Sierra and Colfax/174) is slated as the next project, similar in scope to Ponderosa West. FSCNC will likely apply for the Firewise Community Grant that will allow a Firewise coordinator in the office for assessments, education, etc. If the zero-emissions vehicle applied for through the Northern Sierra Air Quality Management District is awarded, that vehicle will likely be used by the Firewise Coordinator. Joe Fish at NSAQMD specifically requested an application from FSCNC for this grant.
- 8. Budget: See discussion above about Ponderosa West vehicle purchase regarding moving budget among line items to secure vehicles.

Equipment and Vehicle Purchase Status: See discussion above.

9. Lake Wildwood Green Waste Event: Debris piles are to be burned in the winter. Chairman Thane will work with Don Wagner to get an engine and water tender on site at time of burn, and will ask Wildwood to tarp the piles so it will burn easily. Though this project did not go according to FSCNC expectations, and at this point it's easiest to help Wildwood get the debris cleared, though this was not our original plan. A letter was written that contained several false statements, but in the interest of keeping the community safe, we will assist Wildwood with this disposal. ED Jones expressed her frustration with this project, but will no longer recommend holding a Green Waste Event inside Lake Wildwood.

Closing Comments: Director Drown stated Liz Kellar from The Union would be interested in attending a Board meeting from time to time. Director Drown asked if it would be acceptable for her to attend, and of course it is. All such requests should be referred to ED Jones or to Chairman Thane.

10. Motion to adjourn 10:49 by Chairman Thane, seconded by Bill Drown. Meeting adjourned to Closed Session.
