1. CALL TO ORDER ROLL CALL

Meeting called to order by Chairman Thane at 10:00 AM via Zoom teleconference Attendance as indicated above.

2. AGENDA AND ORDER OF BUSINESS

DW moved to approve the Agenda. Seconded by PW. Approved by unanimous vote.

3. MEETING MINUTES

PW moved acceptance of the Minutes from the June 25th, 2020 FSC Board Meeting. This was seconded by DW and approved by unanimous vote

4. PUBLIC COMMENT

No public in attendance.

5. AGENCY/PARTNER REPORTS – (Please limit to 3-5 minutes)

- 1. Firewise Coalition Bob Long reported on the Coalition Zoom conference and training. Attendance was over 300 people, and the event be used by individual Firewise Communities as their annual NFPA required training exercises. The next program will be on the Nevada County Dashboard.
- 2. NCCFD Patrick Mason reported on the Defensible Space Inspection program. The District is sitting at 105 complaints right now and have only one part-time inspectors. The District will be hiring two more. Terry McMann reported that the County 211 program proved to be a good means of transmitting information during the Jones fire.
- 3. Office of Emergency Services Paul Cummings reported the recent Jones Fire. 4000 people were contacted and evacuated. Code Red worked quite well, and residents responded appropriately. Coordination between all services worked very well. The county Dashboard on the fire was overwhelmed by significant use (up to over a million hits per hour) much from users outside the county, but most users got timely information. The High/Low sirens worked well and expedited the evacuations
- 4. CalFire Jim Mathias also reported on the Jones Fire delivering a history of the fire and results. He mentioned that many households in the fire area had clearly been working hard on developing good defensible space and that County and FSC efforts had helped stimulate these actions. He stated that FSC was very effective in the Ready part of the Ready/Set/Go program. Only 14 units were lost. 20 units were saved.
- 5. NSAQMD David Nicolson reported on the air quality during the Jones Fire and cited the Air Now website as the place where local air quality is made available.
- 6. Jamie reported for Caleb Dardic on the Nev. Co. Relief Campaign for fire victims. They have raised \$16,000 since Saturday. Two case workers have been tasked to help survivors in need.

6. REPORT OF THE FINANCE COMMITTEE - Dave Walker

1. DW provided the Financial Report as of May 31, 2020 citing **Revenue** of \$ 2,437,696, and a **Net Revenue** of \$ 65,198. We have \$53,086 in the bank.

He also reported that the extremely successful Greenwaste program had left FSC with a financial problem. The cost of disposing of the waste had left FSC with a substantial deficit. Action on this issue will be further reported on below.

- 2. EDJ also reported on a current problem with the Chipping Program.

 Because of Covid19 we cannot use convict labor, so labor costs have gone up. We currently ask for "donations," but they cannot legally be certified as donations for tax purposes. Most "members" think that their "membership fee" covers their free chipping. We currently do not have a grant to cover the cost of chipping (\$150/hr). so chipping is running in the red.
- 3. DW recommended the need to change our marketing of this program to a "Low Cost Chipping Program" instead of the "free chipping." Discussion indicated that FSC needs to invoice our customers to cover the cost of the chipping program and find a way to help people who cannot afford the low-cost program. DW moved that FSC develop a new marketing program based on a Fee for Service model and a mechanism for charging customers. SE seconded the motion. The motion passed unanimously.

7. REPORT OF THE CHAIRMAN OF THE BOARD – Donn Thane

- 1. A Nominating Committee has been selected by the Chairman and agreed to by the ExecFinance Committee for referral to the FSC Board. This committee for 2020 consists of HW, SE and PW. WK moved that this proposed Committee be commissioned by the FSC Board. DW seconded the motion. The motion passed unanimously.
- 2. Director Janeth Marroletti has submitted her resignation as FSC Director.
- 3. The ExecFinance Committee had discussed FSC Board Member participation and involvement. This discussion should be considered a work in process, but that one possible action could be to actively involve individual Board Members in ongoing FSC efforts. A tour of the Ponderosa Project could be one such activity. ET volunteered for such a tour in September.

8. REPORT FROM THE EXECUTIVE DIRECTOR - Jamie Jones

- 1. EDJ reported that after further research she has found that FSC does not qualify as a tax-exempt group by the State of California. We are tax-exempt for the Federal level.
- 2. EDJ review employment numbers for the ExecFin Comm. FSC had staffed up to over 20 people in January in anticipation of both Ponderosa and the Greenwaste project. However, due mostly to the Federal Covid19 supplementary funding program a number of new employees simply abandoned work to apply for the \$600/wk federal support program. FSC employment is now at 15 people. Because we had reached the twenty-person trigger for supplying benefit packages to all employees, the Board had authorized the implementation of a benefit package for all employees. We have not yet started this process, but the budget has been approved for this year. However, reasonable benefits packages are an employment incentive for potential employees. In fairness, EDJ will move forward on this program.
- 3. EDJ reviewed concerns over potential legal issues downstream due to Covid19 exposure of volunteers in the DSAV program and the "trainer/trainee" buddy program under which we had been operating. FSC currently has a backlog of DSAV's and therefore Advisor training must be completed. As a precaution, FSC will look to obtaining wavers with both Advisors and customers that all DSAV efforts are being done under current State required protocols and entirely voluntary. A web-based process is in development to include a wavier as part of the sign-up process.
- 4. Grant Applications Update Another Coalitions Co-operative Grant that we will be applying for that will allow us to do some potential burn-pile project with the USFS. Also, a planning grant to develop a committee on how to serve the community with potential fire information.
- 5. Greenwaste: In 2019 we had collected 500 tons of greenwaste. This year we collected over 5000 tons, three quarters of this was collected in the last two weeks. It resulted in an astronomical pile of chipping to be moved. The result is that when all the great community support is included, we are still \$117,000 over budget. As indicated above, this shortfall can in part be offset by the complete forgiveness of the \$77,000 Federal PPP loan. Further discussion indicated that income from the Ponderosa Project would also be available to cover the remaining deficit.

DW moved that the ExecFin approve and forward to the full FSC Board that

- i. The Federal PPP loan of \$77,000 be added to the FSC budget and applied to employee costs of the Greenwaste project, and that
- ii. \$40,000 of income from the Ponderosa Project be applied to the remaining Greenwaste costs.

PW seconded this motion. The motion was approved unanimously.

- 6. Lake Wildwood Firewise Recertification: FSC has been asked by Cal-Fire to help them meet their deliverables on their grant to be recertification as a Firewise Community. FSC estimates this will cost about \$2500 to complete this work as a subcontractor under their grant. Recertification would need to be completed by April 2021. No discussions have as yet been held with the LWW Board. The FSC Board indicated that the FSC should discuss this with the Penn Valley Fire Board. HW moved that FSC should develop a MOU with the LWW Board, the LWW General Manger and Penn Valley Fire detailing the deliverables. This was seconded by SH. The motion was approved unanimously.
- 7. Programs: Julie Siegenthaler has recovered from the Greenwaste and the Fire Season Guide is out. She did a phenomenal job on both. Now she has the Chipping Program ready to go online and will report into our software and will simplify the management of this program. She is revamping the DSAV packet, started a DSAV newsletter and initiated group conferences. We have had a number of requests for people to obtain DSAV training. Truckee would love to have a training there. In this year of Covid19, the way we will be looking to accomplish such training will be by video/web seminar. We are looking to

record presentations and present webinars. These could be both live, and the be available for multiple training sessions augmented by interactive web meetings. We have been having trouble identifying viable candidates for our Access and Functional Needs Program (AFN). A lot of qualified people don't actually own homes. We have completed the 15 homes for which we had funding from the County and PG&E has supplied funding for 30 more homes. A press release has gone out, and we have received additional requests and we will be qualifying these with environmental review and sending them on to FEMA for additional funding.

9. DIRECTORS' COMMENTS

ET thanked Bob Long for making an excellent presentation on Firewise Communities to the Rotary Club.

ED stated that he lives in the Jones Bar area and the Code Red worked well. He would be happy to share his perspective with any of the agencies. **SH** responded to thank ED because OES is looking to capture all that type of information. Jim Mathias from CalFire responded that he also is collecting all that information if ED is willing to email it to him. **ED** also stated that he is doing the mapping for Brittney Firewise and for Kentucky Flat.

RN noted that the Real Estate industry has taken extreme steps to mitigate potential legal risks due to Covid19 using forms that individual interested in home and homeowners have to execute before any action or visitations are made. There are fears in the industry that huge lawsuits are just waiting out there. RN will send Jamie copies of documents being used by the industry. Limitational liability is the "way to go."

HW agreed with RN that we need to be super careful.

WM from the insurance industry gave kudos to the agencies involved in working cooperatively with all the residents of the Jones Fire. Also, Kudos to the newsletter that Julie put out. And on the Covid19 issue, she is seeing a calmer and accepting attitude from most people. On the Jones Fire, often insurance agencies will not write policies until 48 hours after a fire is contained, but some agencies will write them now.

RN thanked Jim Mathias for the great job CalFire did on the whole Jones Fire situation.
