1. CALL TO ORDER ROLL CALL

Meeting called to order by Chairman Thane at 10:00 AM via Zoom teleconference Attendance as indicated above.

2. AGENDA AND ORDER OF BUSINESS

3. MEETING MINUTES

WK moved acceptance of the Minutes from the January 28, 2020 FSC Board Meeting. This was seconded by SE and approved by unanimous vote

4. PUBLIC COMMENT

5. SPECIAL AGENCY/PARTNER REPORTS

- Kate Dargan, California FSC -- co-chair (in partnership with Bob Roper) of the California Fire Safe Council.
 Announced the appointment of Hedi Jalon as the new Executive Director of CFSC.
 Announced a refocus of CFSC. Slide presentation attached.
- 2. Paul Cummings, Office of Emergency Services, Nevada County Presented OES new Operational Plan for 2021 focusing on:

AGENCY/PARTNER REPORTS - (Please limit to 3-5 minutes)

1. USFS – Rita Clipperton -- Have continued focus on understory burning along north Highway 20.

2. Firewise Coalition – Scott Beasley – the new Directory of Firewise Coalition stated he was still in the discovery and data gathering phase of his new responsibilities. He is especially interested in Insurance issues and situational awareness for evacuations.

6. REPORT OF THE FINANCE COMMITTEE

1. RN reported on behalf of the traveling DW that the December Financial Report is not fully closed due to the vacancy in the Bookkeeper role at FSC.

Net Revenues: - \$ 79,000

RN explained that this negative income is due in large part to the required billing processes for some of our Grants. Some grant incomes may come monthly, others quarterly, and some upon completion of the grant requirements. This may mean that FSC will be doing work for some variable period of time before seeing income from work completed.

The critical bottom line is that FSC currently has over \$300,000 in its bank account.

RN also referenced the \$130,000 cost overrun on this summer's GreenWaste program was due to the tremendous response to this program. This overrun was paid out of previously retained earnings.

- RN also referenced a bookkeeping error that cost FSC about \$90,000 in Covid PPE response funding.
- 3. EDJ reported that 2019 Audit has been completed, and that again because of bookkeeping errors there were some significant cost overruns not covered by the existing contract. Board action was required to cover this overrun.
- 4. EDJ also reported that the Auditor's contract was currently up for renewal, and that the relationship was a very good one. A recommendation for a three-year contract was made, and a request for Board action on this issue was also required.
- 5. SW moved that the Board authorize supplemental payment of the existing Auditor cost overrun. This was seconded by HW and unanimously accepted by the Board.
- 6. SW also moved that a new three-year contract be authorized for the existing Auditor. This was seconded by HW and unanimously approved by the Board.

7. REPORT OF THE CHAIRMAN OF THE BOARD – Donn Thane

- 1. DT outlined the need for a "Board Historian" that would track over time the major milestones of the FSC on a monthly basis. This information would be used, in part, to performance of the executive director. SH volunteered to assume this role.
- 2. DT outlined the process and timeline for the June salary review for the executive director.
- 3, DT reported that he had met with the principal supporter of the postponed Red Zone Fund Raiser, and that the event is still of major interest. SE volunteered to chair the effort and will be looking for an event in the Fall hopefully in the Fall.

8. REPORT FROM THE EXECUTIVE DIRECTOR – Jamie Jones

- EDJ introduced Billy Spearing, FSC Grant Accountant, as the first FSC employee to be formally introduced to the Board to increase Board awareness of employees and their responsibilities. Billy provided a brief bit of personal background and her efforts to manage all the data and information necessary to manage and report all activities on these grants. Billy is also handling all social media activities for FSC and is general assistant to EDJ.
- 2. EDJ reported that there are currently three staff vacancies Grant Writer, Chipping Supervisor, and Accountant/Bookkeeper. She will begin interviewing next week.
- 3. EDJ reported that an agreement had been reached with OES to permit use of space at Nevada County Airport to secure FSC vehicles.
- 4. A grant has been written to PG&E for a chipping support.
- 5. The Ponderosa Project is wrapping up with a second round of treatment where needed.
- 6. FSC has received \$187,000 of Federal money for Covid Personal Protective Equipment. We will be applying for additional funds in March.
- 7. There is currently a gap in staff to manage the DSAV program. PW has volunteered to help until staff in identified.
- 8. EDJ is currently working with OES on developing the GreenWaste program for 2021.

9. DIRECTORS' COMMENTS

SE stated that a \$ 125,000 grant, managed by FSC to Support the Nevada County Biomass Task Force in development of a Biomass Facility is now closing, as Steve wanted to thank Billy Spearing for her help in making this happen.

10. ADJOURNMENT at 11:33 AM Moved by WK seconded by PW, accepted unanimously.

- 1. Call to Order: 9:38 AM
- 2. Roll call: was taken and is reflected above.
- **3. Public Comment:** No public in attendance.
- 4. Financial Committee Update: David Walker
 - a. No update on either the closing budget for December 2020 or January 2021 due to the current vacancy in the bookkeeper role. Identification of a replacement bookkeeper has been handicapped by the current Income Tax season, and not contractors have responded to the job postings.
- 5. Chairman Update: Donn Thane
 - a. A potential Agency Partner in the Insurance industry with significant experience in the Fire Industry has been identified. DT will follow up and begin a vetting process.
 - b. A clear process for the annual Performance Review and salary assessment of the Executive Director was discussed.
 - c. Red Zone Event discussions are continuing with John Paye.
- 6. Executive Director Operations Update: Jamie Jones
 - a. With the rapidly changing Covid environment, DSAV's with two advisors will now be allowed, provided that all masking and social distancing requirements are followed, and advisors <u>do not</u> travel in the same vehicle.
 - b. Low-Cost Defensible Space service is developing well. Income from this service has been \$136,000 since the beginning of December. Service will require some restriction once the FEMA project begins which will focus on AFN customers.
 - c. Pat Leach has been named the FSC contact for the Firewise Coalition.
 - d. EDJ proposed that FSC close its credit card account with Tri-Counties Bank due to specific limitations, and open a credit card account with Costco. WK moved that this question be forwarded to the full Board, RN seconded the motion, and the motions was unanimously approved.

DW moved adjournment, RN seconded, approve unanimously at 10:42 AM.
