Now back to business... If you were one of the folks wrestling with updating your Action Plan (especially if using a MAC), Thank You for your persistence! Seventy Firewise Communities did so, and another Twentyseven Risk Assessments were updated. This was the busiest year ever for our program. Plus, everyone is doing a better job at submitting their hours and dollars invested – which means more than \$10M was

accomplished and reported OVER 2022. Once the numbers are final, I'll share the fantastic efforts with you!

This Spring, I expect to pass along intel on changes to the method of gathering the annual data, and how the Risk Assessment will be handled into the future per NFPA. Please check the due dates on your portal's Dashboard for your Action Plan and Risk Assessment as I see Twenty-five Action Plans and Thirty-eight Risk Assessments will need to be updated before the deadline this year (historically the Friday before Thanksgiving). Let's not wait until the deadline please, these documents can be completed long before summer is over.

Conduct a Burn Workshop:

Join us for a 4-hour workshop discussing the steps to take in order to successfully conduct a Prescribed Burn.

Including: Visiting a prepped burn unit to discuss the steps taken before burning including setting up water, getting the help you need, gathering permits, setting up logistics for volunteers and notifying neighbors. As well as discussing what is necessary during a burn such as giving an adequate briefing, test burn, the different roles people play on a Prescribed Burn, smoke management, and the firing process. We will also discuss the steps taken after a Prescribed Burn is complete including mop-up, monitoring, evaluation, and maintenance.
