PRIVACY POLICY

Effective Date: December 1, 2021

JBI, Ltd. (a.k.a. Justice Benefits, Inc.) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with JBI, Ltd. of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point in time JBI, Ltd. decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether to permit the use of their information in this separate manner.

This Policy applies to JBI, Ltd., and it governs any and all data collection and usage by us. Through the use of www.jbi-ltd.com you are therefore consenting to the data collection procedures expressed in this Policy.

Please note that this Policy does not govern the collection and use of information by companies that JBI, Ltd. does not control, nor by individuals not employed or managed by us. Information We Collect

It is the intent of this site to use personal information only for the purpose for which it was requested, and any additional uses specifically provided for under this Policy.

Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To better understand your needs and provide you with the information and/or services you have requested;
- To fulfill our legitimate interest in improving our services and products;
- To send you emails containing information we believe you may desire when we have your consent to do so;
- To consider your application if you apply for employment with JBI, Ltd.;
- To contact you when we have your consent to do so; and
- To customize our website according to your online behavior and personal preferences.

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Use of Information Collected

JBI, Ltd. does not now, nor will it in the future, share, sell, rent or lease any of the personally identifiable information it collected to any third parties.

JBI, Ltd. may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the information and/or services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you.

Disclosure of Information

JBI, Ltd. may not use or disclose the information provided by you except under the following circumstances:

- as necessary to provide information and/or services you have requested;
- in other ways described in this Policy or to which you have otherwise consented;
- in the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service; and
- as necessary to maintain, safeguard and preserve all the rights and property of JBI, Ltd.

Non-Marketing Purposes

JBI, Ltd. greatly respects your privacy. We do maintain and reserve the right to contact you if needed for nonmarketing purposes (such as software bug alerts, security breaches, account issues, and/or changes in JBI, Ltd. products and services). In certain circumstances, we may use our website, newspapers, or other public means to post a notice.

Children under the age of 13

JBI, Ltd.'s website is not directed to, and does not knowingly collect personal identifiable information from, children under the age of thirteen (13). If it is determined that such information has been inadvertently collected on anyone under the age of thirteen (13), we shall immediately take the necessary steps to ensure that such information is deleted from our system's database.

Unsubscribe or Opt-Out

All users and visitors to our website that have provided personal contact information have the option to discontinue receiving communications from us. JBI, Ltd. will continue to adhere to this Policy with respect to any personal information previously collected.

Our website does not contain links to affiliate and other websites. JBI, Ltd. does not claim nor accept responsibility for any privacy policies, practices and/or procedures of other websites. Therefore, we encourage all users and visitors to be aware of such when they leave our website and to read the privacy statements of every website that collects personally identifiable information. This Privacy Policy applies only and solely to the information collected by our website.

Notice to European Union Users

JBI, Ltd. only conducts business in the United States. If you provide information to us, the information will be transferred out of the European Union (EU) and sent to the United States. (The adequacy decision on the EU-US Privacy became operational on August 1, 2016. This framework protects the fundamental rights of anyone in the EU whose personal data is transferred to the United States for commercial purposes. It allows the free transfer of data to companies that are certified in the U.S. under the Privacy Shield.) By providing personal information to us, you are consenting to its storage and use as described in this Policy.

Your Rights as a Data Subject

Under the regulations of the General Data Protection Regulation ("GDPR") of the EU you have certain rights as a Data Subject. These rights are as follows:

- The right to restrict processing: this means you can change your communication preferences or opt-out of certain communications. You can do this by sending an email to info@jbi-ltd.com.

We also have protocols in place in the unlikely event that we suffer a data breach and we will contact you if your personal information is ever at risk. Wherever we collect such information, that information is encrypted and transmitted to us in a secure way. While we use encryption to protect information transmitted online, we also protect your information offline. Only employee(s) who need the information to perform a specific job are granted access to personally identifiable information. The computers and servers in which we store personally identifiable information are kept in a secure environment. This is all done to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

The company also uses Secure Socket Layer (SSL) for authentication and private communications to build user's trust and confidence in the internet and website use by providing simple and secure access and communication of personal information.
