1. Welcome and Moment of Silence

Warren Poole, Committee Chair, called the meeting to order at 5:06 PM and welcomed all in attendance. A moment of silence was observed for all those living with, those who have passed, and those affected by HIV/AIDS.

2. Public Testimony

There was no public testimony.

3. Approval of the Meeting Summary from April 28, 2021

The April 28th meeting summary was sent electronically for review prior to the meeting. Poole asked for a motion to approve the meeting summary. One consumer motioned and another seconded. There were no abstentions or oppositions.

4. Ryan White Part A Updates

Recommend topics for future CIA Presentations

The committee mentioned at a previous meeting that they would like to have presentations on how to use Zoom and other technology. Other recommended topics were:

- Members also requested a presentation on COVID-19 changes as the State is opening. There
 should also be a discussion about hesitancy to get the COVID-19 Vaccine.
- Attendees want to know what should or should not be done since the mask requirement is no longer in place.
- A provider in attendance recommends that people should still wear a mask on closed spaces such as public transportation and health care facilities. In addition, for those who are already

vaccinated can have their mask available and wear it as needed and/or wanted. And those who do not have their COVID-19 vaccine, they should still always wear a mask.

6. New Business

- Core and Support Services; What is a Core Service Waiver?
 - The Newark EMA funds Medical (Core) and Non-Medical Services (Support Services). Core services are services related to direct medical care. Support services fund other services such as Emergency Financial Assistance, home-delivered meals, and others.
 - The Health Resource and Services Administration (HRSA) requires the Newark EMA to distribute 75% of Ryan White Part A funds to core services and 25% for support services.
 However, a Core Service Waiver allows the EMA to take away from the 75% for core services and add it to the 25% to increase support services.
 - Last year, there was a greater need for support services such as utility assistance, housing, among others due to the COVID-19 pandemic. Therefore, the recipient, in consultation with the community, applied for and received approval of a Core Service Waiver to increase funds for support services.
 - For the FY2022 application, the Recipient wants to hear from the community about the need for a Core Service Waiver application. Attendees shared the following comments:
 - More funding should be available for <u>utilities</u>, <u>housing</u>, <u>and food</u> to prepare for the future since "we never know what type of crisis is about to hit us".
 - "There seems to be a critical need for housing, but I agree with the other speakers, when they talked about utility and housing homelessness prevention... There are some models out there and I know United Community Corporation (UCC) is promoting one where they have smaller housing components for people who may not have a home.... what I would categorize as homelessness prevention having enough money to support your utilities and keeping your current place as this moratorium end."
 - In Morris, Sussex, and Warren County, "people do not have <u>transportation services</u> and funds for transportation are very limited", particularly for Medicaid and uninsured patients. The bus service in Warren County is at least one mile away from the client's residency, a distance that clients must walk. Some patients are referred to other agencies who provide transportation services but not everyone qualifies for this service. Zufall prioritizes patients to receive transportation, but funding is limited.

Food

- People are "going to need more funding for <u>food</u>."
- This morning, News 12 announced that the Food Stamp program was giving more funds during the pandemic. As the end of July, these funds will be returned to its original limits. Therefore, "more funds for **food** are going to be needed".

Other services

 It would be helpful to have funds for a father program that offers job training opportunities to learn skills leading to employment such as the FELLAS Program. This

- program helps fathers be better fathers for their family. The FELLAS program can collaborate since fathers enrolled in the program need employment opportunities. Attendees agreed that job trainings leading to employment opportunities can be helpful and crucial as a long-term solution.
- Although the Ryan White Part A funds specific service categories, the Ending the Epidemic funds for jurisdictions might be able to fund job training. EHE provides funding for services not included in Ryan White Part A such as the housing program which will have a job training component. This approach was developed in response to the Needs assessment which showed that individuals who are not stably housed might not reach viral load suppression.
- The FY 2021 allocation was set at around 70% for core services and 30% for support services which was outside of the 75/25 already.
- After this discussion, attendees were asked to submit their vote in favor of submitting a Core Service Waiver application for FY 2022.
 - The 16 attendees present agreed to put more funds into support services.

Resource Allocation and Reallocations

- HRSA provides funds to the Newark EMA Ryan White Part A services to be distributed according to the number of people living with HIV throughout the five EMA counties, and the services needed in the area. The unspent money gets sent back to HRSA, but it can also be reallocated to other services that need more funds including support services. A member reminded attendees that "if more money is put in support services, then less money will be available for core medical services."
- The Comprehensive Planning Committee and Planning Council go through a process to take into consideration to increase funds on those categories based on different data including the recommendation from the CIA, data utilization report, the needs assessment, and other data.
- A member also suggested that people can also lobby outside of the congress to increase program funds, even outside of Ryan White. Some organizations that advocate on the state and federal level were mentioned such as AIDS Watch, and the National Health Care for the Homeless Council.
- Support Staff noted that although the Planning Council does not lobby, community members can participate or become involved with advocacy in their own time as individuals.
- Funding priorities: which services will matter the most in 2022?
 - Attendees briefly reviewed the Newark EMA Core and Support Service Categories:
 - Core Services Outpatient/Ambulatory Health Services, Early Intervention Services, Oral Health Services, Mental Health, Medical Nutrition Services, Medical Case Management, Substance Use Outpatient Care, Health Insurance Premium and Cost Sharing Assistance.
 - Support Services Non-Medical Case Management, Emergency Financial Assistance, Food Bank/ Home Delivered Meals, Housing, Medical Transportation, Substance Use Services (Residential), Psychosocial Support Services, Other Professional Services.
 - A discussion followed where meeting attendees shared service areas that they felt should be prioritized in 2022:

- Housing, Medical Transportation, and Food issues "are the main reason people fall out
 of care since finding a place to sleep or food are their main priority, not going to medical
 appointments or taking medicine."
- The long-term effects of COVID-19 will also create a higher demand for <u>psychosocial</u> <u>support</u> services because of the long-term effects of social isolation, the COVID-19 vaccine, and the COVID-19 infections such neuropsychological disorders.
- Oral Health Care was not available for a couple of months because of COVID-19. There is now a high demand for oral health appointments but there are not enough appointments available for these services.
- Medical Case Management because they keep the patient in care and help link patients to other services.
- Emergency Financial Assistance since it provides utility assistance, back rent assistance and other emergency assistance such as a refrigerator to a consumer who needed one.
- After this discussion, meeting attendees used a Priority Setting worksheet outlining funding priorities as follows:
