Review/ Update Foodbank / Home Delivered Meals Service Standard

- The committee reviewed the Foodbank/Home Delivered Meals Service Standard. No changes were made to the service standard.
- Scangarello made a motion to accept the service standard. Rochal seconded the motion. All were in favor, there were no abstentions or objections. The service standard was passed and will be submitted to the PC for a 30-day review.

• Review/Update of the Other Professional Service Standards

- The review of the Other Professional Service Standards was tabled until next month to allow for an expert review of the service standard.
- Support Staff will be inviting representatives from the Community Health Law project and Legal Services of NJ to lend their expertise in the review the service standard.

8. Administrative Issues— PC (Planning Council) Support Staff

- Morales requested that PC support send the COC Work Calendar to ensure that the committee continues to remain on tasks as the year comes to an end. The work calendar should be reviewed monthly, moving forward.
- Dr. Figueroa raised a concern regarding the COC meeting time and how it conflicts with her work schedule. She requests that the committee meet earlier to accommodate for the work responsibilities that committee members may face while in the office.
 - Morales requested that PC Support send out a survey to the entire committee
 to vote on the adjustment of hours that may work best for them. PC Support
 staff agreed to send the survey by the end of the meeting.
