

Politifact never just makes a simple judgment. It always outlines in a step-by-step fashion the reasoning behind their judgments and cites each source. This allows the reader to check out the claims and decide for themselves.

In my Misinformation workshop [and I have several coming up in the new year!] I have begun to include **some** economic data which can be very misleading. For example, the "official" unemployment rate - technically, the U-3 - does not include those who are working part-time but want to work full-time and those who have dropped out of the workforce.

The latter is particular salient as over a million women [primarily] have dropped out to take care of kids because child care options have diminished so much with COVID. There is a rate that is a better reflection of unemployment and includes these considerations - the U-6; which is often 2-3x the U-3 rate.

"The U-6 rate is often considered the true rate of employment, however, as it accounts for those who are unemployed, underemployed, and discouraged workers."

**The Woman Who Took On The Tycoon.** I updated my Resource List for the Activism workshop. I begin with some historical perspective, looking back at the Gilded Age [which we are, unfortunately, living through again, in many ways] and how things improved at the beginning of the 20th Century.

One of the instigators for improvements was the "muckraking" reporter, Ida Tarbell. She single-handedly exposed the corrupt and immoral practices of one of the biggest monopolies of the time, Standard Oil. It went a long way to getting our first antitrust legislation.
