The outcome of these cases will impact the maps used for 2024. Two very significant cases are in the Supreme Court; we'll know their outcome next June.

It is ridiculously easy to submit written testimony [aka your opinion] or to sign up for in-person or virtual testimony now. [We have one of the best systems in the country for doing so!]. Just go to the link and look around: information, sign up, follow the bill via email alerts, etc.
