2. Matters arising from previous AGM:

2.1. Coppice Avenue Library now has its own volunteer gardening group so no further action from TW.

3. Matters arising from reports:

3.1 Donation to Sinderland Green church for car parking increased to £75 (**DR**).

4. Meeting agreed that the Chairperson Jennifer W, Treasurer David R & Secretary Geoff D would continue in their roles.

5. Birch Moss covert - futures.

5.1 For investigation of the water vole ditch water quality perhaps need a hydrologist rather than an ecologist. Penny Anderson were involved in some of the original ecology work (**GD**). Maybe able to call on Mersey Rivers Trust expertise.

5.2 The improvements around the ditch would demonstrate general biodiversity improvement rather than water vole improvement specifically.

5.3 Heather area can be expanded further (**DR**).

5.4 Fruiting thorns can be planted to west of heather area after birch clearance (**DR**).

5.5 Freedom of Information (FOI) requests to Trafford & GMEU regarding both nature reserve conditions (Birch Moss covert and ManU nature reserve). (**MP** to assist **JW.**) The conditions may be time limited and now lapsed.

5.6 Further potential planning threats from increased light pollution and also new ManU car park to west of Birch Road.

6. Willow Tit project – futures

6.1 The closed UU operational land and the open UU land management areas are not currently available for willow tit habitats.

6.2 Continue with proposed habitats on UU operational land to north side of UU works and on NT/Trafford land near Sinderland Brook. (**JW**)

7. Volunteer recruitment

7.1 Looking to increase numbers by about 50% to cover normal turnover of people.
