#### WATER

Nathan presented to the Board that Countyline Coop is no longer interested in a water line at this time. The village, therefore, will not be applying for the EPA or CSX permit needed to get the project going.

We will still get the easement from the American Legion. They were giving us the easement if they could tile their ball diamond outfield and drain into the village storm sewer.

There has been no response from RCAP in regards to the water tower. Nathan will put in a call to Roberta from RCAP concerning this. He will also consult with Feller & Finch and Civil Engineering about how much it would cost to do a feasibility study for the tower project.

HD Supply (the lowest quote for \$4,892.58) will be providing two new hydrants (N. River and Main/Maple), a new valve on the middle of the sidewalk on Bridge St. and the removal of two valves on Bierley.

There was a water break on Front St. on Friday, April 21<sup>st</sup>. There was a sewer break on East Front St. on April 29<sup>th</sup>.

Nathan will be researching generators for the next meeting and he is in the process of getting the pool ready for the summer season.

## **SEWER**

Landry will get prices on a sludge valve that needs to be replaced. Landry and John also worked on breaker panel at the sewer plant because all three pumps weren't working on April 29<sup>th</sup>. A ground shorted out on one of the pumps.

Also on April 29<sup>th</sup> there was a forced main sewer break on 105. The pipe developed a hole. They put a 2 foot clamp on the line to seal the hole. Landry will eventually replace the pipe.

Some of the catch basins were not accepting water. The 105 repaving project caused asphalt to block the catch basins from accepting the water. It took some effort but they have been opened up now. Adkins is coming to do the catch basins this week.

Alton Beeker's sidewalk has been formed.

## **ELECTRIC**

Terex will be doing the annual line truck and bucket truck inspection for \$2,063.67.

Scott Heacock will be doing the drawings for the N. Park building remodel which included electric. Wood County Building Inspection has to sign off on the drawings.

John is still gathering information on new lights for Pemberville's ball diamond. He also mentioned that Luckey's ball diamonds have a demand meter with a x40 multiplier. More information is being gathered about this as well.
