VILLAGE OF PEMBERVILLE COUNCIL MEETING February 21, 2023

Mayor Bailey opened the February 21, 2023, Council meeting at 7:00 p.m. with a prayer and the pledge of allegiance.

Mayor deviated from the agenda to allow John Courtney, the Village's AMP consultant, to discuss electrical rates with Council and members of BPA. Courtney explained the last time rates were reviewed and raised was in 2014.

Roll Call: Present at the scheduled meeting of Council were Angel, Kirkbride, Mazur, Rollins and Titkemeier. Robert A. Kuhlman, Chief Vaughn, Cindy Winfrey, Gene Steele, Eric Campbell, John Courtney, and the Fiscal Officer.

Minutes: Rollins moved, and Titkemeier seconded to approve the minutes from February 7, 2023. Motion passed 4/5 vote. Rollins-yes; Titkemeier-yes; Angel-abstain; Kirkbride-yes; Mazur-yes.

Treasurer's Report: Angel moved, and Mazur seconded the bills in the amount of \$3,338.05. Motion passed unanimously.

ORDINANCE 1633: 2023 ORDINANCE ESTABLISHING MUNICIPAL EMPLOYMENT POSITIONS, DEFINING DUTIES AND PROVIDING FOR THE COMPENSATION THEREOF. 2nd READING

Angel wanted to clarify that all readings are open for discussion by Council at any time they are read and strongly encourages it. Angel stated he received an email with questions from Councilwoman Rahe regarding the wage Ordinance. Angel stated the questions posed were discussed during the Personnel and Finance committee with recommendations. Angel stated a question posed was insurance for Medicare aged employees. Angel stated the committee recommended amending the language in Section 30 to reserve the right to pick up the 15% cost to the employee if it is in the best interest of the Village. Angel stated another question was regarding wages and a contract for Brian Heestand and that will be a recommendation coming from BPA. Angel asked if there were any other questions from Council. Mazur stated a question Rahe posed had been answered by Angel when she contacted him. Angel stated that since there is no other question or further discussion, he would like to suspend the rules and pass the Ordinance tonight.

Angel moved and Mazur seconded to suspend the rules. Motion passed unanimously.

Angel moved and Mazur seconded to approve Ordinance 1633. Motion passed unanimously.

Chief stated the ECIC donated \$1510 towards the computer system needed for the new cruiser. Chief stated he will be attending the ECIC meeting on Friday to thank them for their donation.

Mayor:

Mayor stated that Chief Vaughn has been with the Village for six months. Mayor stated per Ohio Revised Code would like to officially appoint John R. Vaughn as Pemberville Police Chief. Kirkbride moved and Angel seconded to officially appoint John R. Vaughn as Pemberville Police Chief. Motion passed unanimously.

Mayor stated she had finished cleaning out the planters downtown.

Mayor stated she is working on getting a dumpster for the Walnut St. garage.

Mayor stated the Thirsty Thistle opened and will serve cold sandwiches, crepes, and coffee. Hours are Thursday and Friday 4:00pm to 8:00pm and Saturday, 10:00am to 4:00pm.

Mayor stated the East Front St. project is moving forward.

Mayor stated the construction of the Splashpad will be resuming soon.

Mayor stated the ECIC is looking for a someone in the Eastwood Community that would like to serve as the president. Mayor stated if this position cannot be filled, they will likely close down the organization.

Mazur stated the SSLB met on February 16th. Mazur stated the committee did receive one quote for a new 1tom in the amount of \$67,245. Mazur stated the additional equipment needed for the truck could cost just as much as the truck.

Mazur stated a letter has been sent to the Oberhouse family regarding Oberhouse Park. Titkemeier asked what the letter stated. Mayor stated the letter is asking the family to take the property back or to remove the deed restrictions.

Mazur stated they are looking at new doors with timers for the Public Restroom at the park.

Mazur stated the repair on the leaf machine is roughly \$2000 and need to start looking at replacing the leaf machine.

Mazur stated the committee has sent a letter to Home Depot to request donations. Mazur stated a shed is needed at the pool and new spotlights. Mayor stated it is her experience that Home Depot donate materials and labor. Mazur stated the committee has received one quote for painting the Council Chambers And is hoping to receive a couple others.

Mazur stated the next Street meeting is March 14th at 9:00am.
