

**VILLAGE OF PEMBERVILLE
COUNCIL MEETING
April 4, 2023**

Mayor Bailey opened the April 4, 2023, Council meeting at 7:00 p.m. with a prayer and the pledge of allegiance.

Roll Call: Present at the scheduled meeting of Council were Rahe, Kirkbride, Mazur, Rollins and Titkemeier. Robert A. Kuhlman, Chief Vaughn, Eric Campbell, and the Deputy Fiscal Officer.

Minutes: Titkemeier moved, and Kirkbride seconded to approve the minutes from March 21, 2023. Motion passed unanimously.

Tree Committee:

Park and Recreation: Mazur asked for clarification on the pool managers position so a help wanted ad can be placed. Discussion ensued.

Mazur stated the standard timeclocks will be used at the pool this year. Kirkbride moved and Rollins seconded to purchase the timeclock and cards for the pool. Motion passed unanimously.

Mazur stated she has a quote to replace the pool ladder anchors. Mazur stated the quote does include shallow concrete patching. Mazur moved and Kirkbride seconded to replace the pool ladder anchors plus concrete patching for \$9090. Motion passed unanimously.

The first pool sign-up is scheduled for April 22nd and the second sign-up will be May 13th.
