I would especially like to thank Ron Clarke who served on the Community Council for many years and for the last 3 years as Vice Chairperson. I also want to thank Cllr James Gill for standing in as acting Vice Chairperson for the past 3 months. Councillor vacancies were advertised and we welcomed Juna Sathian and Lee Stott who were co-opted onto the Council in January 2021 - welcome to the team.

#### **Covid 19 Pandemic**

The impact of Covid 19 has had such a devasting impact on our lives and the wider community and country. The pandemic and lockdowns have brought us all unknow challenges and sadness. With now just under 3.5 million deaths world-wide we all know the pandemic is not over yet. As we see the rollout of the vaccination programme and now the easing of the national restriction. We are starting to see some progress and are now hopefully heading in the right direction and back to life as we knew it before.

One positive out of all this sadness that I am sure we all can agree is that our sense of community is stronger. It's been great to see people coming forward to help others and offer support to those in need.

Many of us have not been able to have a physical presence in the community due to the pandemic restrictions and local/national lockdowns. However, the Community Council has

been here for local resident in a number of other ways and we have led the way in supporting the community, we have:

I would like to take this opportunity to thank all Key Workers, NHS staff and everyone in the community who have volunteered to support us throughout the pandemic. I do hope that our NHS staff and all key workers get the recognise and pay increase I am sure you will agree they deserve.

#### Our Commitment to Tackle Anti-Social behaviour

Over the past twelve months the Council has seen a massive increase of anti-social behaviour across the whole area of Blakelaw and North Fenham. We receive a number of complaints from residents on a weekly basis and in the six-week period over the months of January and February we received a staggering 73 complaints most of which were regarding anti-social behaviour. We have worked closely with the local Police team and more recently attended a local SAPS meeting to tackle this ongoing issue. We will continue to encourage residents to report incidents of anti-social behaviour. We do this by sharing articles in our newsletter and on our social media sites.

The Community Council have followed up on: -

- Bus Service disruption following youths throwing bricks at bus windows and what will be put in place to prevent this again
- Issues with Blakelaw Park including fires, litter, drug related incidents
- Off road motorbike driving at speed on the footpaths around the estate.
- Fly-tipping and drug use/dealing in north Fenham
- Drug dealing in Blakelaw
- Anti-social behaviour at the shopping centre and around the tower blocks

We are in regular communication with Northumbria Police and will continue to do all that we can to make Blakelaw and North Fenham a nicer and safer place to live.

#### **Sub Committees**

**Community Engagement and Communication**: the group heads up all of the Council's communications including the Council's website, social media platforms, newsletters, publications and events. The committee has been responsible for keeping residents regularly updated regarding the pandemic via specific newsletter, leaflets, key worker thank you cards and posters for local business.

**Environment Group:** this year the group has been limited in what activity we could be involved with due to the restriction in place because of the pandemic. Councillors have been part of the consultation with the City Council regarding the new sports and leisure hub that will be built on Blakelaw Park. As of the 19<sup>th</sup> May we are still waiting for a detailed update from the City Council despite requesting for an update on a number of occasions. We have also engaged and promoted the importance of the Low Traffic Neighbourhood project.

**Employment Group:** The group has met via zoom during the pandemic. Weekly one to one digital meetings/telephone call with the chair and the clerk have been in place throughout the pandemic. The Chair proposes that the title of the 'employment committee' is renamed to 'staffing committee'

### **Funding Local Community Activities:**

Throughout the Pandemic the Community Council have funded food banks, made a large food donation to a Christmas hamper appeal and also support detached youth work provided by Projects4change who have worked tirelessly around the pandemic to deliver support to our hard-to-reach youths. The Community Council also supported the work of Blakelaw Club Juniors Football Club with FA and pitch fees.

#### **Planning Applications**

Throughout the year, the Council receives planning applications for consultation. The Community Council is committed to avoiding inappropriate developments and is asked by the City Council Planning Committee to express its views on each application and also any comments passed to it by the residents. This we do in an advisory capacity only, as the final decision in each case rests with the relevant Planning Authority.

#### **Finance Report**
