**ORDINANCE DISCONNECTING TERRITORY
FROM THE VILLAGE OF PALESTINE, ILLINOIS**

WHEREAS, the provisions of the Illinois Municipal Code, being 65ILCS5, Article 7, Division 3 provides for the Disconnection of territory from a municipality; and

WHEREAS, the aforementioned statute provides that upon written petition signed by the owners of record representing a majority of the area of land in such territory to be disconnected, having been filed with the Village Clerk, and after 30 days from the filing of said Petition, the Board of Trustees, by ordinance, adopted by a majority of its members, may disconnect such territory; and

WHEREAS, the aforementioned Petition for Disconnection has been on file with the Village Clerk for more than 30 days; and

WHEREAS, the provisions of the aforementioned Statute have been fully complied with.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Illinois, an Illinois Corporation, that the following described real estate, be, and it is hereby disconnected from the Village of Palestine, Illinois, to-wit:

All of the following described real estate lying north of the center line of the waterway which transverses the following described real estate, to-wit:

Commencing at the Southwest Corner of the Northwest Quarter of Section Two (2), Township Six (6) North, Range Eleven (11) West running thence 10 chains East thence North 40 rods, thence in a Northerly direction 81 rods and 7 links to a point 12 rods South of the Southwest Corner of LaMotte Town House, Lot, said point being also the Southwest Corner of the Lot formerly owned by Mary Ann Curry, said Lot being situated in the Village of Palestine, Illinois, thence along the West line of said Curry Lot and said Town House Lot in a Northerly direction to the center of the Vincennes Road, thence with the center line of said Road 18 feet, more or less, till intersecting the South line of the A.N. Winters Lots, thence West along said South line of A.N. Winters Lots 20 rods, more or less, to the Southwest Corner of the same, thence continuing West to the East line of the Lawrenceville Road, thence in a Southerly direction with said Road to a point 12 rods West of place of beginning, thence 12 rods East to the place of beginning, supposed to contain 26 acres, except the following described real estate, to-wit: Commencing at a point where the South line of the Vincennes Road intersects the Quarter section line in Section 2, Township 6 North, Range 11 West, in the Village of Palestine, Crawford County, Illinois, and running South 142 feet along the West line of parcel of land owned by the Town of LaMotte, in said County, known as the Town House Lot and running thence West 75 feet, thence North to the South line of the Vincennes Road thence in a Southeasterly direction with the South line of said Vincennes Road, following the meanderings thereof to the place of beginning.

BE IT FURTHER ORDAINED that the Village Clerk shall record a duly certified copy of this Ordinance in the Office of the Crawford County Recorder of Deeds.

THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL AND PUBLICATION IN PAMPHLET FORM AS PROVIDED BY LAW.
