AN ORDINANCE TO AMEND CHAPTER 41, TRAFFIC,
TO ADD SECTION 41.25 – ALTERNATIVE ORDINANCE VIOLATIONS
OF THE PALESTINE VILLAGE CODE

BE IT ORDAINED by the Board of Trustees of the Village of Palestine, Crawford County, Illinois, that CHAPTER 41, TRAFFIC, is hereby amended to add SECTION 41.25 UNLAWFUL USE OF AN ELECTRONIC COMMUNICATION DEVICE, of the PALESTINE VILLAGE CODE be, and the same is hereby amended to be in its entirety, as follows:

41.25

UNLAWFUL USE OF AN ELECTRONIC COMMUNICATION DEVICE: "Electronic Communications Device" means an electronic device including, but not limited, to: wireless telephone, hand-held personal digital assistant or a portable or mobile computer. A person operating a motor vehicle on any roadway shall not "talk or text" on any electronic communication device in which the device is being held in the drivers hand unless for the purpose of dialing 911 or other emergency number to report an emergency incident.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
