AGREEMENT FOR POLICE RADIO AND EMERGENCY PHONE COMMUNICATIONS

This Agreement is made this date by and between the Crawford County, Illinois, a body politic, hereinafter referred to as CRAWFORD COUNTY, and the VILLAGE OF PALESTINE, ILLINOIS, an Illinois Municipal Corporation, hereinafter referred to as VILLAGE.

WITNESSETH:

WHEREAS, Section 10 of Article VII of the Constitution of the State of Illinois authorizes units of local government to cooperate together to carry out the functions of the respective units of the local government for the common good of the citizens thereof, and in this regard to enter into cooperative intergovernmental agreements; and

WHEREAS, CRAWFORD COUNTY and VILLAGE are units of local government; and

WHEREAS, CRAWFORD COUNTY and VILLAGE desire to enter into a cooperative intergovernmental agreement for the combined police radio receiving monitoring and dispatching services.

NOW, THEREFORE, in consideration of the aforesaid recitals and of the following covenants and agreements, CRAWFORD COUNTY and VILLAGE agree as follows:

1. CRAWFORD COUNTY agrees to maintain the equipment utilized and the base radio communication system and a computer utilized for LEADS.
2. The radio communication system shall be located at such place as the Sheriff of CRAWFORD COUNTY shall determine, provided that the location thereof does not reduce the services to be provided hereunder or compromise the confidentiality thereof.
3. Except as provided herein, VILLAGE shall retain its radio equipment as its own separate property.
4. CRAWFORD COUNTY through the Sheriff, agrees to employ, as employees of Crawford County, Illinois, full and part-time dispatchers, trained and certified to operate the communication system. The Sheriff of CRAWFORD COUNTY will bear full expense of training and certification of dispatchers. Dispatching employees shall report and be answerable to the County Sheriff. Written complaints against dispatchers

forwarded to the Sheriff of CRAWFORD COUNTY by the Chief of Police of VILLAGE will receive review and be answered by written reply within ten (10) working days.

5. VILLAGE OF PALESTINE, in consideration of the services to be provided herein, agrees to pay CRAWFORD COUNTY the sum of \$2,835.00 annually, payable monthly which will apply to the payroll expense incurred in operating the radio communication system.

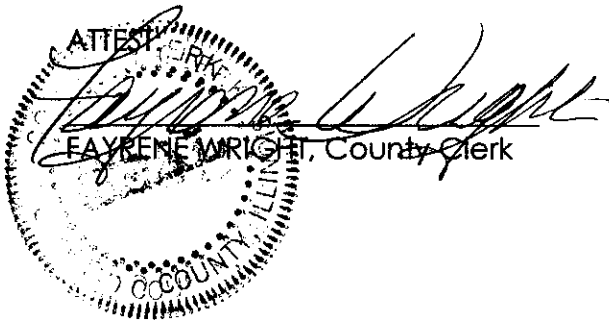
6. The Agreement shall extend for a period of one (1) year from May 1, 2021 through April 30, 2022, and shall automatically renew for successive one (1) year periods until April 30, 2025, unless either party notifies the other, in writing, at least thirty (30) days prior to the annual termination date that said Agreement shall not be renewed, and will be terminated.

IN WITNESS WHEREOF, the Chairman of the Crawford County Board on behalf of CRAWFORD COUNTY and the Mayor of the VILLAGE OF PALESTINE, on behalf of VILLAGE, have caused this Agreement to be executed and attested by the Clerk of each party.
