1) Welcome and Announcements – K. Rees

- a) Discussion of article in the Union by Susan Rogers. Discussion of Sacramento Bee PGE article on fire safety issues. These are the partners needed for the cause; we need more people and sources talking fire safety.
- b) Staying on target with our mission: The Coalition promotes fire safety through advocacy, education, and community involvement with other stakeholders interested in working toward stronger fire safety practices. We need to get all parties on our side and to see the wisdom of being pro active about fire safe activity. Partnering is helpful in solving problems. We can be the political group to help drive towards the cause.
- c) Staying on target with our Goal: **To draw all key organizations, public and private, into being invested in wildfire prevention in the recognition that fire is everyone's fight.** Kent reminded us all of the mission and goal, not to lose our focus.
- 2) Communications Plan S. Rogers Tom Peck and Marty Main met with Susan and talked about using Marty's newsletter as a base that coalitions could add to. This led to the question of how FireWise Groups communicate. Susan passed out survey, "How do you communicate with your Firewise Community" There will be an electronic survey coming for those not in attendance.
- 3) Hazardous Vegetation Appeal- No report, Frances not present.
- 4) Microgrids and Underground Power Lines J. Mason Microgrid is a localized power source. They run on their own using solar, wind, fuel cell etc with battery. Still connected to PGE, in the event of a power outage, your community would switch to the 'microgrid'. This led to discussion broader discussion about broadcasting as an effective way to communicate. The old fashioned transistor radio can be very effective as long as KNCO/KVMR or other radio stations are broadcasting.
- 5) F. Subcommittee Progress Reports
 - a) Real Estate Working on Defensible Space disclosure form with the realtors. The FSC will create a designation for Firewise Certified Realtors after they get the training. There was some logistical issues with the training, Joanne is still working on getting all speakers lined up for the training of realtors.
 - b) Enforcement One of the top issues was the lack of enforcement of 'hazardous vegetation'. Plan was to talk with supervisors and OES. The team met with Heidi Hall, gave her brief overview of the coalition. County inspections are sometimes poorly timed. Need to be earlier so that people can actually do the work. Inspections should be more thorough with follow-up. Enforcement team will meet with Matt Furtado at the Rood Center. Comment: It is a difficult task to inspect all homes continually and there are not enough inspectors for the amount of homes. Comment: Firewise Communities need to be the eyes and ears. Comment: Frustration on lack of aggressiveness by Cal Fire on inspections.

 - d) John Russel who works at Washington Camp, can organize crews that can clear large plots. He needs maps with detailed layout. Prefers large plots, obviously needs permission from landowner etc.
