Course Description:

Start at paint mark on road on B1111 approx. 0.2 miles north of A11,
 Proceed south under A11 to turn left onto sliproad A11 signed 'Thetford' (0.25 miles)
 Proceed on A11 via Thetford rab to Croxton interjunction, take sliproad and
 Proceed to T junction (CAUTION), turn right and
 Proceed under A11 to turn left onto sliproad signed 'Norwich',
 Proceed to join A11 (7.90 miles).
 Proceed on A11 via Thetford rab to take sliproad to B1111 (14.54 miles),
 Proceed to T junction with B1111 (CAUTION) turn left to
Finish at paint mark approx. 50 yards past Start just prior to Larling sign.
