# When we say "Housing For All" we mean...

Housing for our retirees whose pensions aren't covering costs.



Housing with 3 or 4 bedrooms for our Lynn families to live in.



Housing for students and young adults who want to remain in Lynn and contribute to our city.



Housing for the long-time residents whose rent has significantly increased because of management changes.



Housing affordability for homeowners paying more than a third of their income on their mortgage.



Housing for people with different abilities and needs.

# MYTHS

"Lynn already has too much affordable housing"

"Developers won't want to create affordable housing"

"Limited affordable housing only affects those with lower incomes"

# REALITY

**57% of all renters and 78% of low-income renters are struggling to pay rent.**

**Development incentives allow for developers to financially benefit from creating affordable housing in Lynn.**

**\*ex: Gateway North development**

**Housing insecurity impacts the vast majority of Lynners - both homeowners and renters.**

**'Expendable income' is code for 'not working class'.**

**Investment can help or hurt us, make us better or drive out the Lynners who live here today.**

**In 2010, the Downtown area reported having close to 30,000 residents.**

**According to the State Data, Lynn has 12.4% affordable housing and 01901 was rated the 5th least affordable zip code in the state. Lynn has additional subsidized housing that does not meet federal affordable standards.**

# Why Now?

*For those seeking to leave low and middle income Lynn residents out of development, it is never a good time to talk about affordable housing.*

There are no laws in Lynn that require developers to include a certain percentage of affordable housing - unlike the neighboring towns of Peabody, Beverly and Swampscott.

Lynn is facing massive developments that will reshape Lynn for the next 100 years- the time is now.

"Housing is an important determinant of health: affordability, safety, quality and neighborhoods all effect how and whether residents get sick, and how and whether they heal." (1199 SEIU)

In a forthcoming study by Conservation Law Foundation, 54% of respondents living in Lynn for 20+ years reported thinking they'll have to leave in the next 5 years due to housing costs.

# GET EDUCATED

- Circulate this packet and start conversations
- Learn about candidates' housing platforms and support those with comprehensive plans for housing for all Lynns families
- Attend public planning events

## GET ORGANIZED

-Support non-profits, unions, coalitions and organizations that fight for housing justice in Lynn

-Get to know your neighbors: in unity there is strength

## GET ACTIVE

-Pressure Lynn City Government to create a fully staffed planning department and make information public on developers submitting proposals for Lynn

-Talk to your city councillors about Lynn's housing crisis (Ask them about plans and deals for development)

# Some laws and policies you need to know

## Chapter 40B

The state's Affordable Housing Law. This allows developers to build affordable housing with a streamlined permit process and flexible zoning rules, for developments with at least 20-25% of their units for low and moderate income families. (*Mass.gov*)

## Chapter 91:

The oldest program of its kind in the nation, Chapter 91 guarantees public access to waterfronts, and protects coastal and inland waterways. (*Mass.gov*)

## Section 8

A federal assistance program to help low-income residents pay their rent. In Massachusetts, it is against the law to refuse rent to someone just because they have a section 8 voucher. (*HUD*)

## Housing Development Incentive Program

HDIP provides Gateway Cities with a tool to develop market rate housing while increasing residential growth, expanding diversity of housing stock, supporting economic development, and promoting neighborhood stabilization in designated areas. (*Mass.gov*)


## Rent Control

Capping rents at a certain level and limiting the percentage rent can go up every year. This practice is currently illegal in Massachusetts. (*Mass.gov*)

# Let's Clarify Some Things:

## **Affordable Housing**

Housing that costs no more than 30% of household income leaving enough income to cover other basic needs.

## **Zoning**

Regulations that control different uses of land, including development.

## **Housing Code**

The minimum standards for property maintenance, sanitation, etc that must be met by all housing.

## **Gentrification**

The rapid shifting of working-class neighborhoods to appeal to new upper-income residents.

## **Displacement**

When current residents of a neighborhood are priced out and can no longer afford to live in their own community. Typically replacing marginalized people and people of color.

## **Area Median Income (AMI)**

The household income level where half of households in a given area earn more and half earn less. Lynn's estimated AMI in 2017 was \$53,513 and the city's federal housing district AMI is \$82,099.

## **Market Rate Housing**

Housing rented or sold at maximum profit for highest possible rents.
