- Sensure Your Credit is NOT frozen, to unfreeze, please call 1-888-909-8872
- Fill Out Application(s)
- How to Fill Out: (YOU MUST DOWNLOAD IN ORDER TO FILL OUT FORMS)
  - Option 1: From Your Phone/Tablet Download Forms > Fill > Sign > Save > Email
    Smartphone Users: Download Free Adobe App > Fill > Sign > Save > Send
  - Option 2: From Your Computer Download Forms > Fill > Sign > Print > Scan > Email
    - In order to fill-in forms electronically, you must have Adobe Reader on your computer
    - No Scanner? Take a picture on your phone > Download free iScanner App > Upload Photo > Save > Email
- Be sure to select the correct report(s). Your landlord / manager / real estate agent should have provided you with what report to choose - *typically Comprehensive Individual or Married reports are chosen.*
- Ensure complete application This includes signing your application!
- Submit the Following Forms:
  - Application(s)
  - Credit Card Authorization Form
  - Copy of Driver's License
  - Copy of Pay Stub
