



LANDLORD INSTRUCTIONS

- ❖ Charge the prospective tenants a non-refundable application fee.
- ❖ It is strongly recommended to screen all prospective tenants starting at age 18yrs.
- ❖ Send prospective tenant to www.tenanscreeningnow.com or the PDF application and credit card forms.
- ❖ Physically verify all information provided including pay stub and rental history.
- ❖ Keep a copy of tenant's picture ID on file. Retain all applications for 5 years.
- ❖ Ensure application is legible, complete and it's signed.
- ❖ Submit via email to David@tenantscreeningnow.com with Cover Sheet.
- ❖ Adverse Action Notice MUST be issued with the following:
 - Denial of tenancy
 - Increasing the security deposit
 - Requesting additional advance rent amount or any changes of rent schedule
