

Privacy Policy for the Flutter Development Contest

1. Introduction

- 1.1. The "Flutter Dev Contest" (hereinafter "**Contest**") is a competition with cash prizes organized by Fhoster s.r.l.with registered office in Rome (Italy), via Baldo degli Ubaldi 190, tax code and VAT number 09983451007 (hereinafter "**Organizer**").
- 1.2. The enter the Contest, participants (hereafter "Participants") need to register an account on Livebase, which is a low-code development platform (hereafter "Platform") developed by the Organizer, and to use it to create a software application (hereafter "Entry") to be submitted for evaluation.
- 1.3. The Contest falls under the case from art. 6 of Italian D.P.R. 430/2001 (non-primarily commercial nature): participation is totally free (it does not require the prior purchase of any product or service), and the prizes up for grabs will be recognized as performance of work only to those Participants whose Entries will show high-profile technical skills and abilities according to well defined and published evaluation criteria.

2. Data Controller

3. Purpose And Legal Basis Of The Processing, Nature of the Conferment

3.1. Participation in the Contest and disbursement of the prize.

- 3.1.1. **Purpose**: to enable you to carry out the registration to the contest, the related participation and the possible disbursement of the prize.
- 3.1.2. Legal basis: execution of a contract or pre-contractual measures (art. 6.1 lett. b) GDPR).
- 3.1.3. **Nature of conferment**: necessary to be able to participate in the contest and for related fulfillments.

3.3. Publication of your photograph as a winner of the Contest.

- 3.3.1. **Purpose**: in case of winning the contest, publication of your photograph on the social networks used by the company and/or on its web site.
- 3.3.2. Legal basis: consent in accordance with Art. 6.1 lett. a) GDPR.
- 3.3.3. **Nature of conferment**: optional and does not affect participation in the contest. For this purpose, an appropriate disclaimer will be sent to you attached.

4. Revocation of consent

- 4.1. Consent may be revoked at any time by contacting the data controller at one of the contact details indicated in this policy.
- 4.2. Revocation of consent does not affect the lawfulness of the processing based on the consent before revocation.

5. Recipients Of Personal Data

- 5.1. Personal data will be made accessible to employees and collaborators of the owner, authorized to process them pursuant to Article 29 GDPR or to data processors pursuant to Article 28 GDPR.
- 5.2. Such persons, in carrying out the processing of personal data, shall follow the instructions provided by the owner.
- 5.3. You may request the full list of data processors by forwarding a specific request to the owner at one of the contact points indicated in this policy.
- 5.4. In the case of publication on Social and/or newspapers, the data will be published as described above.

6. Storage Of Personal Data

- 6.1. Data will be processed for the duration of the contest and, once it is over, for an additional two(2) years.
- 6.2. With reference to the processing carried out on the basis of your consent, personal data will be processed until you revoke your consent.

 - 8.1.3. the right to be forgotten pursuant to Art. 17 GDPR;
 - 8.1.4. the right to limit processing when one of the hypotheses provided for in Art. 18 GDPR occurs;
 - 8.1.5. the right to receive certification that the operations carried out pursuant to Art. 16, 17 and 18 GDPR have been brought to the attention of those to whom the data have been communicated, unless this proves impossible or involves a disproportionate effort (Art. 19 GDPR);
 - 8.1.6. the right to data portability under Art. 20 GDPR;
 - 8.1.7. the right to object to the processing of personal data under Art. 21 GDPR;
 - 8.1.8. the right not to be subjected to a decision based solely on automated processing pursuant to Art. 22 GDPR;
 - 8.1.9. the right to withdraw consent (Art. 7 GDPR) as stated above;
 - 8.1.10. the right to lodge a complaint with a supervisory authority pursuant to Art. 77 GDPR.
