Contract agreement template for promoters

The life of a nightclub promoter is risky. For every event that pulls in a lot of cash, there are a couple that lose money. A thorough club promoter contract is the best way to help prevent losses and ensure a solid show. When it comes down to it club promoters and clubs are on the same side. They both want to pack the place and make a sizable profit, but expectations need to be set beforehand. Any club promoter contract should cover the very basics of the event. Most contracts clearly outline the following: The date of the event The venue name (include the address and phone number) The load-in time Event start and end time Club facilities open for use (like dressing rooms and showers) Artist rider (which is particularly important regarding alcohol licensing) Backline equipment Merchandise terms Payment, split and expenses Required insurance and security (if venue requires it at all) Curfew Additionally, most club promoter contracts include a clause where the promoter is responsible for damages that occur during their event. Basically, the most important thing to a nightclub renting out their space is knowing that they're going to get paid and their facilities will not be destroyed in the process. If you're looking at a nightclub promoter agreement sample, you'll probably notice that the finances are completely up front. There are a few types of payment structures nightclubs use with promoters. Door-split deals Flat rental rates Bar percentage minimums and kick backs For a door-split deal, a promoter will be paid a percentage of the ticket sales, while the nightclub will keep the rest. For example, a promoter might be paid 75% of the door after 15 tickets are sold (15 tickets being the number a club needs to sell to cover their nightly expenses). On the contrary, small club may charge a room rental rate of, say, \$500 up front regardless of whether or not any tickets are sold in order to cover staff expenses, sound technicians, and security. This is a bit of a gamble for a promoter if they're working with a new act, but the promoter stands to make a lot more money if the gig does really well. Nightclubs also do bar minimum deals with promoters, which means an event needs to make X amount of money from bar sales or the promoter has to pay a room rental fee. A promoter might also look to add a bar kick-back clause to a nightclub promoter agreement, but this is typically only granted if the promoter already has a good, proven relationship with the club. This means a promoter is given a certain percentage of bar sales if the event makes a certain amount of revenue. Basically, it's a reward for booking a great, lucrative event. Artists often have gear preferences and promoters are responsible for providing that gear. For this reason, a club promoter agreement should outline what gear the club will provide, if any. This way, the promoter has adequate time to find gear rentals if the artist has a specific brand or model outlined in their contract that isn't readily available. Some nightclubs also have stagehand union labor, which means anyone who is not a stagehand cannot legally bring gear into the building or set it on stage. This should be outlined in advance so a promoter doesn't accidentally break union laws by loading in his own PA system, for example. Many nightclubs take a percentage of merch profits (between 10% to 20%), while others let artists keep all of their sales. This is mandated by the nightclub, not the promoter, so it should be outlined in the nightclub promoter agreement. Some clubs also require their own staff to vend the merchandise, while other clubs require the artist to bring her own vendor. There are a few other legal considerations outlined in nightclub promoter agreements. For one, some venues require promoters to carry event insurance. Even if the club already has its own event insurance, it would be wise to carry a policy anyway. Alcohol licensing laws also vary depending on the state and the license carried by the club. This should be outlined in a club promoter contract. In some cases, a promoter will not legally be able to provide outside alcohol requested on their artist's rider and must, instead, purchase it from the bar. Some clubs only allow alcohol to be given to artists in the form of drink tickets. Other clubs have exclusive contracts with liquor brands or are only legally allowed to sell beer. Alcohol laws also varies based on whether it's kept back stage or in the front of house. Always ask for clarification in your contract beforehand. Nightclub promoters schedule entertainment and advertise events on behalf of nightclubs. If you are a promoter, an agreement with the bar owner is extremely important to protect your rights. In addition to determining the various responsibilities of the parties, a good nightclub promoter agreement will establish how contingencies will be handled, how compensation will work and who will retain the rights associated with the events taking place at the nightclub. In your nightclub promotion agreement, you must clearly dictate the terms of payment. Most agreements provide for compensation on the basis of club attendance. However, in some circumstances the club promoter will be paid a flat fee. In your agreement, you should clearly state how you will be paid, when you will be paid and the basis for payment. Also, club promoters sometimes receive a portion of tips or drink sales; negotiate terms that will be beneficial based on your circumstances. Your promoter agreement should clearly state who is responsible for staffing the various positions at the club and who will pay the staff. Although the nightclub will usually provide most of the staff, you might be required to hire doormen or security workers for certain events. Additionally, a good agreement will state what happens when the club is understaffed because an understaffed establishment can strain a professional relationship. If the terms of your compensation are based on door sales and the club is responsible for collecting fees at the door, you might negotiate an audit so that you can ensure that the club is compensating you appropriately. Generally, nightclub promotion agreements will set a specific term and state how many nights the promoter must provide entertainment within that term. The agreement should dictate what will happen if the promoter is unable to provide services on a particular night and when the parties will have the right to cancel an event because of inclement weather or unforeseen circumstances such as local sporting events. Be sure to include terms providing compensation for you if the nightclub owner decides to terminate the agreement prematurely. To properly promote an event at a nightclub, there must be a certain image and a sense of goodwill associated with the event. After an event is established, the public might begin to attend the event without the need for much advertising or additional promotion. Because of the large amount of work necessary to build goodwill in the eyes of the public, a nightclub promoter agreement should state who will retain rights to the name of the event after the agreement is terminated and how the parties can proceed with business following termination. The agreement must state what would happen if the promoter is incapable of furnishing services on a specific night and when the parties would have the right to cancel an event due to bad weather or unforeseen conditions. Also, ensure to contain terms providing payment for you if the nightclub owner chooses to terminate the contract prematurely. Goodwill: In order to promote an event at a nightclub, there should be a certain image and some goodwill connected with the event. Due to a large amount of work essential to build goodwill in front of the public, a nightclub promoter agreement must specify who shall retain rights to the name of the event after the agreement is terminated and how the parties could continue with the business following termination. How to Draft the Club Promoter Contract? The basic points to cover in a club promoter proposal sample are; Compensation terms between promoter and club owner. Date of services provided. The term club promoter contract may be terminated by either party for a material breach(1) of terms or a reasonable reason by any of the contractual parties in writing. In case the parties are unable to resolve the dispute, then the affected party could sue the other in the local court of the State After you have been in the club promoting business for a while, you will realize that almost every customer has special requests relating to your services. Thus having a good contract in place would protect your business in the unfortunate incident of a non-paying customer.
