# GYPSY NATIONAL CHAMPIONSHIPS SHOW

# **RULES AND REGULATIONS**

#### **EFFECTIVE DATE**

These rules become effective September 1, 2022, for the conduct of the 2022 Gypsy National Championship Show. This show shall be governed by the rules and regulations of the 2022 Feathered Horse Classic Official Rulebook and the 2022 Gypsy National Championship Handbook.

All participants and owners agree to abide by such rules and regulations. Any rules and regulations not covered by the 2022 Feathered Horse Classic Official Rulebook or by rules and/or regulations of the 2022 Gypsy National Championship Show will be handled by the Show management, and their decision will be final without recourse of any nature.

This show will follow all regulations of the Horse Protection Act of 1970, Public Law 91-540 or as amended.

Upon entry, every exhibitor, owner, trainer, person in care, custody, or control of a horse, and all other National Show participants (collectively "Participants") accept the facility and grounds, including but not limited to, the arenas, barns, stalls, and alleyways on an "as is" basis.

All Participants agree to obey the decisions/instructions of FHC representatives, Bell County Expo Center officials, and local, state, and federal officials.

#### **Admission to the Arena**

No person will be permitted to enter the arena, except participants in the class, judges and their assistants. In classes where attendants are allowed, they will not be permitted in the arena until summoned by the judge.

#### **Arrival**

Early Arrival will start on Tuesday, November 1, 2022 at 8am. See Entry Form for Applicable Fees. There will be someone onsite to check you in. ABSOLUTELY NO ARRIVALS WILL BE ACCEPTED PRIOR TO THIS TIME.

Standard Arrival begins Wednesday, November 2, 2022 at 8am.

#### **Arena Gate Calls**

Barn calls are a courtesy and will be made for each class. Regardless of the circumstances, it is the exhibitor's ultimate responsibility to report to their class on time.

# **Attire for Driving**

All attendants must be neatly and suitably attired for a National Championship Show. Stable Livery as defined in the FHC Rule Book, pg 57 and appropriate footwear are required.

Shorts, tank tops, sandals, etc., are not considered proper. Hats are optional, but ball caps are not permitted. The management may, at their discretion, bar any entry or person from entering the arena if deemed not suitable to appear before an audience.

### **Breaks**

FHC reserves the right to reschedule any published breaks as necessary. Additional breaks will be announced as deemed proper according to the progression of the show.

# Cancellations/Refunds

No Refunds for stalls, classes, shavings, office fees, vendor space, sponsorships, catering or advertising. No refunds for cancellations due to hazardous weather, Acts of God, human or equine accidents, illness or emergencies.

## **Check In Procedures**

Please bring to the Horse Show office your printed copies of your Health Papers, Registration Papers and Amateur Cards. You will be given your Horse Show Packet with your back numbers at that time.

# **Class Placings/Awards**

1<sup>st</sup> - National Champion – Neck Ribbon & Award

2<sup>nd</sup> – Reserve National Champion – Ribbon & Award

3<sup>rd</sup> - 6<sup>th</sup> - Ribbons

7<sup>th</sup> – 10<sup>th</sup> – Will be awarded Finalist Ribbons

During the Gypsy National Championship, the placings for each judge will be posted after the conclusion of each class. The announcer will announce the average placings in all classes.

Average placings only will line up for awards.

Showmanship, English Equitation, Trail, Western Horsemanship and Ranch Riding are scored classes.

All other classes are placed classes

Results of classes are considered final upon receipt of the judge's cards, unless an error in tabulation has occurred. FHC reserves the right to correct obvious errors on judges' cards when detected.

## **Commercial Exhibits/Vendors**

If an individual wishes to sell, display, or advertise tack, clothing, jewelry, furniture or any miscellaneous merchandise, a signed vendor contract must be on file with FHC. In addition, the merchandise must be sold in designated vendor areas only. No items may be displayed or sold out of the barns or parking lots. Anyone found in violation of this rule will be issued a written warning on the first offense. The second and all subsequent offenses will yield a \$500 Fine each.

## **Departure**

All facilities must be vacated by 9pm Sunday, November 6, 2022 unless other arrangements have been made with Show Manager.

# Disqualification

Abuse – Any horse that shows evidence of fresh blood in the mouth, nose, chin, shoulder, barrel, flank or hip area will be considered to be abused and may be excused from the arena.

Dishonesty – Any exhibitor that has made or caused to be made any false statement in regard to any animal or article exhibited, or if any exhibitor shall attempt to interfere with the judges in the performance of their duties, he or she shall be excluded from exhibiting.

General – In all individual work classes, simple majority opinion of the judges shall prevail, such as off pattern and lameness.

Lameness – A horse will be excused from the arena if a simple majority of judges disqualify the entry due to lameness.

Loose Horse – Any equine that becomes separated from its handler, rider or driver and cannot be caught by the original exhibitor or is beyond the exhibitors control may be disqualified and excused from the arena.

## **Electronic Devices**

Any exhibitor using an electronic device in the show arena will be immediately disqualified. (Exception: Reasonable Accommodation certificate has been issued.)

#### **Exhibitor Back Numbers**

It is the responsibility of the exhibitor to verify, prior to entry into the ring, the correctness of their exhibitor number. Any exhibitor not displaying a number or displaying a wrong number will not receive credit for placing in that class and will be disqualified.

In-Hand – Exhibitor numbers should be worn on the exhibitor's back, between the neck and the waist.

English and Western/Ranch Classes – One number must be on **EACH** side of the saddle pad/blanket.

Driving Classes – Number must be displayed on both sides of the vehicle shafts.

# **Equipment Judges/Technical Stewards**

Equipment Judges/Technical Stewards shall be responsible for attire and equipment rule interpretations. Final interpretations are the responsibility of show management.

All bits, tack, appointments and attire shall be checked by the equipment judge prior to entering the arena. Any equipment considered to be inhumane or illegal by the official equipment judge must be removed or entry into the arena will be denied.

The equipment judge may disqualify an entry for the presence of blood on the horse.

The equipment judge (s) may serve as an official alternate judge at the discretion of show management.

# **Exercise/Lungeing**

Exhibitors will receive a schedule of available practice times for some specific disciplines in their show packets. No lungeing will be allowed in the show arenas. Lungeing areas will be designated and should be closely followed.

# **Health Requirements**

All equine must have their printed health certificates and Coggins papers checked.

## Required Health Documents

To comply with Texas State Animal Health Regulations and to ensure the health of your horse, the following requirements will be strictly enforced for all equine at the Gypsy National Championship Show.

#### All equine must have:

- 1. A 12-month Original Negative Coggins test. The State of Texas Department of Animal Health Division requires a negative Coggins Test, showing said animal to be negative to either AGID or ELISA test for EIA within 12 months prior to show date, must accompany all equines. Foals, 8 months of age and under, are exempt from this requirement if accompanied by their negative tested dam. Date and results of this test must be shown on the health certificate. Test result papers should include animals REGISTERED NAME (rather than barn names) and MARKINGS.
- 2. A PRINTED hard copy of a 45-day Health Certificate or a current, valid equine interstate passport or equine identification card issued within 6 months is required for all equines entering the facility..
- 3. Any equine arriving without a negative Coggins test and Health Papers will be quarantined until released by a veterinarian or until originals can be supplied. All tests will be at the owner's expense.
- 4. Make sure and bring your Health Certificate & Coggins to the Show Office in order to get your show packet. All health papers must be printed on paper; no pictures on phones will be accepted.

# Horses, Dog & Pet Management

No horses should be turned loose in any arena on the grounds of the Bell County Equine & Livestock Complex at any time.

No dogs will be permitted on the Bell County Equine & Livestock Complex during the course of the show except those under leash control of the owner. Any dog running free will be impounded and removed from the grounds.

No dogs are allowed in the show arenas.

Dogs are prohibited in the warmup arenas and makeup areas while classes are showing.

Owners must assume all liability for pets brought to the show.

Proof of current rabies must be available upon request

#### **Horse Show Office Hours**

Sunday, November 6, 2022 – 7AM to 30 minutes after last class of day

#### **Inhumane Treatment**

No person shall treat any equine in an inhumane manner. This prohibition against inhumane treatment applies to all Trainers, Agents, Representatives, Employees, Exhibitors, Owners, and Spectators. Inhumane treatment shall include, but not be limited to, the prohibited conduct specified below.

- 1. For purposes of this rule, a person responsible for the care of an equine is also responsible for and may be disciplined for the inhumane conduct of their trainers, agents, representatives and employees. For violation of this rule, an individual may be disciplined, suspended, disqualified, expelled from show grounds. The Show Steward will be on hand to police any type of inhumane treatment.
- 2. Inhumane treatment of any horse or any other animal on show grounds is strictly prohibited. Treatment of any horse will be considered inhumane if a person, educated or experienced in accepted equine training techniques, would perceive the conduct of an individual to be inhumane.
- 3. For purposes of this rule, a fines and penalty system has been established based on the severity of the offense. All offenses below will be assigned a minimum level of offense (level 1 = mild; level 2= moderate; level 3 = severe). Depending on the facts of a situation, the level of offense may be increased.
- 4. Warning or Show Ground Removal cards will be issued based on the frequency and level of offense.
- 5. Inhumane treatment includes, but is not limited to:
- a. placing an object in an equine's mouth so as to cause undue discomfort or distress (min. level 2);
- b. leaving a bit in an equine's mouth for extended periods of time so as to cause undue discomfort or distress (min. level 1);
- c. tying an equine up or around in a stall or anywhere at event in the manner as to cause undue discomfort or distress (min. level 2);

- d. longing or riding an equine in a manner as to cause undue discomfort or distress to the equine (min. level 1);
- e. tying or fastening any foreign object onto an equine, halter, bridle and/or saddle in order to de-sensitize the horse (min. level 2);
- f. use of training techniques or methods such as poling or striking an equine's legs with objects (min. level 2);
- g. excessive spurring or whipping (min. level 1);
- h. excessive jerking of reins (min. level 1);
- i. use of prohibited equipment, including, but not limited to: saw tooth bits; hock hobbles; tack collars; or tack hackamores; whips used for showmanship; war bridles or like devices; riding in a curb bit without a curb strap; wire or solid metal curb straps no matter how padded; wire cavesson; wire or cable tie-downs; bumper bits; metal bosals (no matter how padded); chambons; headstalls made of metal (no matter how wrapped or padded), twisted rawhide, or rope may not be used on a horse's head (3/8 inch rope may be used with a slip/gag bit); running martingales used with curb bits used without rein stops; draw reins attached between or around the front legs will not be allowed (min. level 2);
- j. use of any item or appliance that restricts movement or circulation of the equine's tail (min. level 3);
- k. exhibiting an equine which appears to be sullen, dull, lethargic, emaciated, drawn or overly tired (min. level 1);
- I. intentional or negligent treatment which results in any bleeding intentional (min. level 3); negligent (min. level 1);
- m. applying excessive pressure on or excessively jerking of a halter lead shank (min. level 2);
- n. Any other treatment or conduct deemed by a show official to be inhumane or abusive (min. level 1).

## **Lost Back Numbers**

In the event of a lost back number, a fee of \$20 will be assessed for a replacement.

#### **Lost & Found**

Lost & Found items should be turned into or claimed at the Horse Show Office.

# Official Photographer/Videographer

The Championship Show's official photographer, and videographer are the only parties permitted to provide others with competition photos or videos – whether for payment or for free. Anyone, other than credentialed official sources, who provides or intends to use photos or video footage in violation of this Policy can be ejected from the event and/or indefinitely banned from the show.

#### **Paddock Procedures**

Exhibitors are required to check in with the Equipment Judges in the warm up/paddock arena. Exhibitors will be required to drop bridles for bit checks and will be required to trot for soundness checks. The Paddock Master will call exhibitors to the arena in their posted order of go.

Barn calls are a courtesy and will be made for each class. It is the exhibitors' responsibility to report to their classes on time.

# **Unsportsmanlike Conduct**

Unsportsmanlike Conduct or any other form of misconduct that is irresponsible, illegal, indecent, profane, intimidating, threatening or abusive is prohibited. This provision applies to exhibitors, trainers, owners, owner representatives, spectators and all other persons on the show grounds. Show management may immediately expel individuals exhibiting unsportsmanlike conduct from show grounds and shall file a written report with above mentioned associations concerning the conduct in question.

# **Qualifying Requirements**

Every entry must have shown at least one show during the qualifying period (January 1, 2022 thru October 30, 2022) and placed 1<sup>st</sup> thru 6<sup>th</sup> in respective classes.

## **Show Rules**

Gypsy National Championship show will follow Feathered Horse Classic Show Rules. Any issues not covered by FHC Rulebook will follow up with GVHS Rule Book.

#### **Show Schedule**

The National Championship Show will be held November 3-6, 2022, at the Bell County Equine & Livestock Complex, Belton, TX.

The tentative schedule is available online and may be changed at show management's discretion.

Any classes deemed necessary by the Show Management will be split. For Rail Classes, all recalls from the average will be announced in random order by the exhibitor numbers and will retire to the Paddock area until call for the Final Go.

# Stalling/Shavings

Stall Fees must be received and paid for by the September 26, 2022 deadline. Please make sure that you order all horse and tack stalls on your entry forms. There will be no switching of stalls once they are assigned and no additional stalls will be available in Main Barn after deadline.

Initial Shavings order must be on the Entry Form and subsequent orders will be done on-site from the facility.

IF STALL CURTAINS ARE USED ACROSS AN ALLEY, THEY MUST BE TIED BACK AND REMAIN OPEN FOR PASSAGE THROUGH. THERE WILL BE NO EXCEPTIONS.

No part of the decorations may extend from the edge of the stall in any alleyway. No nails, liquid nails or tacks are to be placed in any stalls to hold up decorations.

Stall decorations may not extend more than three feet into the alley.

Stall decorations may be constructed any time until the first day of competition. Once the show has begun, construction may only occur outside the hours of competition.

# **Tack Changes**

All Tack changes must be pre-scheduled with the Paddock Master. There will be a 3 minute time limit which will start when the final class call from the Equipment Judge will be allowed for all changes to be made in the Paddock Area.

# **Vendors**

Only approved vendors are allowed to sell product or services during the Gypsy National Championships Show.

# **Working Orders**

All Classes will have a posted working order. The working orders will be posted by 6pm the night before the class is to be run. If an exhibitor does not show up for their turn in the working order and does not have a pre-scheduled conflict or tack change, it will be considered a missed classes and will NOT be moved in the order.
