INTRODUCTION

This form should be used by the Breeder(s) to register all puppies in a litter by name and must be submitted within 12 months of date of birth. Any pupples emitted on this form will not normally be considered for subsequent registration. In exceptional circumstances the Committee may consider to register a litter after 12 months of age, the smalication and cheque for the fee should be accompanied by an explanatory letter.

GUIDANCE NOTES

- 1) Owner(s) of the sire at the date of mathie. The name(s) entered on the form MUST be the same as in the Sire's Registration Cartificate. All owners MUST sign the Confirmation of mating on this form. This may be signed at time of Mating,
- 2) Breeds (s) The owner(s) of the Dam at the date of whelping. The name(s) entered on the form MUST be the same as on the Dama KCJ Registration Certificate. All owners MUST sign the Breeders declaration on this form.
- 3) Registered names of both the Dam and the Sire must be entered as they appear on their registration Certificate along with their respective Registration Numbers.
- 4) Stud Book Numbers this should be used in place of a Registration Number is obtained. 5) Non-Jersey Stad Dogs - A copy of the three generation pedigree with registration numbers MUST be included with the application.
- 6) Date of Mating and Date of Birth must be accurate as discrepancies may result in the application being rejected.
- 7) The number of Puppies in Litter must be the same as the number of puppies named.
- 8) All Pupples most be named on this form in the absence of sufficient names, or alternative, the Registrar may allocate a name. See note 10, Once named a puppy may not change its name except for the addition of an affix.

GUIDANCE FOR SELECTION OF NAME

9) When selecting a name please run embar:-

- A) The name must be at least two words and may not be longer than 24 letters factoring the breeders affix if applicable. An affix may be granted to a breeder, on application and is reserved for their sole use when naming dogs. It is not necessary to have an affix to register a litter.
- B) Names may not be re-used within 15 years by a dog of the same group. Although this may be used as part or inn conjunction with other names or an affix to make the selected name unique.
- C) No names recorded in the UK Stud book may be re-used with the same breed.
- D) Names must not conflict with another persons recognised affix. The KCJ respects and maintains any affix also held in Guernsey or the UK.
- E) You may not include the Surmanne(s) of Breeder(s) and no Channel Island names or
- F) Single Letters shall not start the name.
- G) Inttials cannot be used and abbreviations may be disallowed.
- H) Numbers may be written but not in figures and may not be used to indicate a sequence.
- I) Ponetuation marks may be rejected.
- 1) Canina terms may not be used. Such as dog, bitch, hennel, Crufts, Champion etc or the
- K) Repetition of a word, with the exception of an affix, within a litter is not permitted. If an Affix is applied for at the same time as registration the affix most be granted before registration if processed.

L) An Affix may be used when registering a litter, if the breeder has one, this must be the first word in the name. A new owner of a dog may add their affix to the end of a dogs name at a later date. If this new owner is the breeder of both the Sire and the Dam they may add their affix at the front. No affix may be edded if endor-ement 12(d) is added at the time of

- M) It is not possible to change the name of a dog after registration, except for the addition on an affix as mentioned in 11.
- N) Names that appear in the pediarce of the Sire or Dam are discouraged as they may cause confusion and may not be accepted by the registrer.
- O) Offensive or inappropriate names will be refused.
- 10) Alternative names should be given in case unacceptable names are disallowed. The Registrar may select an uncorpriate name without reference to the breeder, Also see note 11. Where insufficient eligible names are given the Registrar may provide a name. This

name may not later be changed except for the addition of an affix. COLOURS & ENDORSEMENTS

- 12) Any or all andersements may be placed on any dog by it's current owner(s), these may only be lifted by application to the Kennel Club of Jensey in writing by those who imposed the endorsement, or by a new owner if the Kennel Club are eatisfied that the endorsement was impropedly applied.
- It is important to check for breed specific information on any breeding restrictions and the colours available for your breed.
- A) Not eligible for Show, field or Working Trial held under KCJ licence.
- B) Progeny aut eligible for Reststration,
- C) Not elizable for the issue of an Export Pedigree.
- D) Name unchangeable by addition of an affix (additional fee payable for 12(D))

GENERAL NOTES

- 13) To Register more than 8 dogs please attach a further Form KCI 1 to this application.
- 14) When close to entry for a show is before the applicant has received confirmation of Registration then N.A.F (Name applied Por) should be entered on the entry form in place of the Registration Number, Enough time should be left for Registration as any dog without completed Registration will not be permitted to be shown and entry fees are forfelt.
- 15) When a blich has been served by more than one dog in the same season the program will not be registered unless a DNA prufile match is completed.
- 16) The Registration Certificate and transfer forms will be sent to the breeder for all puppies in the litter upon completion of registration.

NON-ACCEPTANCE OF REGISTRATION

- 17) The Kennel Club of Jersey reserves the right to reject any application to register or ament an affix, or to resister, transfer, change a dog's name. Also the KCI may cancel or suspend any registration already made.
- 18) Registration will be refused for any litter where:
- A) The Dam has aircardy had 4 litters (registered or not)
- B) The Dum was 8 years or older at date of whalping
- C) Has been bred from for two or more consecutive seasons.
- D) Where the litter was born before the Dam was 12 months of age.
- E) Where the mating is of a mother/son, bither/daughter or brother/sister.

MISCELLANEOUS

- 19) The acceptance of a registration is not a guarantee of its accuracy.
- 20) This form remains the property of the Kennel Club of Jersey.
- 21) The Kennel Chib of Jersey is registered under Data Protection (Jersey) Law
