IMPORTANT NOTES

1. An affix consists of one word only and must not be hyphenated.
2. **The affix should be a 'made up' word**, A word listed in a dictionary is unlikely to be granted as a registered affix.
3. The Committee will not grant the use of **an affix** of the names of counties, countries, towns, Parishes or titles, **a** letter or number, or an adjective or noun appropriate to the name of the dog, and any grant will be at the discretion of the Committee, who may cancel any grant at any time.
In no circumstances may the grantee dispose, or attempt to dispose of **an** affix.
4. Affixes constitute part of **a** name and cannot be used for registration by any person other than the person who for the time being is entitled under a subsisting grant to the Committee.
5. If the applicant has been granted **a** word for use as an affix by a recognised and ruling body overseas, details supported by documentary evidence should be given. If the grantee of a registered affix wishes to use it when registering **dogs (a)** bred by him or (b) bred from parents each of which was bred by him, it must **appear** as the first word in the name. Otherwise it must appear as the last word in the name.
6. The name of a dog on its initial registration is restricted to not more than 24 letters. If **a** registered affix contains too many letters there will be difficulty in selecting short words suitable for use in conjunction with the prefix and to comply with the above requirements.
7. The Committee will grant to a partnership the use of an affix, but **applicants** should note that the word can be used only for registration of dogs owned by that partnership and not separately by the individual partners. If it is proposed to use the word for the registration of names of dogs owned by the partnership and singly, the affix must be registered separately by the partnership and the individual partners.
8. The word cannot be used for the registration of the names of dogs until it has been officially granted by the Committee but applicants for the registration may be lodged at the time of application for the affix and will **be** held pending the decision of the Committee.
9. For the benefit of the Committee, if you think that you have **a** prior right to the word overleaf ~~please state~~ your reason in the form of **a** letter.
