Other programs operate starting at higher multiples; for example, families are eligible for Weatherization Assistance at 200% of the FPIG, and SNAP (previously known as food stamps) at 160%. Welfare fraud refers to wrongfully obtaining or using public assistance or benefits offered through government programs that are meant to assist low-income, disabled, or elderly individuals. Your household's combined income for the past 30 days must be below 150% of the poverty level. In Tennessee, LIHEAP is administered through a network of 19 local agencies that reach all 95 counties. Both programs are funded with Pennsylvania Lottery. cost of living led to the Poverty Guidelines amounts being raised in 2020
