GUARDIAN PLAN (GBV)



Gender-based violence remains a deep-rooted problem in South Africa. Often, when we see the news, there is a report of a female who has gone missing or has died as a result of women's abuse.

This violence includes verbal, emotional, sexual, physical, and psychological abuse. Although both men and women experience GBV, the statistics in South Africa show that most of the victims are women and girls.

GENDER BASE VIOLENCE (*Starting at R75 / month*)

Residential Guardian offers an armed security protection to members to protect them from GBV. In the event of the member feeling unsafe and are in danger, an armed, highly trained security guard will be dispatched to the member's location.

The product includes the following benefits:

- Access to security networks within a 50km radius of the major metropolitan areas;
- 24-hour crisis centre will dispatch the reaction units to the member's location;
- The roadside Guardian will stay with the member until assistance arrives or at the time that the member feels safe and no longer require their services.

General Conditions:

- The 24-hourcrisis centre will evaluate the member's scenario and determine if a reaction unit will be required;
- Response times within the 50km radius varies between 15 and 40 minutes depending on the member's location, acts of God, weather conditions, road conditions and traffic.

1) USSD PANIC CUSTOMER JOURNEY

The Panic USSD function enables a call-back to the member's cellphone via mobile network. Within 60 seconds of activation the member will receive a call back to assist with any of the emergency services the member has access to.

To qualify for access to the benefit the member must be active on the database
Location based services must be activated in order to identify the member's exact location.

•Service is requested via a unique short-code, which is made available to the member at the time of registration.



TRAUMA & ASSAULT PROTECTION

Telephonic trauma counselling is provided in the event of the customer being affected by an event, condition or incident which could be but is not limited to domestic violence, school bullying, teen suicide, teen pregnancy, motor accident, hijacking, and burglary, the loss of a loved one, family chronic or life- threatening medical condition or disability. Telephonic debriefing and counselling are conducted by the qualified counsellor and should the counsellor determine a need for additional face-to-face counselling, the customer will be directed to an appropriate trauma counselling centre, nearest to the customer's work or home address.

HIV COVER

In case of accidental or traumatic exposure to HIV/AIDS you have:

- Unlimited telephonic counselling intervention, advice and information.
- "Morning after" pill to prevent pregnancy.
- 30 Day starter pack of anti-retroviral medication.
- 7 Day courses of medication for the prevention of the development of sexually transmitted deceases.
- Registration for an HIV/Aids management programme. Counsellor recommended.

Contact Centre must be notified within 24 hours of exposure to access the C5 HIV prevention plan.

Family Matters Covered

Civil Matters

- Institute civil action on your behalf OR defend an action instituted against you.
- Prepare and serve a Letter of Demand, issue a Summons and obtain a Warrant of Execution.
