CHAPTER PRESIDENT'S SUMMARY



The members of the Coalition have worked diligently to engage our Prince George's County and Maryland communities in the fostering of economic empowerment, advancing home ownership, and financial literacy through partnerships with Wells Fargo, the Truist Foundation, United States Coast Guard, Arctaris, and business leaders that shared their knowledge and skills in numerous webinars.

NC100BW, Inc. Prince George's County Chapter has advanced the mentoring of Black women and girls through leadership development talks, advancing college readiness, career skills, while partnering with the U.S. Soccer Association, the United States Coast Guard, Quality of Life Pharmacy and Health, Arctaris, political and health leaders, and Prince George's County Public Schools.

Advancing legislatively, the safety of our children, equitable school funding, building opportunities for women transitioning from incarceration into the workplace are just a few of the women's and girl's issues addressed thanks to partnerships with the Maryland Legislative Agenda for Women (MLAW), Office of States Attorney, the Prince George's County Legislative Delegation and the Maryland Black Caucus.

We thank our members for their advocacy in our fight for gender equity and leadership in the areas of economic empowerment, education and mentoring, health equity and public policy to foster social justice.

We thank our members for advancing the most comprehensive police reform and accountability legislation in the country.

We thank our members for helping to prevent homelessness and protect home ownership and family wellbeing through policies related to addressing COVID. We thank our long-standing partners, like the Central Baptist Church of Camp Springs for advancing health outcomes and equity during the pandemic as we worked collectively to vaccinate over 2,000 people. We also worked together to advance awareness of the Ora Lee Smith Cancer Foundation with their lab proven cure for solid mass cancerous tumors.

We thank individuals doing excellent work that we have joined in partnership with, such as Dr. Hadiyah Nicole Greene, for her work to save our lives and change the economics of cancer prevention (see www.weareoralee.org). We thank Dr. Kevin Streete for caring for the health of the underserved communities in Prince George's County's and helping bring down the COVID infection rate and providing needed services in the Capital Heights area. Our health team informed the community on the metabolic syndrome that plagues our Black community, cancer awareness, urinary health, stress reduction and mental health resources. We brought awareness to the need for sickle cell testing in our communities coast-to-coast and better preparedness of doctors in treating us as patients and health consumers.

Our public policy team prepared position papers, shared resolutions on the need for school funding to address students' catch-up needs post-COVID, the need to address youth and adult obesity and healthy eating. We worked to ensure that marriage is not an excuse for rape. We advocated for the Time to Care Act. We asked for help for families and seniors so negatively impacted by COVID and its economic ravages. We supported the advancement of the first Black woman Supreme Court Justice and advanced the need for more representation of Black women in state elected offices. We thank our sister Chapters for their support and alliances to help move the most needs-based, people-oriented, progressive agendas through the Maryland legislature. Having the skilled, caring and talented Speaker of the House, Adrienne Jones, and two of our esteemed members, The Honorable Senator Joanne Benson and Delegate Diana Fennell, to help guide us. Having Maryland Black Caucus Chair's Delegate Daryl Barnes as a strong community partner and devoted public servant to Prince George's County and the State of Maryland was tremendous support to our effective advocacy on behalf of Black women and girls. Having a smart caring County Executive, Angela Alsobrooks, helped benefit the people of this county with increased legislative funding and resources for food, shelter, and health. States Attorney Braveboy and her team helped us address domestic violence and child protection.

We were delighted to feature a representation of our vast number of partners on our new website, ncbwpgc.net. I thank you each and everyone. To the dynamic advocates of NC100BW, Prince George's County Chapter, it is my honor to serve with you as president, as we seek to do justly, show mercy and walk humbly with our God, per Micah 6:8.





Title: Maximizing Your Health and Wellness!

Date: October 28, 2021

Location: Virtual

Purpose: The purpose of the webinar was to educate the community on healthy eating alternatives that enable long term wellness benefits.

Format: Virtual webinar with interactive questions from the audience as well as questions submitted prior to the event.

Number of Attendees: 25

Targeted Initiative: Health Awareness: Metabolic Syndrome Initiative. Health consumers have been given numerous options and a plethora of information on how to live a healthier lifestyle.



Activity Goal: To provide an open forum to discuss the benefits of adopting a holistic approach to health and wellness, gain in-depth knowledge of little-known nutritional facts, understand how food impacts the body at the cellular level, and the overall impact our environment plays in creating wellness. The meeting was designed to be highly interactive with all participants able to ask questions, gain feedback and understand current approaches to living a healthier lifestyle.


Effectiveness: Did Activities Achieve Its Objective: The program achieved the objective of creating an interactive discussion with health expert, Sheldon Ingram, who created a "safe zone" for discussing sensitive health topics related to the metabolic syndrome, nutrition and general wellness. This was a very informative and educational webinar, because the speaker shared various ways to eat healthy, dealing with stress, maximizing nutritional health, how important it is to get enough sleep and so much more. Mr. Ingram kept everyone engaged and asked many questions of the attendees. The speaker also answered many questions that were asked of him and went over his allotted time. At the end of the webinar, Mr. Ingram agreed to send us a copy of his book and other literature regarding how to improve health and wellness outcomes.

Outcomes/Impact: This webinar provided participants with a new way to look at their health – from the cellular level; how to decipher and navigate through the information on nutrition available in the public domain; the many alternatives to food purchases (i.e., membership in community farms) and different approaches to meal preparation; and treatments for health concerns such as obesity, high blood pressure, and diabetes.

Title: Coast-to-Coast Black Women's Health Initiative: Sickle Cell Webinar

Date: December 4, 2021

Location: Virtual

Purpose: The goal was to educate and have a discussion on the importance of research and the disparity of the community that is affected by Sickle Cell Disease. Our goal was also to bring new awareness, research and work that is still being done to combat Sickle Cell Disease.

Format: Virtual Webinar with interactive questions from the audience as well as questions submitted prior to the event.

Number of Attendees: 127, 266 registrations, and 204 views since posting the Sickle Cell Disease Presentation on the web

Targeted Initiative: Health Awareness: Sickle Cell Disease Awareness. The webinar targeted individuals interested seeking to understand what is Sickle Cell Disease, how is the disease treated, what resources are available in the health care industry and community to support individuals living with the disease or families supporting a loved one as a care-giver, and how can they become proactive in determining how future generations within their family may be impacted.

Sponsor: Prince George's County Chapter (Lead Chapter) in partnership with other NC100BW Chapters: Central Valley, Los Angeles (Co-Lead), Oakland/Bay Area, and San Francisco, Silicon Valley, and NCBW Maryland Chapters, Anne Arundel County and Baltimore Metropolitan, all worked together to present the Zoom webinar.

Co-Sponsor: Enterprise and Global Blood Therapeutics. The panel: Linda Blount, PHP, CEO, Black Women's Health Imperative; Dr. Salome Weaver, PharmD, Howard University College of Pharmacy; Dr. Terri Peters, RPh, PD, CEO, Quality of Life Pharmacy and Health; Deborah Green, Director of Health Education of the Sickle Cell Disease Foundation; Honorable Donna M. Christian-Christensen, MD, Dr. Michael Rutledge DeBaun, MD, MPH, Director, Vanderbilt-Meharry Center for Excellence in Sickle Disease and Patient Advocate Charla Davis.

Activity Goal: To provide a high-quality informational webinar in response to the National Resolution on Sickle Cell. To convey a rationale for participants to engage in and follow-up on the six "call-to-action" items presented at the end of the webinar, including writing in letters of support for HR495, conducting follow-up calls on Senators and Congressman on HR495, seeking genetic counseling, getting a health evaluation/test for Sickle Cell Disease, and becoming a bone marrow donor and specifically designating donations for Sickle Cell Disease recipients. The webinar provided in-depth information, through a speakers panel of experts and a patient advocate, on the Sickle Cell Disease in a comprehensive manner that included discussion on the types of Sickle Cell disease states (ex. Sickle Cell Disease anemia); current medical treatments and innovative drugs in the development pipeline; challenges with treatment in medical settings due to bias and health inequities; the negative economic effect on individuals, families, healthcare systems, and communities due to Sickle Cell Disease; and the historical and current legislation to support outcome improvements and access to quality treatment for all types of Sickle Cell Disease states. The webinar was designed to be highly interactive with all participants able to ask questions through the webinar's Q&A format.

Effectiveness: Did Activities Achieve Its Objective: Outcomes/Impact: The plethora of clinical health information and the sharing of legislation in support of Sickle Cell Disease research, treatments, and funding provided a clear pathway to the "call to action" stated at the end of the webinar. Participants were left with learning that more than 3.5 million people are affected worldwide by Sickle Cell Disease including approximately100,000 Americans. Sickle Cell Disease (specifically, SCD-Anemia) was first described in the western literature more than 100 years ago, but unfortunately the translation of such knowledge into developing treatments has been very slow and elusive. We certainly achieved our objective of informing chapter members, webinar guests and others through our collective social media that Sickle Cell Disease can be treated and managed, and with technology advancements, cured both in the United States, Africa and in other parts of the world. Participants learned there are medical professionals who are continuing to work hard on more research on drug clinical trials, gene therapy and resources for Sickle Cell Disease, and current legislation in Sickle Cell Disease and the importance of research and disparity of pain treatment. Since the event there have been 204 views since posting the Sickle Cell Disease Presentation on the web and conducted two radio/tv broadcast programs on www.ourtv.network.


Activity Goal: The activity goals of the event were to create a safe-space for a presentation and discussion forum with women participants on a highly sensitive subject, which was very informative and interactive. To help dismiss any discomfort regarding the subject, Dr. Walton engaged the participants in bingo game, in which there were three winners, using medical terms typical of her practice, such as vagina, pelvic floor, odor, yeast, etc., The presentation slides presented were extremely eye opening in terms of statistics, types of medical conditions, causes of pelvic floor health issues, etc., and very shocking to see, but at the same time very educational. The session extended long to ensure that all participants' questions were answered, which created robust conversation well after the original closing time.

Effectiveness: Did Activities Achieve Its Objective: The activities achieved our objective because it was clear by the many questions asked that women are misinformed or not aware of the medical field of urogynecology. Dr. Walton answered all the questions that extended the workshop by ¹/₂ hour with a desire to further extend the session because participates where still asking questions and gathering information.

Outcomes/Impact: Participants were able to understand urogynecology's complex role in women's health and medical treatments; understand why various female health issues within the pelvic region were not stressed in the medical community; how robotic technology contributes to effective treatments; and the types of questions to ask your gynecologist when possibly seeking treatment in order to become an educated health consumer. Based on the participants questions to the presenter, they had a clear understanding of the concepts presented. 100% of participants rated the program excellent, a five!

Targeted Initiative: Health Awareness: Improve Health Outcomes



Effectiveness: Did Activities Achieve Its Objective: The webinar exceeded our objectives by validating what participants learned and how to apply the learning in making lifestyle changes through physical activities, which was paired with previewing select NC100BW-approved apparel.

Outcomes/Impact: At the end of the webinar, members were still asking the vendor questions about certain items while engaging in more discussion regarding common concerns such as the impact of health inequality for Black women, the challenges with accessing healthcare, and the need for more open discussion about improving health outcomes for Black women and girls. It was a great event and a great collaboration with the Chapter's Community Outreach Committee and Shades of Me, LLC.

Sponsor: NC100BW, Inc. Prince George's County Chapter


Co-Sponsor: DuVal High School and Quality of Life Pharmacy & Health, Inc.

Effectiveness: Did Activities Achieve Its Objective: Students/Mentees were able to do the following:

- b) Answer questions related to the topic

Outcomes/Impact: Students understood the broader concept of pandemics and the global impact to our community's health. They engaged in robust discussion on how to address this health crisis personally and responsibly based on individual choices and attentiveness to personal health habits within their families and as a member of the community. Students shared the knowledge they learned about COVID-19 and healthy habits for teens with family and friends as an action step to help reduce the spread of COVID-19.

Title: DuVal High School Communication, Social Media and Mentoring Workshop

Date: December 9, 2021

Location: DuVal High School/Hybrid

Purpose: Educate mentees about the importance of engaging in social media responsibly and avoiding its pitfalls that hinder focus on the pursuit of educational goals.

Format: Virtual and On-Site Presentations, Discussions, Quiz, Videos, and Questions and Answers

Number of Attendees: 24

Targeted Initiative: Education and Mentoring: Improved Outcomes and Graduation Rates.

Sponsor: NC100BW, Inc. Prince George's County Chapter

Co-Sponsor: DuVal High School

Activity Goal: The workshop was moderated by NC100BC member, Katrina Dixon Patterson, and NC100BW member and Social Media Manager on the Communications & Technology Committee, Mya Hudson served as presenter to convey the important of mindfulness, safety, and appropriateness in the use of social media for school, social interaction, and fun.

Effectiveness: Did Activities Achieve Its Objective: Students were able to do the following:

- Discuss the importance of engaging in social media responsibly
- Understand and avoid its pitfalls, such as inviting unwarranted attention or falling prey to scammers
- Discuss what informative decisions they can make to change their social media habits

Outcomes/Impact: Students shared that the knowledge gained will assist them in being mindful about the choices they make regarding postings of content on social media. They left the workshop armed with an understanding of how social media can alter their emotions and unknowingly drive their decision-making, resulting in feeling inadequate, depressed, unfocused, confused, etc. Students learned the harmful effects of social media based on how data is used to further entice their engagement. Students also learned the positive opportunities social media creates and how to focus on these attributes. Lastly, Students stated they will share what they learned with their contemporaries and family members, and put into practice their learning.





Effectiveness: Did Activities Achieve Its Objective: Outcomes/Impact: The outcome of the voter registration and education program enabled members of the community not fully engaged in the voting process to understand the critical reason voting is a human right for all citizens and why becoming a registered voter is necessary to fully participate in the American democracy. Historically information was shared on various voting rights act and notable advocacy milestones, such as the women's suffrage movement resulting in the passing of the nineteenth amendment to the U.S. Constitution which allowed women the right to vote. MARYLAND AND PRINCE GEORGE'S COUNTRY AFFORDABLE HOUSING CHALLENGES MARYLAND

For over forty years, inequitable access to an insufficient inventory of affordable housing in Maryland has been a problem. In the last two years, COVID-19 related economic challenges have exacerbated the problem with increasing housing instability—particularly in low-income minority communities. As revealed in a Community Development Network of Maryland report, approximately 79% of tenants behind on rent in Maryland are black and brown, 49% are unemployed, and 78% have an income of less than \$50,000. In addition, tenants are more vulnerable to landlord's unfair housing practices such as a low threshold "just cause" lease terminations and evictions.

Maryland lawmakers proposed a 'Housing Justice Package' for the 2021 Legislative Session. The package of bills included an overhaul of the state's eviction process and new emergency restrictions on landlords. In addition, the legislation proposed to codify and expand current moratoriums on evictions through 2021 and prevent landlords from charging late fees or increasing rent during the state of emergency (Maryland Matters, Lawmakers Eye 'Housing Justice Package', December 28, 2020). Unfortunately, many of the "package bills" were not passed. An initiative to give tenants access to counsel in eviction cases was passed during the 2021 Session (Maryland Matters, Lawmakers Vow Renewed Push for Tenant Protections In 2022 Session, January 7, 2002).

During the 2022 Legislative Session, greater success was achieved in passing pro-tenant rights legislation thanks to the League of Women Voters' (LWV) and other partner organizations' advocacy efforts (e.g., Affordable Housing Issue Paper and written testimony on HB 881, HB 674 and related bills). Some of the bills that were passed include:

SB 6/ HB 86 Tenant Protections Act of 2022 -- Requiring that landlords disclose utility bill systems, making certain provisions if not disclosed, and providing rights to the tenants. Passed both chambers and enacted by the Governor.

SB 279/HB 571 Access to Council in Eviction Special Fund -- Altering the funds to include a broader category of where the money comes from and how it can be distributed. Passed both chambers enacted into law without the Governor's signature.

SB 744/HB 927 Affordable Housing - Excess Real Property – Requiring the Planning Department to turn in a list of excess property so the Department of Housing can determine if it can be used for affordable housing; establishes a rental housing fund. Passed both chambers and is on the Governor's desk.

SB 384/HB Stay of Eviction Proceeding for Rental Assistance Determination – Provides for safety of evictions proceedings when a tenant is waiting for a good faith application for rental assistance. Passed both chambers and is on the Governor's desk.


Similarly, housing insecurity, an insufficient supply of affordable housing and related issues are major challenges in Prince George's and other Maryland Counties (e.g., Baltimore). To address these and other challenges, in March 2016, the Prince George's County Council adopted a Resolution, CR-13-2016, to establish a Comprehensive Housing Strategy (CHS) Ad Hoc Subcommittee to develop a Comprehensive Housing Strategy for the County. The FY 2021-2025 Consolidated Plan is Prince George's County's strategic plan for leveraging the annual allocations of Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), HOME Investment Partnerships Program (HOME), and Housing Opportunities for Persons with AIDS (HOPWA) entitlement fund resources to develop viable communities of choice. It builds on the analysis presented in Housing Opportunity for All, the County's first 10-year Comprehensive Housing Strategy (CHS), and directly supports implementation of more than 17 actions from the CHS.

In addition, as part of the County's response to the Covid-19 pandemic, the County will leverage CARES ACT, Covid Relief funding and program income to support broader emergency rental assistance activities and provide funding for non-profit service providers to expand foreclosure counseling, housing counseling, eviction prevention, food pantry, as well as other activities.

The November 16, 2021 PRINCE GEORGE'S COUNTY CONSOLIDATED PLAN CFY 2021-2025 (FFY 2020-2024) report reveals that "tens of thousands of owner and renter households, especially those with lower incomes, experience housing cost burden. A household is considered 'housing cost burdened' if they spend 30% or more of their gross monthly income on housing costs". The report further details there are 46,043 households in Prince George's County with incomes at 100% or lower than the Prince George's County Household Median Income or AMI (Area Median Income) of \$74,260 (Table 40 – Median Household Income, p. 81) that experience housing cost burden and no other housing problems. Out of the total households, 25,326 are renter households and 20,717 are owner households.

In addition to severe cost burden, 2011-2015 Comprehensive Housing Affordability Strategy (CHAS) data shows that 29,004 (96%) of renter households and 19,915 (92%) of owner households with incomes at 80% or less than AMI have one or more severe housing problems, such as, lack of kitchen or complete plumbing, severe overcrowding and severe cost burden. The existence of severe housing problems for so many households implies that it is critical to provide affordable and quality housing for households below 80% of AMI.

Upon comprehensive examination of cost-burdens in Prince George's County, the Consolidated Plan report revealed that "a large share of cost-burdened households are households of color: Black or African-American represent 71% of all cost-burdened households, followed by Hispanic households at 13%. In comparison, White households make up 10% of all cost-burdened households".



Outcomes/Impact: This program was designed for current and potential Chapter leaders in the use of rules of order employed in several meetings and assemblies. These procedures are acceptable rules, precedents and practices used to maintain decorum and ascertain the will of the majority to preserve the rights, mission and vision of NC100BW. The Parliamentary Procedures Development Program effectively defined the purpose of parliamentary procedures, providing a basic understanding of the importance and efficiency in conducting a productive meeting. Post test responses by attendees showed that participants understood the importance of parliamentary procedures and Roberts Rules of Order, how parliamentary procedures impact organizational governance, and what parliamentary procedures help make an effective meeting.





- > The Chapter's website and online calendar feature was re-designed and re-launched with a new domain name, <u>www.ncbwpgc.net</u>. The Chapter also launched a stand-alone Member's Only Portal for members to access critical documents, photo gallery, news releases, and submission of requests for committee support from the communications team. The re-structuring, branding and expansion has created an interactive presence and during the first 2-weeks of the launch there were 517 visits with consistent increases since the November 2011 re-launch.
- > The Chapter's social media networks were improved with consistent content and daily monitoring for broader social media visibility with channels on Facebook, Instagram, Twitter and LinkedIn. The Chapter's social media presence has seen a significant increase in individual "Likes."
- > During COVID-19 isolation, the Chapter held several monthly interactive virtual social and educational events that provided a mental health, stress-release impact for members, the community and friends (i.e., virtual Sip & Paint, Book Reads, Hat Tea fundraiser, etc.). All events included some practical tips to help participants cope with pandemic isolation stressors.
