Kennel Guarantees

We guarantee our puppies to be in good health, to the best of our knowledge. A health certificate from our licensed veterinarian will accompany each puppy. Buyer will have 3 days from date of possession to have the puppy examined by a licensed veterinarian. If a problem is detected that CANNOT BE CORRECTED Rebel Yell Kennel will refund the price of the puppy, less deposit and travel/shipping expense, upon return of puppy to our kennel. Expense incurred in shipping of the puppy back to our kennel and veterinarian exam expenses are the sole responsibility of Buyer. The puppy must be returned and in Rebel Yell Kennel's possession, along with the veterinarian's statement about the puppy and the problem, within 2 days of the examination. The stress of travel and adapting to a new environment can weaken the immune system, causing viral and bacterial infections and colds. This type of thing is not covered under our guarantee as these are natural problems that can and do occur in puppies. Parasitism is not covered. If buyer continues with Rebel Yell Kennel's protocol parasites will be eradicated. Umbilical hernias are not genetic and, if present, should have been observed and repaired by Rebel Yell Kennel's veterinarian. However, if one is detected within 3 days of Buyer possession, Rebel Yell Kennel will pay for umbilical hernia repair, up to \$50.00, upon receiving a bill from the veterinarian performing the surgery. Any health problem that arises from an injury or accident is not covered.

Rebel Yell Kennel puppies are guaranteed for two years from date of birth from genetic defects. Although we do everything that we can to ensure our puppies are free of genetic issues, we realize that sometimes they cannot be helped. We will replace your puppy with another, no money will be refunded. Rebel Yell Kennel must have written verification from a licensed veterinarian, and applicable test results, that the issue is a genetic condition. Buyer has to return the puppy to Rebel Yell Kennel within 3 days of agreement by Rebel Yell Kennel that the problem is a genetic one. Any expense incurred in veterinarian services, testing, and return shipping are the sole responsibility of the Buyer.

Hip and Elbow Dysplasia, although linked to heredity and genetics, are also closely linked to poor nutrition and improper care or injury. To qualify for the two year genetic guarantee for this condition, Rebel Yell Kennel requires a licensed veterinarian's statement that the dysplasia was caused by genetics, not improper nutrition, improper care, or injury. Radiographs (x-rays) shall accompany statement. Rebel Yell Kennel will then speak with other owners of puppies from the same litter to verify a genetic problem before replacing the dog. If it is, in fact, genetic, at least one full brother or sisters should be showing signs of the same problem. If genetics is to blame, Rebel Yell Kennel will replace the puppy.

Buyer Responsibility

Buyer realizes that no guarantees are made by Rebel Yell Kennel regarding size, color of coat, color of eyes, temperament, or compatibility of puppy.

Buyer agrees to maintain a healthy puppy, to perform all vaccinations and deworming at the scheduled times, and to provide clean water, age appropriate food, and adequate exercise.

Buyer agrees that pet ownership is a life long commitment. He or she is responsible for the health and well-being of the puppy. If, at some time, Buyer cannot adequately care for the dog, Buyer will give Rebel Yell Kennel the first opportunity to take the dog back. Surrendered dogs will not be refunded nor replaced, but will have the opportunity for a good life. This far outweighs the consequences a dog may face if left at a shelter or with a questionable new owner.

Buyer is aware that Rebel Yell Kennel will reimburse to buyer \$200.00 upon receiving proof of spay or neuter of puppy. Surgery must be performed between 6 and 8 months of age to be eligible for rebate. Photos of the puppy at 4 months, 6 months, and at time of surgery, plus a veterinarian statement verifying spay or neuter must be sent to Rebel Yell Kennel to receive rebate.

Registration

Rebel Yell Kennel's name will be included in the registered name of the puppy. The puppy's name will begin with Rebel Yell or Rebel Yell's
