## The RHA Bill Passed; Governor Cuomo Signed It



Pro-lifers all hoped it would never happen, but no such luck. After the election last November the NY State Assembly and Senate gained Democrats, all of whom are militant pro-aborts.

On January 22<sup>nd</sup>, on the anniversary of Roe v. Wade that legalized abortion, the House and Senate passed the most egregious and dangerous pro-abortion bill in the history of our country. The so-called "Reproductive Health Act" is not healthy and there is nothing reproductive about it.

Gov. Cuomo immediately signed the bill and in an arrogant fashion celebrated by lighting up several New York landmarks in pink.
