Heartbeat Bills

The furor on the left, the rage, the violence. Pro-abortion militants are becoming unhinged now that several states, including Georgia, Missouri and most recently Alabama have passed their own state Heartbeat Laws. Alabama's bill, signed by Gov. Pro-life facts that begin at conception.



Did you know that the eggs of migratory birds get more protection than fully developed babies in the womb? It's true. In my article, [Pro-life Facts that Begin at Conception](#), I talk about the 1918 Migratory Bird Treaty Act, which is still in effect. Babies can be killed up to and after birth if they survive, but bird eggs are protected.

As explained in [Conservapedia](#): "Over 800 species of native birds warrant federal-government protection under the Migratory Bird Treaty Act of 1918 while the fertilized egg of a human being is regarded as a disposable mass of tissue."

An article that appeared last week in the New York Times was the most astonishing and outrageous read I've seen. The piece, entitled "Pregnancy Kills, Abortion Saves Lives," tries to make the case that abortion is safer than childbirth. The author provides a list of potentially dangerous

conditions that can develop during pregnancy. He includes a ruptured uterus and placenta previa in the list, two potentially deadly complications of abortion. But there is a reason he does not tell you this.

Consider the source. The author is 81-year old Warren Hern, a late term abortionist who, back in 2015, butchered a woman so badly she had to have a hysterectomy. This was a wanted child. The Nebraska couple were told late in the pregnancy that their baby had brain anomalies, and so they decided on an abortion. Hern left a large portion of her baby's skull inside her uterus, causing bleeding on and off for a year. She went to a different doctor and had to have a hysterectomy. But it gets even worse. *The couple lost the case.* You read that right. The woman can never have children, and on top of that, the jury [found against the couple](#), concluding that Hern caused her no harm or injuries. Really? He left a skull fragment in the woman's uterus. Hern is not responsible? Safe, legal abortion. Yeah. Right.

Let's not forget our veterans. They are our heroes, the men and women who keep us safe and fight for our freedom.

Of course, some radical pro-aborts will use any excuse or event as an opportunity to promote abortion - even a day commemorating fallen soldiers - to dishonor honorable veterans wounded in wars by making a comparison to women who died by illegal abortion. Outrageous statements like those made by Gloria Allred:

"The victims are the women and the girls who have to get a back-alley abortion and who are going to be left to die. It was our women's Vietnam. More women died or were maimed before Roe v. Wade by illegal abortions than men ever died in Vietnam. We thank our brave men for their sacrifices we can never thank them enough. But we also were hurt by these laws which forced us into no-win situations."

Please. To make this comparison is not only an insult to our war heroes, but a lie to women as well. Tens of thousands of women did NOT die of abortions pre-Roe.

Bernard Nathanson was one of the pioneers in the early days of the movement. He presided over tens of thousands of abortion and was co-founder of the National Association for the Repeal of Abortion Laws, now known as "NARAL." Bernard Nathanson admitted the statistics were lies intentionally promoted publicly on the news to get public sentiment toward liberalizing abortion laws. Nathanson eventually realized abortion was wrong. He became a pro-life activist and produced two films, **The Silent Scream** and **Eclipse of Reason**, which show early ultrasound abortions.
