A consignment warehouse contract is an agreement between the owner of the company and the seller. The seller decides on the quantity of his product that he wants to sell on behalf of the company. However, all the benefits of these articles go to one of the parties (the seller or the company). This type of arrangement usually lasts for a period of agreed time.

Each of the parties can then terminate the contract for notice. The advantages are that it allows companies to avoid the cost of maintaining stocks while having access to many products that may not be available in physical stores. Such arrangements also help sellers with excessive stocks without storage space to quickly find buyers. You will find below a list of common areas included in the consignment warehouse contracts.
